Whistle blowers are jumped on from great heights. Police violently attack people for “resisting arrest” and “assaulting Police” – **you are** the totalitarian corrupt regime.*

Nations and **national boundaries** have some meaning - it is **one of** humanities attempts to overcome the **problems of tribalism**. They had to learn to cooperate and not live as tribes. but would be ashamed to resort to large-scale falsehoods. It would never come into their heads to fabricate colossal untruths, and they would not believe that others could have the impudence to distort the truth so infamously. Even though the facts which prove this to be so may be brought clearly to their minds, they will still doubt and waver and will continue to think that there may be some other explanation.... The OSS psychological profile of Hitler described his use of the big lie:

His primary rules were: never allow the public to cool off; never admit a fault or wrong; never concede that there may be some good in your enemy; never leave room for alternatives; never accept blame; concentrate on one enemy at a time and blame him for everything that goes wrong; people will believe a big lie sooner than a little one; and if you repeat it frequently enough people will sooner or later believe it."

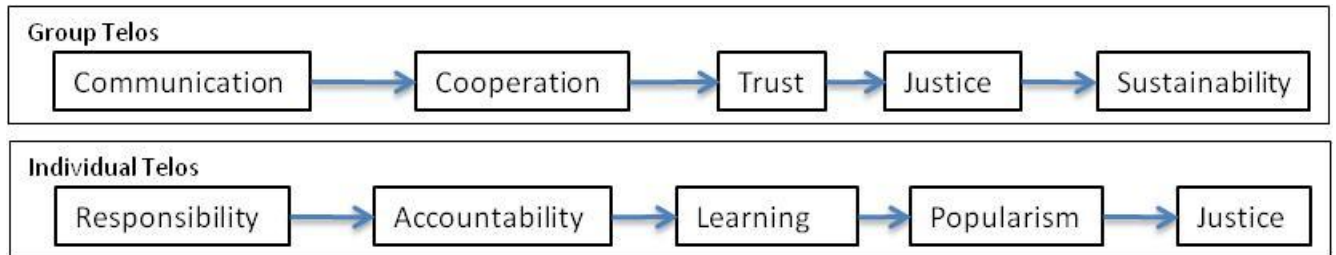
If I become incoherent all I need to do is display my virtue and stoke empathy and mob reaction.

Dear friends,

It is sad to watch what is happening around Ukraine, and it hurts the soul, imagining where our world and the whole world's contribution can go...

First of all, I would like to note that we have ratified the recognition of the People's Republic of DPR and LPR. For 8 years, the world public has not noticed the genocide of the peoples of these regions, the western media has not noticed the lawlessness, the violation of the principles of democracy and human rights in general. The most unpleasant thing about this is that the leadership of Ukraine itself closed its eyes to this, putting false and distorted accents according to the Western decree. We needed the recognition of the independence of the Republic of DPR and LPR to protect them from complete extinction. It was thought that this could be developed the possibility of continuing negotiations and finding new compromises to settle all sharp corners.

To my great regret, the whole Campaign in recognition of the DPR and the LPR had a completely different idea and plan, which was initially hidden, and as a result, we were in a state of full-scale confrontation and war between the two states. We did not have enough endurance, nor political will to try after recognition that the republics of DPR and LPR continue to gain their positions peacefully. Has "denacification" and "demilitarization" always been solved exclusively by military means?

I condemn any radical nationalist movement, I will not accept genocide, destruction and lawlessness. But just as much as I hate war and military solution of issues. I say this not as a foreign observer or a politician, but as a direct participant of such, very recent, events of Russian history. It is very painful to lose colleagues, colleagues, co-workers, ordinary young and promising guys. It is very painful to look in the eyes of their parents, children and loved ones.

I condemn the West's unjustified strategy, their double standards policies, promoting their own interests through a change of lawful power in countries they don't suit, seize new territories under false slogans of protecting democracy. I also condemn the leadership of Russia, which began to use the same methods of double standards. Under the aegis of recognition of the DPR and LPR, we have hidden plans to launch a full-scale war with our closest neighbor.

Today there is a war between two friendly nations, whose leadership was not enough, unfortunately, neither the mind nor the will to avoid the confrontation. So this is also our fault. We couldn't find the right words, we couldn't find a right solution. In this case, I mean a fact like the events of 2014, when it could still be resolved peacefully. It is sad to admit that today all wars on the Planet are lobbied not by the interests of peoples, but by the interests of business elites within states. We are watching a crisis of world order and order.

Given the current situation and the emerging situation between Russia and Ukraine, I am convinced that the development of the confrontation becomes at the hand of the third parties. To whom this war is most profitable?! I am convinced that neither the people of Russia nor the people of Ukraine need such a war... Every nation, every nation should have the right to self-determination, to the freedom of their choice...

The tribes and binary thinkers grew in number and the relatively few who remained free of binary tribalism and hatred faced a constant challenge of overcoming the mob violence - but changes did take place and humans started to consciously debate, value and appreciate things rather than just react or sacrifice chickens to their ignorance. Libraries of written words grew and these became a vast store of knowledge and information to be used for discussion and debate. Messages were left by those who became before us. 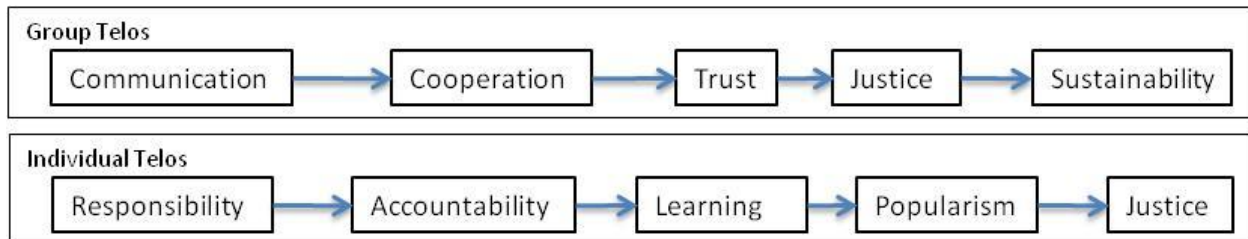

Propaganda and Delusions were not invented by the Germans or the Russians or the Chinese, USA, UK, Africans, etc. It is a human condition problem.

Do you notice the **destruction of Education** to become a training ground for certain causers, bigots, outrage, groupthink, hatred, moral grandstanding and virtue signaling?

A Rush to Principle

As a stark contrast to a "**Rush to Judgement**" - **imagine** you had someone in your MOB your group or tribe who whenever the Mob got riled up and demanded certain action - this one person said "**Hold-on - wait a minute - let us think a bit** - *about the principles involved, can we learn anything new or have any of our principles, frames, schemas been undermined, ignored and have now become in-coherent because of this intended action? Have I missed something important?*"

Imagine waking around the countryside as a mob - firstly the mob would get angry and abuse the one person - he just keeps doing that all the time - why doesn't he just play "**follow the dear leader**" like everyone else? - he keeps asking questions and tries to get other people to ask their own questions (See Socrates) - the mob is angry ,especially as they had not learned to think, imagine or use abstraction - they would be confused, upset and angry - their feelings would rise up. Then - as the tribe numbers dwindled and the one person turned out to make better choices than the idiotologists and hotheads who rushed off into their choice of certain death - the tribe might allow group discussion and the one person might become two or more. More **discussion before action** takes place.

Then, **as a principle itself** (in a recursive kind of way) - the principle of **debate and discussion within the group about principles** - you know - like a kind of general technique - **becomes valued, understood and appreciated.**

But, sometimes, after the discussion, the first choice is made - so it **seems like the debate was a waste of time and resources** and people invent sayings like *“Strike while the iron is hot”* and others counter with *“Look before you leap”*. Then the mob might **regress** (one step forward - two steps backwards) and become more mob like as other mobs join the group and the mobs have to re-learn everything all-the time - because this was not a genetic inheritance - but a learned and **hard won behaviour** (Hypothesis testing - see **04 Humanism – Information Classification Frame, Version 1, date 10/02/2019** <https://humanistman.com/wp-content/uploads/2019/02/04-Humanism-%E2%80%93-Information-Classification-Frame.pdf>)

There would always be the problem with the binary, mob like thinkers, the hot heads and the underdeveloped - feminists, binary extremists, women (on average - think quotas, average wages), children and weak minded men. The **technique of thinking** would be attacked because of jealousy, resentment and sheer bloody mindedness or the corrupt - especially the “virtue signalers” (filling their own god like certain cups of special certainty) and bad actors.

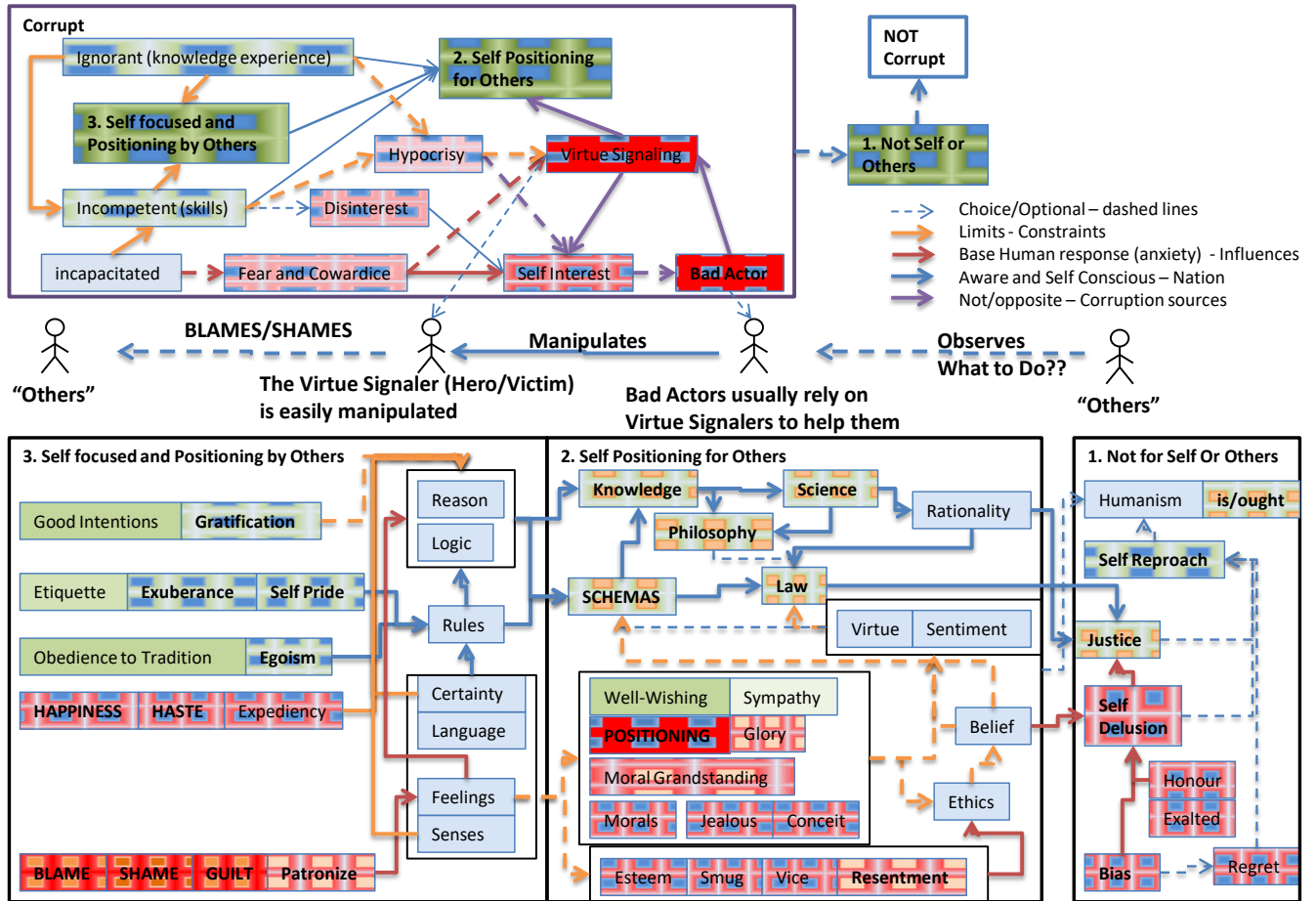

A Brief History of Public Service and how to destroy it

Protecting the tribe from animals and attacks from others became the - **Army**.

Conflict/Issue resolution became tribal leader - decision maker - **Leader** and **Judge**.

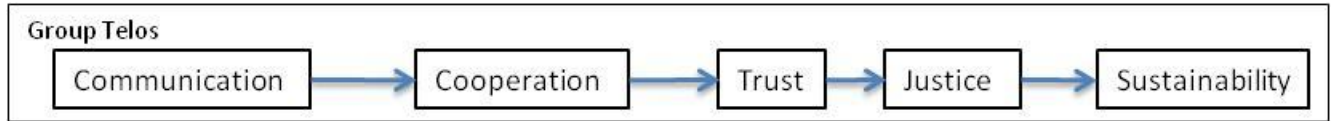
Record keeping became songs, poems, chants, rituals - **Education** and **Library**.

Houses, Roads, Water, Food, Trade and skills (Agriculture, Farming, Fishing, Building, Soothsaying) developed into an - **Economy**.

Armies have been around for thousands of years and mercenaries for just as long. Your army would fight alongside other tribe's armies not always for reciprocal arrangements - sometimes just for money and possessions.

With the laws and codes being communicated and written down (e.g. Code of Hammurabi) and people being educated enough to read and understand things - this became a tool to reduce the need to constantly judge matters and allowed people to cooperate under the law.

If someone broke the trust of the law then they could be taken before a judge for justice to be done. As long as these things generally held together then the tribe was sustainable.



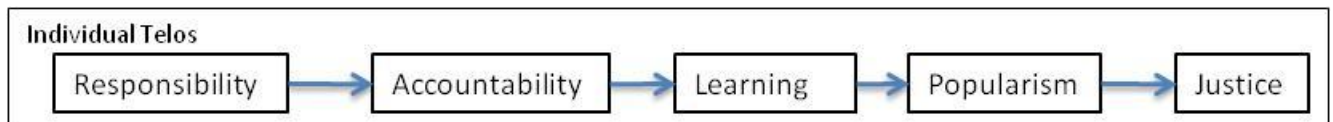
Early public libraries in Athens, Alexandria, Constantinople, Mesopotamia, etc - became places of learning, education, literacy - copying the records. Some paid to be taught by experts (Alexander the great and Aristotle). Socrates lead by example and showed people how to do things. Archimedes invented things and showed people how they worked. Others **became inspired** and creative in their own way.

Thinking, Philosophy, Astronomy, Map Making, grew - even though religious dogma tried to control everything (burn books - sacred texts, the accepted "dogma") - monks throughout Europe, Italy, Turkey and other places - copied books, taught young boys to think, write, learn, and teach others. Writing and books were valued as a public resource. This was possible because of the Economy that the Greek/Romans had created - public roads to be used by everyone for travel, public bridges, water systems, entertainment, sport (Olympic games), taxes, armies (defense), etc.

Oratory, exploration of ideas and difficult issues and debates were public and good speakers were recognized, appreciated and rewarded.

The concept of public service grew - the use of shared facilities - public water, toilets - sometimes paid for - sometimes free - roman baths, spas, entertainment, drama, poetry, songs, music. People learned to cooperate in their use. Talent was rewarded with education, training and opportunity and was passed on to others through generations.

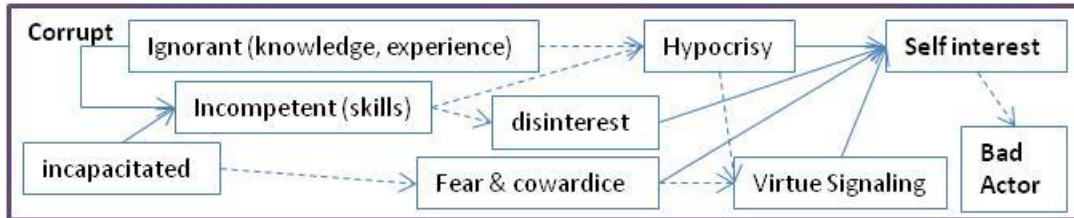
People were responsible for behaving well, they were held to account for their actions, learning developed and grew, they acted **not** out of a desire to be popular (**that way lead to narcissism, paranoia, violence and destruction**) - they wanted to be competent - have a skill - some value to the group - to show some **appreciation** and **gratitude** for the life they had and any opportunities that came their way. (see **Marcus Tullius Cicero** - he was always expressing his gratitude and working to help others in the group - the army kept them safe, the economy allowed all to function, the libraries allowed all to read and develop)



The Public service - especially in Australia - is now fully corrupted. It is so corrupted that people do not even know what corruption is. The very idea of corruption no longer exists - it has been replaced with the "cause" the certain virtue. The "certain ends". There is no longer any concept of "public service" - the sharing for the group - it has been replaced with "self" - self-focus, self promotion, self virtue, and

the individual and group victim and has become a haven for narcissistic psychopathic bullies, liars, virtue signalers, self promoters and bad actors. E.g. the Legal professionals-courts, Politics, Universities, Office of “women”, etc - all public services.

Public services has become cheap virtue signaling of public money to causes, mobs and whingers. Let’s give money to causes. Let’s employ some blacks/women - in some nonsense expensive job.



Women now enter the public service based on a notion of being the entitled/victim. They seek to get promoted not based on skill or ability - but based on any technique that works - identity, quotas, threats, blackmail, hoarding corporate knowledge, sexual favours, etc - any amount of “**Bad Acting**” justifies the certain ends - in other words many people who enter the public service are not there to be “a public servant” they are there to promote themselves and get more money - their own **Self Interest**. The concept of “**Permanent Tenure**” of public servants **was designed** to encourage people of good character and talent - with a focus of public service - not themselves and “advancement” for its own sake. Responsibilities and commensurate salary was advanced as skill, demonstrated ability, actual delivery (results) , learning and character grew. People were trained and nurtured into jobs to work as **permanent public servants**. This was seen as **an investment** in the most capable, trained, apolitical and uncorruptable people working on behalf of the group. This was a valued and respected responsible position. Open, Accountable, Transparent and Competent.

TRUST was essential for the group.

Even if the politicians were corrupt you could **trust the public servants** to behave honestly with integrity.

Encouraging people with the wisdom of Solon, Socrates, Aristotle - allowing them to make mistakes - learn, grow and develop new skills and capabilities on behalf of the group.

All inventions belonged to the public service - if you did good work - then that work became part of the collection of good works - it was not your “intellectual property” - your ideas were given freely and encouraged to be debated and discussed - away from the political and corrupt debating frames - things were analyzed and explored in “frank and fearless” ways and not out of appeasement to the tyrant, dictator, cause, feminists, blacks or other mob like groups. **Speaking truth and exploring difficult issues**

was the job - exposing problems was important - although now it is called “Whistle blowing” and has been criminalized by the public service and politicians wish to continue to corrupt the public service.

Slowly the concept on contractors grew. Originally there were few contractors because the public service had all the people with the best skills and talent. Then people entered the public service - deliberately set out to gain skills and knowledge using all the technology, training and opportunities provided for them - and then made friends” with as many people as possible (agreeable and sycophant) so they could then be employed as “contractors” on higher wages and with more “respect”, influence, job opportunities and power. In this way employees effectively promoted themselves - based on convincing people how wonderful they were or deliberately storing essential corporate knowledge in themselves and making themselves the repository of corporate history and skills. The alternative to this approach was to write manuals and other documents to train and help other employees - to transfer corporate knowledge within the organization and encourage debate and discussion about difficult issues. Sycophants grew and the greasy pole climbers sucked up to whatever boss they could find. Contractors demonized public service staff as “ignorant” and “incompetent”.

Fat, Dumb and **Lazy** bosses **forgot about the purpose of the public service** and fell to the habit of “get a contractor in”.

Imagine outsourcing your army to a group of contractors.

Debate and arguments stopped - people stopped learning and developing - collusion and corruption developed - services and capabilities were diminished and destroyed. At one stage the Australian Tax Office was looking to outsource its entire data holding to a computer center in India. Like Australian Accountants who send Australian Tax Records to large TAX processing centers in Asia - because it is “cheaper” and makes more profit for them (regardless of the privacy and security threat issues)

One (of many) examples is AUSTRAC - when they got a Teradata computer. The staff using and learning about the computer developed programs and expertise - using the public service data, resources and technology - and they all banded together to form a group. They then negotiated with AUSTRAC (either corruptly or as blackmail) to be employed as “contractors” - separately from the “public service” thus destroying the concept of public service from within.

We see this in the States of Australia where whole public service agencies like Ambulances, Hospitals, Fire Services, Protection, (not police yet) are “outsourced” to contractors - like “mercenaries” in an army. (compare this concept with the Ukrainian army of dedicated individuals fighting to protect their own country - regardless of the profit motive.)

John Howard, famously in “the night of the long knives”, sacked all the old heads in the public service because they dared to disagree with him or argue the case (highlighting his ignorance).

Now heads of public service are appointed as favours, graft, bribes, corruption to friends, family, political partners or women and blacks as a virtue signal. **Merit no longer exists** - only **corruption**.

(2) *The APS demonstrates leadership, is trustworthy, and acts with **integrity**, in all that it does.*

(3) *The APS respects all people, including their **rights and their heritage**.*

Here is where the rot and dogma begins - we get undefined rights and "heritage" becomes the new gods rather than people - humans - themselves. BLM, etc. Why not simply - the APS respects all people. Or all citizens? Why include it at all except to highlight the terms Rights and Heritage? Who is going to interpret this exactly?

(5) *The APS is **apolitical** and provides the Government with advice that is **frank, honest, timely** and based on the **best available evidence**.*

(1) *The APS is a career-based public service that:*

Fair here has become **corrupted to mean** promotes women and blacks on a quota system.

(g) *recognises the **diversity** of the Australian community and fosters **diversity** in the workplace.*

The **New cause/god** of diversity here has been inserted to **replace the legislation which said "merit based selection"**. 10A APS Employment Principles

APS Employment Principles

(1) *The APS is a career-based public service that:*

- (a) makes **fair employment decisions** with a fair system of review; and*
- (b) recognises that the usual basis for engagement is as an ongoing APS employee; and*
- (c) makes decisions relating to engagement and promotion that are **based on merit**; and*
- (d) requires effective performance from each employee; and*
- (e) provides flexible, safe and rewarding workplaces where communication, consultation, cooperation and input from employees on matters that affect their workplaces are valued; and*
- (f) provides workplaces that are **free from discrimination, patronage and favouritism**; and*
- (g) recognises the diversity of the Australian community and **fosters diversity in the workplace**.*

Decisions based on merit

(2) *For the purposes of paragraph (1)(c), a decision relating to engagement or promotion is based on merit if:*

- (a) **all eligible members** of the community were given a reasonable opportunity to apply to perform the relevant duties; and*
- (b) an assessment is made of the relative suitability of the candidates to perform the relevant duties, using a competitive selection process; and*
- (c) the assessment is based on the relationship between the candidates' work-related qualities and the work-related qualities genuinely required to perform the relevant duties; and*
- (d) the assessment focuses on the relative capacity of the candidates to achieve outcomes related to the relevant duties; and*
- (e) the assessment is the primary consideration in making the decision.*

Note: Commissioner's Directions may determine the scope or application of the APS Employment Principles (see subsections 11A(2) and (3)).

This is completely incoherent doublespeak. **Merit** now becomes defined and mixed up with **diversity**. **Diversity now becomes merit itself, in fact to be eligible to be selected you must be diverse first before you merit can be tested.** This allows positive discrimination - based on identity characteristics - which works hand in glove with the Discrimination Act to ensure that Discrimination is encouraged and supported - not only in government departments - but public organizations as well. **Discrimination based on identity** as defined under various definitions of diversity (see discrimination Act) **is encouraged over merit and capability.** Penny Wong, Labour and Greens have supported this for decades and actively sought to corrupt every piece of legislation they can.

(2) Without limiting subsection (1), the Commissioner's functions include the following:

(a) to foster, and contribute to, leadership, high quality learning and development and career management in the APS;

(b) to **lead the thinking about**, provide advice on and drive reforms to **workforce management policies** so that the APS is ready for future demands;

(c) to develop, review and evaluate APS workforce management policies and practices and **maintain appropriate databases;**

(d) to **foster an APS workforce that reflects the diversity** of the **Australian population; (ON AVERAGE!!!)**

18 Promotion of employment **equity**

An Agency Head **must** establish a **workplace diversity program** to assist in giving effect to the APS Employment Principles.

Diversity and equity - OF WHAT EXACTLY!!! - AGE, WEIGHT, HEIGHT, SMELL, RACE, RELIGION, FRIENDS, RELATIVES, Disability, Transgender, Sentient pets, Averages?- (whatever that means) are **mandated!** Merit, competence, outcomes, etc - mean nothing.

Compare this to the bullshit of saying that there is a **PRO-INTEGRITY culture** in the APS.

*"In order then that the social compact may not be an empty formula, it tacitly includes the undertaking, which alone can give force to the rest, that whoever refuses to obey the general will shall be compelled to do so by the whole body. This means nothing less than that he will be **forced to be free**; for this is the condition which, by giving each citizen to his country, secures him against all personal dependence. In*

*this lies the key to the working of the political machine; **this alone legitimises civil undertakings, which, without it, would be absurd, tyrannical, and liable to the most frightful abuses.***"

*"Every service a citizen can render the State he ought to render as soon as the Sovereign demands it; but the Sovereign, for its part, **cannot impose upon its subjects any fetters that are useless to the community**, nor can it even wish to do so; for no more by the **law of reason** than by the law of nature can anything occur **without a cause.**"*

*"From whatever side we approach our principle, we reach the same conclusion, that the **social compact** sets up among the citizens an equality of such a kind, that they all bind themselves to **observe the same conditions and should therefore all enjoy the same rights**. Thus, from the very nature of the compact, every act of Sovereignty, i. e. every authentic act of the general will, binds or favours all the citizens equally; so that the Sovereign recognises only the body of the nation, and draws no distinctions between those of whom it is made up. What, then, strictly speaking, is an act of Sovereignty? It is not a convention between a superior and an inferior, but a convention between the body and each of its members. It is legitimate, because based on the social contract, and equitable, because common to all; useful, because it can have **no other object than the general good**, and stable, because guaranteed by the public force and the supreme power. So long as the subjects have to submit only to conventions of this sort, they obey no-one but their own will; and to ask how far the respective rights of the Sovereign and the citizens extend, is to ask up to what point the latter can enter into undertakings with themselves, each with all, and all with each."*

The public service is not serving the **public good** to "reflect" Society - it is required to serve the public en masse - to **do things** rather than to **be something** - to **merely exist** as an **identity statistics** database.

*"When I say that the object of laws is always general, I mean that law considers subjects en masse and actions in the abstract, and never a particular person or action. Thus the law **may** indeed decree that there shall be privileges, but cannot confer them on anybody by name. It **may** set up several classes of citizens, and even lay down the **qualifications for membership of these classes**, but it cannot nominate such and such persons as belonging to them; it may establish a monarchical government and hereditary succession, but it cannot choose a king, or nominate a royal family. In a word, no function which has a particular object belongs to the legislative power."*

*"Laws are, properly speaking, only the conditions of **civil association**. The people, being subject to the laws, ought to be their author: the conditions of the society ought to be regulated solely by those who come together to form it. But **how are they to regulate them?** Is it to be by common agreement, by a sudden inspiration? Has the **body politic** an organ to declare its will? **Who** can give it the foresight to formulate and announce its acts in advance? Or how is it to announce them in the **hour of need?** How can a **blind multitude**, which often **does not know what it wills**, because it **rarely knows what is good for it**, carry out for itself so **great and difficult an enterprise as a system of legislation?** Of itself the people wills always the good, but of itself it by no means always sees it. The general will is always in the right, but the judgment which guides it is not always enlightened. secured from the seductive influences of individual wills, *taught to see times and spaces as a series*, and *made to weigh the attractions of present and sensible advantages against the danger of distant and hidden evils.*"

*How dare you suggest that Women lie. (Graham Perrett said words to that effect in parliament - expressing his outrage that anyone could think that women lie and that that person could be appointed to a committee looking into family law). **Humans lie**, Graham. Graham walks in BLM “protests” signaling his support for lies, groupthink, mobs, virtue and hypocrisy (likes most Labour Green types) and how easily he is manipulated for his “virtue” by bad actors.*

*How dare you question me (Andrew Leigh in a public town hall meeting) when we are proud we have 50% women in the Labour party - see - we are not misogynists and bigots - we don't discriminate - it is you who hate and women and discriminate against women, blacks and jews - we don't discriminate and we can prove it - We have 50% women by quotas (active discrimination - the **“right kind” of discrimination and bigotry** - not the “wrong” kind like you). We love inclusion so much we have 70% women in some of our agencies- see how inclusive we are!*

How dare you suggest the Emperor has no clothes!

Richard Marles (Labour Party Male non-entity and public sentient pet sacrificial eunuch for the Labour Party and Green Feminist cause) *“With respect”* he says to the reporter in an effort to frame and shame them using the positioning method (I know better than you - who do you think you??? are asking that question). He does not have the practiced abusive stare that Penny Wong has developed over the decades but he is working on it following her example. *“With Respect”* - (I know better than you - isn't about time you behaved yourself). When this repeats it becomes behavior (pattern). Repeated Bad behavior can vary in frequency. When humans frame Bad behavior in an unevolving model then **they no longer learn** - they become stuck.*

*An individual human or subset of a group who knowingly makes Bad choices on behalf of a group using an **incoherent and unevolving frame have corrupted the choice process**. It is corruption.*

*Bad choices can be made by Humans - **human development** is corrupted **when nothing is learned** and no **improved information** is used for future choices. This lack of learning and development impacts **human survival**.*

*Hypocrisy is one behavior which corrupts human development and is usually done by **insecure and confused humans**. They may not realize that they are developing a consistent frame for decision making or they or have a state of mind where **self consistent choice making frames** have not yet or will never develop.*

*The hypocrisy exposes itself when a **human consistently argues a frame for decision making choices and then swaps it when another choice arises**. This, they argue, is having a number of different decision making frames for choices and that they – the individual human – is best suited to choose.*

They invest themselves with special power on behalf of the group. They champion incoherence.

*Hypocrisy usually arise when individuals are **faced with challenging choices** which affect their decision making frame. (We will ignore undeveloped humans at this stage). Because **resistance to change***

*(inertia) (Fat, Dumb and Lazy) is built into humans they will often **discard the choice making frameworks** development for something else – none, senses, ignorance, lack of development and inbuilt incoherence. **They disdain any need for a developing coherent choice making frame.***

Choice is difficult and for many people the world is (simply) too complex. “Anything other than having to think”

This breakdown of coherent frames for choice leads to many forms of corruption and all that flows from it** – <https://www.transparency.org/glossary> . Reflect on this - if you can't have a coherent developing frame for choice then why have one at all? **Just do what you like whenever you like?

Hypocrisy is not a new problem, nor is developing accepted and agreed frames for choice for groups

We see many examples of this every day - especially from politicians, courts, media (ABC), universities, schools - it is widespread in all cultures - usually by people blaming and shaming others. The Greens and Labour party - especially the women and weak-minded men who dominate will say “*Now is not a good time to look at allegations of bullying behaviour*” - when allegations emerge of a culture of WOMEN bullying other WOMEN in the Labour party. The reason this is getting current attention is because a woman from the Labour party who died recently from a heart attack accused other WOMEN in the Labour party of abusing and harassing her.

So then some pissed off women psychopath chooses the same time to make allegations against the “others” - the other side (This is standard technique used in all arguments) - “*so if you will not investigate allegations against you/your group why should we investigate ours?*” This falls into the category of the **race to the bottom** (cascading through binary trees) based on a general allegation of “hypocrisy” usually involving the “**false equivalence**” technique (binary thinking) - “*You also lied once so why shouldn't I lie all the time?*” OR “*You cannot prove you are telling the truth - so that means I can lie all the time*” (**Bad Actor** - Delusional Psychopaths- ABC, Feminists, Binary extremists, Women (on average), weak minded men, etc) “*They are both as bad as each other*” “*They are the same*” .

Aristotle seems not to have dealt much with this argument/debating technique

<https://plato.stanford.edu/entries/aristotle-rhetoric/> - it might be “ad hominem” - a kind of **instant reflex response** to any allegation - a “fight” **rather than a debate or discussion** of a real or perceived problem. See Farnham Street blog <https://fs.blog/bad-arguments/> . Also too, it has much to do with **tribal warfare, Prisoner's dilemma** and **Game theory**. These techniques are all about avoidance of any investigation and fobbing off and doubling down on any feedback or criticism (opportunity to learn and develop). Aristotle has already assumed/taken for granted (and hence seems to have not closely examined this kind of counter allegation attack technique) that there is **some kind of fair judge** or appointed judge “*various magistracies*” to examine allegations and gives us some of his thinking in the history of Draco and Solon in “**THE ATHENIAN CONSTITUTION**” <https://www.gutenberg.org/files/26095/26095-h/26095-h.htm> . Aristotle also lays out much of his logic in “**The Categories**” <https://www.gutenberg.org/cache/epub/2412/pg2412.txt> “*Qualities admit of variation of degree. Whiteness is predicated of one thing in a greater or less degree than of another. This is also the case with reference to justice. Moreover, one and the same thing may exhibit a quality in a*

greater degree than it did before: if a thing is white, it may become whiter.” - he attempts to describe a structure for language and logic and describes many of the structures I have described in my **14 Humanism – Language Development, Version 1, date 06/10/2019** <https://humanistman.com/wp-content/uploads/2019/10/14-Humanism-%E2%80%93-Language-Development.pdf> . Here he is making a distinction between binary and opposite into “*differentia*” and “*degrees*” of difference using “justice” as an example - a kind of logical conceptual link (which is part of the general problem of **linking two things** of ANY thing declared or described) - but significantly - he recognizes “**discrete or continuous**” (Binary) for “Quantity” **without recognizing** the initial self-reference, recursion problem. E.g. continuous continuums.

An Aside: The unbounded chaotic universe - (based in my view of the initial self-reference, recursion problem) seems to have been **FIRST understood** from **Anaximander** and later, **Heraclitus of Ephesus**, as far as we can tell from the written record. Anaximander seems to also have understood transfinite concepts (bounded infinities). The importance of this is that many others do not grasp this concept and insert **various versions of certainty** at mathematical or philosophical level as an alternative to that view. “*In the beginning*” is a comfortable and soothing notion to many people but is at odds with an unbounded chaotic universe. An alternative might be “*transfinitely in the beginning*” or “*I am declaring (is) a starting point*”. Pythagoras understood many things but stopped developing at a certain point in his life and become **too smug in his certainty** and he and his followers were “driven out of town”.

Solon’s changes to Dracos laws followed a long period of the **Greek Dark Ages** https://en.wikipedia.org/wiki/Greek_Dark_Ages where it seems that the Military made themselves the elites - **possibly (no-one knows for sure)** because they had defended and built up the city of Athens out of the dark ages and had entrenched their power in the laws, judgments and constitution - pretty much like we see with the feminists in politics, courts and the public service today. Corruptly grabbing more power, money and entitlements and fining, damaging, enslaving those who disagree or complain. Solon was popular, educated, a lover of wisdom and **gained respect** from the community. They all knew things were going downhill and getting worse in the city. Eventually he re-wrote the Athenian laws and systems and helped establish a new era of prosperity for all the city. Although the Code of Hammurabi https://en.wikipedia.org/wiki/Code_of_Hammurabi predates Solon by 1200 years - both seem to contain **ideas of fairness**, some **degrees of freedom** and common sense - “*Moreover, since the laws*

were not drawn up in simple and **explicit terms** (but like the one concerning inheritances and wards of state), disputes inevitably occurred, and the **courts had to decide in every matter**, whether public or private. Some persons in fact believe that **Solon deliberately made the laws indefinite**, in order that the **final decision might be in the hands of the people**. This, however, is not probable, and the reason no doubt was that it is **impossible to attain ideal perfection when framing a law in general terms**; for we must judge of his intentions, not from the actual results in the present day, but from the general tenor of the rest of his legislation. “ - they were generally accepted “I gave to the mass of the people such rank as befitted their need, I took not away their honour, and I granted naught to their greed; While those who were rich in power, who in wealth were glorious and great, I bethought me that naught should befall them unworthy their splendour and state; So I stood with my shield outstretched, and both were safe in its sight, **And I would not that either should triumph, when the triumph was not with right.**” - whereas Draco’s laws were seen as biased, cruel and harsh - and empowering the “elites”

https://www.worldhistory.org/Dracos_Law_Code/ - **very much like we see now** in all the feminists (**Entitled/Victim/Elite**) laws and government organizations displayed as **obvious corruption, bias** and dogmatic detail - Family Law, Domestic Violence law, “Office of Women”, CSA, “respect”, Donations, public service appointments, Grants, ABC, Universities (Positive discrimination), Schools, “Black Judges”, courts, Police Action, public service, Public Grants of money and resources to women and blacks, etc.

1. If a man bring an accusation against a man, and charge him with a (capital) crime, but **cannot prove it**, he, the accuser, **shall be put to death**.
2. If a man charge a man with sorcery, and **cannot prove it**, he who is charged with sorcery shall go to the river, into the river he shall throw himself and if the river overcome him, his accuser shall take to himself his house (estate). If the river show that man to be innocent and he come forth unharmed, he who charged him with sorcery shall be put to death. He who threw himself into the river shall take to himself the house of his accuser. (this seems to be the basis for the Monty python sketch about the witch in the Life of Brian)
3. If a man, in a case (pending judgment), bear **false (threatening) witness**, or **do not establish the testimony that he has given**, if that case be a case involving life, that man **shall be put to death**.
4. If a man (in a case) bear witness for grain or money (as a bribe), he shall himself bear the penalty imposed in that case.
5. If a judge pronounce a judgment, render a decision, deliver a verdict duly signed and sealed and afterward alter his judgment, they shall call that judge to account for the alteration of the judgment which he had pronounced, and he shall pay twelve-fold the penalty which was in said judgment; and, in the assembly, they shall expel him from his seat of judgment, and he shall not return, and with the judges in a case he shall not take his seat.

Justice insists on the importance of Adolf Eichmann, the man in the glass booth built for his protection: medium-sized, slender, middle-aged, with receding hair, ill-fitting teeth, and nearsighted eyes, who throughout the trial keeps craning his scraggy neck toward the bench (not once does he turn to face the audience), and who desperately tries to maintain his self-control—and mostly succeeds, despite a nervous tic, to which his mouth must have become subject long before this trial started. **On trial are his deeds**, not the sufferings of the Jews, not the German people or mankind, not even anti-Semitism and racism."

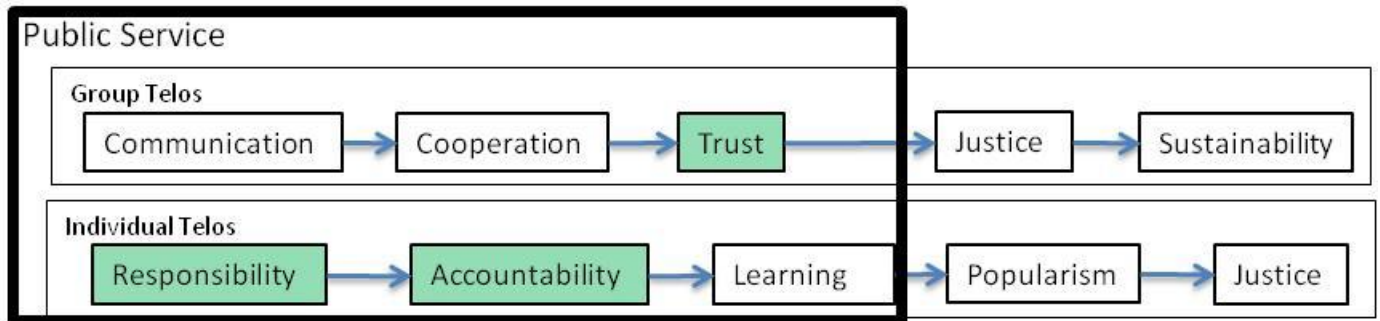

Police encourage people to come forward and make false allegations against specific targets and corrupt the legal process as much as they can in Melbourne (Gobbo, Cardinal George Pell), Canberra, Darwin and most places in Australia. This is done corruptly for political, financial or other purposes. The issue is never treated as women lying - it is always treated as a partial complete truth against a man. So the **crime of making false allegations and swearing false affidavits is ignored by Magistrates**. This has been going on for 50 years. There is **never any consequence for a woman making false allegations** - (They become “celebrities” rewarded by government and media) - only the damage to the man who has false allegations made against him. Tribal Entitled/Victim Groupthink Focus destroys Nations

For many decades it was the constant Jew focus - Jews were the tribe deserving the constant victim status and focus of everyone's attention all the time. The **permanent entitled/virtuous/victim narrative**. This dates back thousands of years. Then it was the Blacks. Then Women. It differs in many places but the technique is to establish a tribe based on skin colour, gender, **belief** or other identity features, claim special group status (tribal), demand and cajole others - usually using the shaming, blaming technique of designated "Others" to get constant attention and more money - by positioning. This becomes a feedback loop as the dominate tribe gets more attention and money until the whole system is fully corrupt and unable to escape the constant "special" narrative - special "victim" - special "entitled". This becomes fully entrenched in the schools, media, courts and public services until the idea of nation is destroyed and replaced by fully tribal narratives. *"But once peace was restored and Christian kings had taken over the reins of government of the Romans, then vice and scandal entered the Church, and synods and **sects multiplied**, because **every year someone invented a new creed**. **Security and peace led to many evils**. The **lovers of glory stirred up troubles unceasingly**, using gold to obtain the consent of kings, so they could **play about with them like little children**. All this happened among the Romans."*

John bar Penkaye shows history just prior to the Muslim conquest in the 700's and he describes in detail the collapse of civilization around him - the entitled ruler class - doing and saying the same kinds of things we see today. There is no shortage of **vainglorious, driveling, idiots** through history - willing to puff themselves up with other people's money, destroy all things and smugly sneer and snark about it. There is no “National Debate” - it is all about tribes debating each other - only special tribes are allowed into the national tribal debate (the elites - special entitled/special victim) - “others” are excluded. With “respect” you must leave the room.

There is no debate about “**The Nation**” - what the nation should do, what kind of nation the people want - only the tribal victim and special entitled tribal narratives.

Nation flags and songs are replaced with tribal dances, ceremonies, sacrifices, flags and songs - tribes replace the nation at every level. 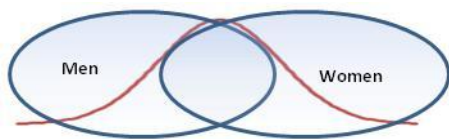

I was talking to a friend and she told me that most people don't understand complexity and then explained the Venn diagram of identity characteristics. She had been called names - labeled as a "cis-type" by some in her community.

I explained that they were binary thinkers using binary concepts and less than 30% of humans can overcome this bias - even if they work hard on it.

She did not understand how a Venn diagram could be binary so I had several goes at explaining the continuum. She saw Venn diagrams as the limit of complexity.

What is inside the circle "Women" - what then, is outside the circle, "men"? - NO its not - it is "Not Women". What is outside the circle within the box? Continuum - everything.

A different way of looking at this is to start with a concept at a sufficiently vague or higher level of abstraction. To do this you start at low levels of fact and **push upwards towards higher level of abstractions**. This **is** a thinking and analysis technique - finding the right level of abstraction. **Finding the right (Utility) level of Zoom and Focus**. This means it will be a useful level of abstraction and a level where it generally encompasses all the usual day to day requirements without **having to be argued and amended all the time** - it has **some** robustness, coherence, cohesiveness and longevity - it is architected to survive the tsunamis and earthquakes - it can withstand - and should withstand - constant testing, debate and discussion.

This becomes a different approach to lawyer and binary types who insist on expensive excruciating dogmatic certainty (for their own profit and certainty) - Pharisees and Scribes.

The other issue worth noting is the general problem of push back against any declared thing. Think the Black Obelisk in Arthur C Clarke’s 2001: A Space Odyssey. **Once a thing is declared** - it is there to be pushed back against, argued, examined and explored - so the general idea is to find things which fit well within the shared group schemas.

Sufficiently certain - sufficiently vague. On a continuum.

So instead of saying there are concepts of things like Male and Female - you say there is a concept of gender based differences on a continuum - or shorthand “**Gender Continuum**” for **most human characteristics**. A lower level of abstraction shows **several specific places where Gender matters** in a shared society - biological reproductive sex - Male/Female, Toilets and Sport. These are the **limited number of specific places** we define in shared society schemas - rather than a complete legal dogmatic enumeration and definition of everything.

Here is how babies are made. - Here is where you go to the toilet - here is the sport you play by gender - Societal variable schemas sometimes explored, discussed and debated- not legislated mandates.

In the **vast majority of life - GENDER makes no difference!** - Even clothes can be worn at different times - based on preference, situation and societal norms - **not legislated dogma**. Gender is irrelevant for doing any job - it is based on skills, capability, interest, etc. If you do not have the capabilities, skills and interest in a job there may be many factors involved - making these factors a **groupthink/victim narrative is a resentful tendency of weak minded binary thinkers, etc.**

So the “**RIGHT**” - **useful/sensible/cohesive/coherent/comprehensive** - level for abstraction for jobs is competency, capability (knowledge, experience and skills), capacity, interest - not a **hypocrite**, not a **coward** (not facing your fears), not **self centered**, not **virtue signaling** and not **bad actor**. i.e. not corrupt. These are continuums and not binary - it is complex.

So **GENDER** or **RACE** is exactly the **WRONG thing to focus on** when looking at jobs. But this is what Binary certain idiots do - all the **binary extremists** do this - communists, fascists, religious zealots, feminists, women on average (quotas, average wages), weak minded men - the **choose the wrong thing** like Race, Gender, Belief, political party, etc - a **deliberate corruption** - the **very definition of corruption** for public jobs and money. So instead of saying a fireman has to be able to lift 100 kilogram body out of a burning building or hold a hose full of water - they say this discriminates against women - when in reality all it does is discriminate against those humans who cannot lift 100 kilogram body. In science you have to be clever and pass tests. Males do better than females (on average) so they say this discriminates against women or blacks or idiots (on average) - when in reality all it discriminates against is those humans who cannot pass the test. So they **lower the standards** of the tests so scientist's standards drop, etc. You need some intelligence in the public service - but this allegedly discriminates against females - so they invent *emotional intelligence* as a selection criteria so unintelligent females can be "included" in an **inclusive** way that the Labour and Green champion for lowering the standards of everything. This is the opposite of **working to one's strengths and capabilities (building excellence in your area of skills, interest and capabilities)** - instead of **destroying standards in everything else (based on the resentful entitled victim of discrimination)** - a **race to the bottom** kind of thing based on an **AVERAGE view of things** rather than an **EXCELLENCE view of things**. Driven by **resentment**.

This **Wrong focus** - has it's origins in the weak - the weak minded, insecure and incompetent. This is why schools need to encourage all children to find something they enjoy and can feel proud of (**self confidence** - **NOT virtue signaling**) - rather than demonizing and grouping. The weak - generally the little girls in the playground - start playing little group games where they exclude "others". They practice being "special" with signs, clothes, insignia, attitudes, whispers, words, language, songs - anything which build cohesion within their group. So we have boys and girls gangs. They say thing like we exclude people called "homer", tall people, ugly people or people "we" do not like - they practice **exclusion games** and start defining characteristics for their little special groups - the **mean girls** enjoy their **smug feelings of power** when they abuse and belittle others. They like the reaction when they declare that others are "excluded" from their special group. Some special groups do not even wait to be asked - they straight away go around pointing at others, demonizing and belittling them and publicly declare they are excluded" as a constant put-down and abuse. They become teachers, scolders and demonizers of "others" (diversity and inclusion officers, human rights, etc) .They then control what characteristics define the "in-group" as they see it with smug certainty. i.e. the **WRONG** things for humanity (to be debated and **we hate debate**) but the **RIGHT** things for our special in-group.

Many take this behaviour into adulthood - into gangs, motorcycle clubs, politics, law and political staffers - **playing exclusion games** and **narcissistic power trips** by demonizing others. For many this is only a **right of passage** (trying to build some self-confidence by putting other people down) into **becoming a responsible adult**. Some skip the games altogether and go straight to responsible individual adult.

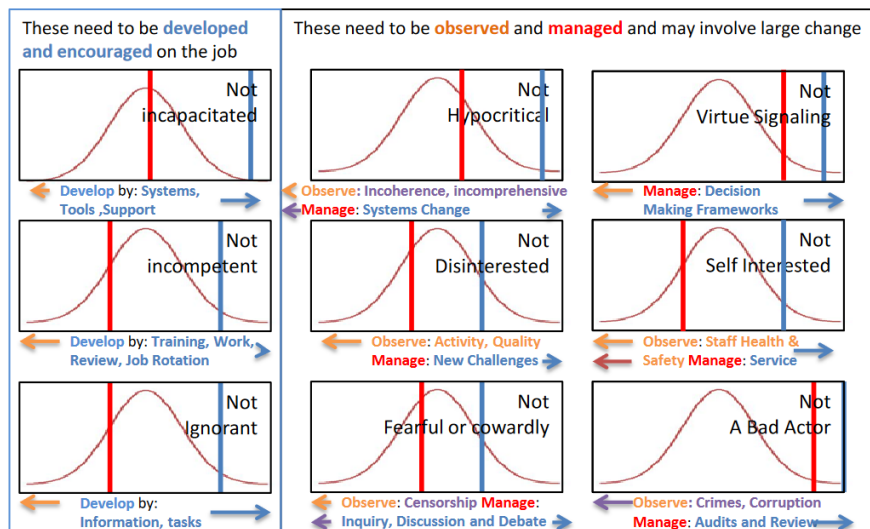
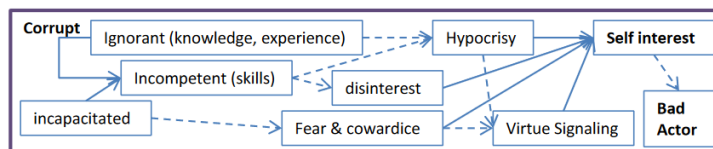
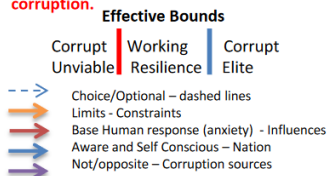
Hypocrisy next shows the system in breakdown – incoherent or incomprehensive - biased.

A high level of ignorance or incompetence in society is a later stage sign of a collapse and corruption.

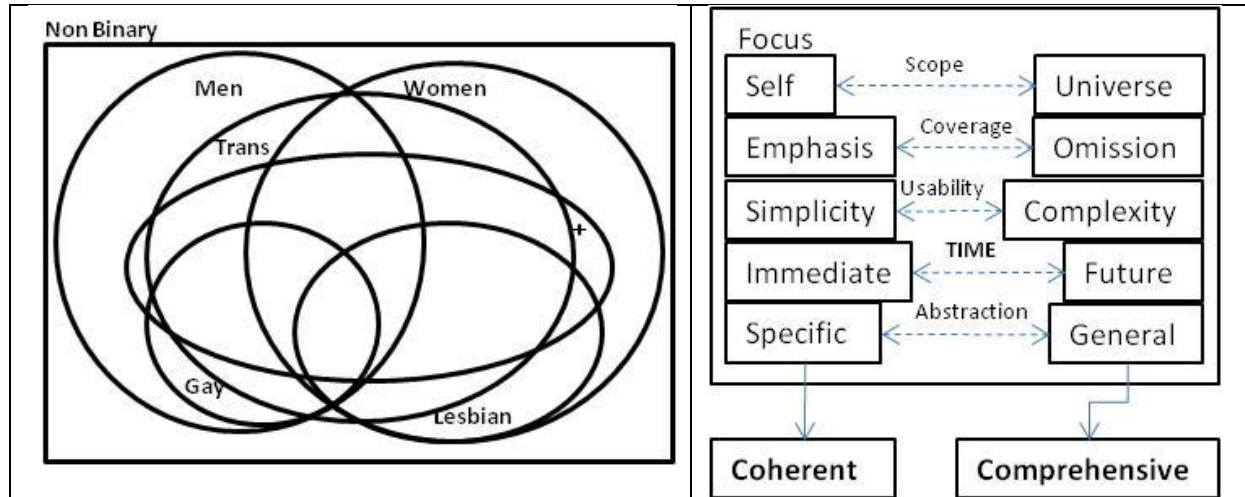


Skin colour, beliefs, gender are the **WRONG** levels of abstraction for a job. **You will not get the best human.**

At age 34 he is becoming a man and starting to escape the strong influences on him. He is thinking for himself more now. He has seen the Greeks, Death, War, University and great art. He is also of a time when people read books - they sought out information and debate. They were **not driven by instant feedback** using radio, TV or Internet. They were prepared to investigate and learn.

*“Perhaps I could be fairly reproached with much “art” in this regard, many fine counterfeitings; for example, that, wisely or wilfully, I had **shut my eyes** to Schopenhauer’s blind will towards ethic, at a time when I was **already clear sighted enough** on the subject of ethic; likewise that **I had deceived myself** concerning Richard Wagner’s incurable romanticism,[7] **as if it were a beginning and not an end**; likewise concerning the Greeks, likewise concerning the Germans and their future—and there may be, perhaps, a long list of such likewises. Granted, however, that all this were true, and with justice urged against me, what does it signify, what can it signify in regard to how much of the self-sustaining capacity, how much of reason and higher protection are embraced in such self-deception?—and **how much more falsity is still necessary to me that I may therewith always reassure myself regarding the luxury of my truth**. Enough, I still live; and life is not considered now apart from ethic; it will [have] deception; it thrives (lebt) on deception ... but am I not beginning to do all over again what I have always done, I, the old immoralist, and bird snarer—talk unmorally, ultramorally, “beyond good and evil”?”*

*“Thus, then, have I evolved for myself the “free spirits” to whom this **discouraging-encouraging** work, under the general title “Human, All Too Human,” is dedicated. **Such “free spirits” do not really exist and never did exist. But I stood in need of them**, as I have pointed out, in order that some good might be mixed with **my[8] evils** (illness, loneliness, strangeness, acedia, incapacity): to **serve as gay spirits and comrades**, with whom one may talk and laugh when one is disposed to talk and laugh, and whom one may send to the devil when they grow wearisome. They are some compensation for the lack of friends. **That such free spirits can possibly exist**, that our Europe will yet number among her sons of to-morrow or of the day after to-morrow, **such a brilliant and enthusiastic company, alive and palpable and not merely, as in my case, fantasies and imaginary shades**, I, myself, can by no means doubt. I see them already coming, **slowly, slowly**. **May it not be that I am doing a little something to expedite their coming when I describe in advance the influences under which I see them evolving and the ways along which they travel?”***

The Traditional Error of Philosophers.—All philosophers make the common mistake of taking contemporary man as their starting point and of trying, through an analysis of him, to[21] reach a

conclusion. "Man" involuntarily presents himself to them as an aeterna veritas as a passive element in every hurly-burly, as a fixed standard of things. Yet everything uttered by the philosopher on the subject of man is, in the last resort, nothing more than a piece of testimony concerning man during a very **limited period of time. Lack of the historical sense is the traditional defect in all philosophers.** Many innocently take man in his most childish state as fashioned through the influence of certain religious and even of certain political developments, as the permanent form under which man must be viewed. **They will not learn that man has evolved,**⁴ that the **intellectual faculty itself is an evolution**, whereas some philosophers make the whole cosmos out of this intellectual faculty. But everything essential in human evolution took place aeons ago, long before the four thousand years or so of which we know anything: during these man may not have changed very much. However, the philosopher ascribes "instinct" to contemporary man and assumes that this is one of the unalterable facts regarding man himself, and hence affords a clue to the understanding of the universe in general. The whole teleology is so planned that man during the last four thousand years shall be spoken of as a being existing [22]from all eternity, and with reference to whom everything in the cosmos from its very inception is naturally ordered. Yet everything evolved: there are no eternal facts as there are no absolute truths. Accordingly, historical philosophising is henceforth indispensable, and with it honesty of judgment.

A wider focus model can help frame explorations of philosophy. See all my frames.

Dream and Civilization.—The function of the brain which is most encroached upon in slumber is the memory; not that it is wholly suspended, but it is **reduced to a state of imperfection as, in primitive ages of mankind**, was probably the case with everyone, whether waking or sleeping. Uncontrolled and entangled as it is, it perpetually confuses things as a result of the most trifling similarities, yet in the same mental confusion and lack of control the nations invented their mythologies, while nowadays **travelers habitually observe how prone the savage is to forgetfulness, how his mind, after the least exertion of memory, begins to wander and lose itself until finally he utters falsehood and nonsense from sheer exhaustion.** Yet, in dreams, we all resemble this savage. Inadequacy of distinction and error of comparison are the basis of[32] the preposterous things we do and say in dreams, so that when we clearly recall a dream **we are startled that so much idiocy lurks within us.** The absolute distinctness of all dream-images, due to implicit faith in their substantial reality, recalls the conditions in which **earlier mankind** were placed, for whom **hallucinations had extraordinary vividness**, entire communities and **even entire nations laboring simultaneously under them.** Therefore: in sleep and in dream **we make the pilgrimage of early mankind over again."**

Fat, Dumb and Lazy uncivilized people prefer easy delusion to any reality - no matter much how violence, death or destruction is involved. Remember Merv/Mary and Genghis Khan - **rivers of blood** for my delusions.

*"It was for the most part by sacrifices, processions, and religious dances, which he himself appointed and conducted, and which mingled with their solemnity a **diversion full of charm** and a beneficent pleasure, that he won the people's favour and tamed their fierce and warlike tempers. At times, also, by **heralding to them vague terrors from the god**, strange apparitions of divine beings and **threatening voices**, he would **subdue and humble** p333 their minds by means of **superstitious fears**. 4 This was the chief reason why Numa's wisdom and culture were said to have been due to his intimacy with the Pythagoreans; for in the philosophy of the one, and in the civil polity of the other, religious services and occasions have a large place. It is said also that the **solemnity of his outward demeanour** was adopted by him because he shared the feelings of Pythagoras about it. 5 That philosopher, indeed, is thought to have tamed an eagle, which he stopped by certain cries of his, and brought down from his lofty flight; also to have disclosed his golden thigh as he passed through the assembled throngs at Olympia. And we have reports of other devices and performances of his which savoured of the marvellous, regarding which Timon the Phliasian wrote:—*

*"Down to a juggler's level he sinks with his **cheating devices**, Laying his nets for men, Pythagoras, lover of bombast."*

Once, they say, when the inhabitants of Egypt were being hard pressed by a famine, many in their need laid hands upon their fellows, yet not a single man was even accused of having partaken of the **sacred animals**. 2 Furthermore, whenever a dog is found dead in any house, every inmate of it shaves his entire body and goes into mourning, and what is more astonishing than this, if any wine or grain or any other thing necessary to life happens to be stored in the building where one of these animals has expired, they would never think of using it thereafter for any purpose. 3 And if they happen to be making a military expedition in another country, they ransom the captive cats and hawks and bring them back to Egypt, and this they do sometimes even when their supply of money p289 for the journey is running short. 4 As for ceremonies connected with the Apis of Memphis, the Mnevis of Heliopolis²⁵ and the goat of Mendes, as well as with the crocodile of the Lake of Moeris, the lion kept in the City of Lions (Leontopolis), as it is called, and many other ceremonies like them, they could easily be described, but the writer would scarcely be believed by any who had not actually witnessed them. 5 For these animals are kept in sacred enclosures and cared for by many men of distinction who offer them the most expensive fare; for they provide, with unfailing regularity, the finest wheaten flour or wheat-groats seethed in milk, every kind of sweetmeat made with honey, and the meat of ducks, either boiled or baked, while for the carnivorous animals birds are caught and thrown to them in abundance, and, in general, great care is given that they have an expensive fare. 6 They are continually bathing the animals in warm water, anointing them with the most precious ointments, and burning before them every kind of fragrant incense; they furnish them with the most expensive coverlets and with splendid jewellery, and exercise the greatest care that they shall enjoy sexual intercourse according to the demands of nature; furthermore, with every animal they keep the most beautiful females of the same genus, which they call his

concubines and attend to at the cost of heavy expense and assiduous service. 7 When any animal dies they mourn for it as deeply as do those who have lost a beloved child, and bury it in a manner not in keeping with their ability but p291 going far beyond the value of their estates. 8 For instance, after the death of Alexander and just subsequently to the taking over of Egypt by Ptolemy the son of Lagus, it happened that the Apis in Memphis died of old age; and the man who was charged with the care of him spent on his burial not only the whole of the very large sum which had been provided for the animal's maintenance, but also borrowed in addition fifty talents²⁶ of silver from Ptolemy. And even in our own day some of the keepers of these animals have spent on their burial not less than one hundred talents.
