"(1) It is unlawful for a person to do any act involving a distinction, exclusion, restriction or preference based on **race, colour, descent** or **national** or **ethnic origin** which has the purpose or effect of nullifying or impairing the recognition, enjoyment or exercise, on an equal footing, of any human right or fundamental freedom in the political, economic, social, cultural or any other field of public life."

The above statement **is a lie** - because it becomes **limited by** the special clauses and exceptions later on. The dogma. The detail. The **legal scum bag** types. The courts then will run expensive legal cases to interpret **"their gospel of certainty"** on how the world should be in their excessively detailed and obscure dogma. #### 18C Offensive behaviour because of race, colour or national or ethnic origin

(1) It is unlawful for a person to do an act, otherwise than in private, if:

# (a) the **act is reasonably likely**, in all the circumstances, to **offend, insult**, **humiliate** or **intimidate another person** or a **group of people**; and

For example \_ I am offended by being attacked because of being white and male - for children being taught about whites in history or **Australia** - **nation**, **Britain** - **nation**, "the west" being evil. This offends me and is a constant daily insult - but this is not how this legislation is designed. More than that really - it is not "offence" as such, because humans destroy humanity in many ways - of course the pig-ignorant scum we see (legal types, ABC, Guardian, politicians, etc) - it is **a despair** of how **things could have been**. Idiots everywhere - the only people who believe that Malcolm Turnbull or Kevin Rudd have anything important to say about anything are themselves. So all the females appointed anywhere in the public services places are liars - they simply lie staring straight down the lens at the camera and LIE. *Women are the real victims - the biggest victims - the most needy victims*. 

So the **Trap** for **staying in the feedback loop** of **3**. – *self focused and positioning by others* is **taking on** the **blame**, **shame**, guilt or being **patronized** (stroked)



This represents **the baby or child state** - being controlled by a dominating person - a feminist, tyrant, abuser, tyrant, dictator, controller, magistrate, etc - they try to invoke you feelings of shame, guilt and responsibility - even for things that are none of your business. This is the Black Lives Matter, Blacks, Feminists domestic violence, Trans, Women's Homelessness, Quotas "isn't about time we had a trans-pixie as a president", "Greater Good", Communist party manifesto, the "state". **Resentment, Entitlement and Vice** – constantly positioning themselves as superior and getting some support from others playing the same mob games – like feminists, mobs and other corrupt people – they dive into **Jealousy**, Resentment and increasing corruption which they see as their entitlement and if called out they fall back to the previous 2 feedback loops and re-enforce and strengthen those. The **feedback trap** for **1**. **Not for Self our Others** is being aware of all the other feedback loops but also the risks of **self delusion**, **bias** and **regret** – which can affect motivation and energy – especially back to the underlying human conditions of **Fat**, **Dumb** and **Lazy**. In short – those people best positioned to deal with **not not** ignorance are those **most fully and almost overwhelmingly aware of everything** they are facing. Hence the circle of the universe surrounds them - they are fully out of the cave of certainty.



At this stage of development learning means not "how to do something" - but recognizing the depth and breadth of how little you know. You know that if people agree with you or you are popular then you are probably wrong. Justice remains a concept almost impossible to define - yet justice might be the right kind of concept. Socrates did not write about himself - others did so that his name lives on. It might have been a precursor model for the "savior" myth or the stories about "the wise one". Hannah Arendt did not get around to writing Justice or "judging" <u>https://en.wikipedia.org/wiki/Hannah\_Arendt</u> - there were too many things to investigate along the way.

### **Organized Crime Syndicates**

*Gangs of New York* - everywhere. Greens/Labour types - bags of cash, favours, protection rackets, paid judges and corrupt police and court systems, corrupt media, political appointments, grants, gifts, government money to friends and family, mob violence, stand over tactics and threats - that's the way we do things around here.

Green and Blue gangs formed in Byzantine Roman Empire - supported by the corrupt Justianian and his wife. They roamed the streets stealing and killing and entered into power arrangements around the empire. Tribalism was everything but is was not obvious why - except for naked power and control and disruption of society.

The people had **since long previous time been divided**, as I have explained elsewhere, into two factions, the Blues and the Greens. Justinian, by joining the former party, which had already shown favor to him, was able to bring everything into confusion and turmoil, and by its power to sink the Roman state to its knees before him. Not all the Blues were willing to follow his leadership, but there were plenty who were eager for civil war. Yet even these, as the trouble spread, seemed the most prudent of men, for their crimes were less awful than was in their power to commit. Nor did the Green partisans remain quiet, but showed their resentment as violently as they could, though **one by one they were continually punished**; which, indeed, urged them each time to further recklessness. For men who are wronged are likely to become desperate.

Then it was that Justinian, **fanning the flame and openly inciting** the Blues to fight, made the whole Roman Empire shake on its foundation, as if an earthquake or a cataclysm had stricken it, or every city within its confines had been taken by the foe. Everything everywhere was uprooted: **nothing was left undisturbed by him**. Law and order, throughout the State, overwhelmed by distraction, were turned upside down.

First the rebels revolutionized the style of wearing their hair. For they had it cut differently from the rest of the Romans: not molesting the mustache or beard, which they allowed to keep on growing as

long as it would, as the Persians do, but clipping the hair short on the front of the head down to the temples, and letting it hang down in great length and disorder in the back, as the Massageti do. This weird combination they called the Hun haircut.

Next they decided to wear the purple stripe on their togas, and **swaggered about** in a dress indicating a rank above their station: for it was only by ill-gotten money they were able to buy this finery. And the sleeves of their tunics were cut tight about the wrists, while from there to the shoulders they were of an ineffable fullness; thus, whenever they moved their hands, as when applauding at the theater or encouraging a driver in the hippodrome, these immense sleeves fluttered conspicuously, displaying to the simple public what beautiful and well-developed physiques were these that required such large garments to cover them. They did not consider that by the exaggeration of this dress the meagerness of their stunted bodies appeared all the more noticeable. Their cloaks, trousers, and boots were also different: and these too were called the Hun style, which they imitated.

Almost all of them carried steel openly from the first, while by day they concealed their two-edged daggers along the thigh under their cloaks. **Collecting in gangs as soon as dusk fell, they robbed their betters in the open Forum and in the narrow alleys**, snatching from passersby their mantles, belts, gold brooches, and whatever they had in their hands. **Some they killed after robbing them**, so they could not inform anyone of the assault.

These outrages brought the enmity of everybody on them, especially that of the Blue partisans who had not taken active part in the discord. When even the latter were molested, they began to wear brass belts and brooches and cheaper cloaks than most of them were privileged to display, lest their elegance should lead to their deaths; and even before the sun went down they went home to hide. But the evil progressed; and as **no punishment came to the criminals from those in charge of the public peace**, their boldness increased more and more. For when crime finds itself licensed, there are no limits to its abuses; since even when it is punished, it is never quite suppressed, most men being by nature easily turned to error. Such, then, was the conduct of the Blues.

Some of the opposite party joined this faction so as to get even with the people of their original side who had ill-treated them; others fled in secret to other lands, but many were captured before they could get away, and perished either at the hands of their foes or **by sentence of the State**. And many other young men offered themselves to this society who had never before taken any interest in the quarrel, but were now **induced by the power and possibility of insolence they could thus acquire**. **For there is no villainy to which men give a name that was not committed during this time, and remained unpunished**.

Now at first they killed only their opponents. But as matters progressed, they also murdered men who had done nothing against them. And there were many who bribed them with money, pointing out personal enemies, whom the Blues straightway dispatched, declaring these victims were Greens, when as a matter of fact they were utter strangers. And all this went on not any longer at dark and by stealth, but in every hour of the day, everywhere in the city: before the eyes of the most notable men of the government, if they happened to be bystanders. For they did not need to conceal their crimes, having no fear of punishment, but considered it rather to the advantage of their reputation, as proving their strength and manhood, to kill with one stroke of the dagger any unarmed man who happened to be passing by. No one could hope to live very long under this state of affairs, for everybody suspected he would be the next to be killed. No place was safe, no time of day offered any pledge of security, since these murders went on in the holiest of sanctuaries even during divine services. No confidence was left in one's friends or relatives, for many died by conspiracy of members of their own households. Nor was there any investigation after these deeds, but the blow would fall unexpectedly, and none avenged the victim. No longer was there left any force in law or contract, because,of this disorder, but everything was settled by violence. The State might as well have been a tyranny: not one, however, that had been established, but one that was being overturned daily and ever recommencing.

The magistrates seemed to have been driven from their senses, and their wits enslaved by the fear of one man. The judges, when deciding cases that came up before them, cast their votes not according to what they thought right or lawful, but according as either of the disputants was an enemy or friend of the faction in power. For a judge who disregarded its instruction was sentencing himself to death. And many creditors were forced to receipt the bills they had sent to their debtors without being paid what was due them; and many thus against their will had to free their slaves.

And they say that certain ladies were forced by their own slaves to do what they did not want to do; and the sons of notable men, getting mixed up with these young bandits, compelled their fathers, among other acts against their will, to hand over their properties to them. Many boys were constrained, with their fathers' knowledge, to serve the unnatural desires of the Blues; and happily married women met the same misfortune.

It is told that a woman of no undue beauty was ferrying with her husband to the suburb opposite the mainland; when some men of this party met them on the water, and jumping into her boat, dragged her abusively from her husband and made her enter their vessel. She had whispered to her spouse to trust her and have no fear of any reproach, for she would not allow herself to be dishonored. Then, as he looked at her in great grief, she threw her body into the Bosphorus and forthwith vanished from the world of men. Such were the deeds this party dared to commit at that time in Constantinople.

Yet all of this disturbed people **less than Justinian's offenses against the State**. For those who suffer the most grievously from evildoers are relieved of the greater part of their anguish by the **expectation they will sometime be avenged by law and authority**. Men who are confident of the future can bear more easily and less painfully their present troubles; but **when they are outraged even by the government what befalls them is naturally all the more grievous, and by the failing of all hope of redress they are turned to utter despair.** And Justinian's crime was that he was not only **unwilling to protect the injured**, but saw no reason why he should not be the **open head of the guilty faction; he gave great sums of money to these young men, and surrounded himself with them: and some he even went so far as to appoint to high office and other posts of honor**.

#### **Explaining some of the idiocy**

Wake up and notice this. This is insight and understanding that most humans cannot appreciate.

In this section I will be examining many things that humans do which are based on a fundamental view of probability, choice and populations. Most humans have no real understanding of these things and will fall back (Fat, Dumb and Lazy) to simplified interpretations and then invest smug


certainty and abuse (confirmation bias, sunk cost bias) against anyone who dares to explain things or question their dim, half-witted ideas.



### **Definition** – Communication and Language uncertainties and complexities



Humans find it difficult to think when complacency has set in - Fat, Dumb and Lazy Humans particularly Women (on average - quotas/targets - wages - entitled/victim, etc) and Blacks - generally sit around all day doing nothing but complaining and big-noting themselves while living off the fat of the land - narcissists, etc - humans fail to notice or contend with things because the only thing these narcissists and self-possessed psychopaths deal with is themselves - not the nation or society as a whole - but just what they individually can get out of it in money, graft, corruption, revenge, certain "safety" (the cave), abuse, control, virtue signals (a stairway to heaven), etc. In societies where every person has to contribute and all contribute to society in their own way - they tend to be more cohesive and every person is valued. 
Note Well:NB: The duality concept of Zero/Null - Measurement/Definition - is a significant conceptual frame - although it seems obvious - it is not well documented or stressed. ## Creative people dive into the unknown to retrieve fragments from the Chaos of uncertainty and complexity.

### **They are Explorers**

Beauty can be **found in the unexpected** which emerges from the newly explored or the newly created. Walking into the Pantheon or a great cathedral or Plitvice Lakes or the 12 apostles, seeing new art works, etc.


The explorers I described in previous articles were generally exploring the known spaces of the number line and pre-defined frames or very well framed or grounded in something. Compare this when creative types who try to leave as much grounding aside to find the unknown. This is not for the faint hearted. Setting off in a sailing ship with a small crew not knowing what happens to the universe as you leave the safety of known places is a journey many of us take in many ways. Many have tried and failed.

Smug cave dwellers find anything new or different "offensive" and wish to remain tribal mobs.

China will never have creative people because they are all bound by communism (certainty) and totalitarian rule (dogma). The Chinese go out of their way to kill creativity and exploration. They are destined to repeat the simple things they already know and the ideas they can copy and steal from other civilizations.

So we have the spreadsheets which I have reformatted and updated so you can see more clearly. Remember - the **mandated group strategy** is to pick your box - the box with your number on it i.e. person number 1 picks box number 1, read the number inside the box from the slip of paper and then go to that box and pick it. This is demonstrated to improve the group results and likelihood of picking their own number for the group as a whole. For the 4 box model of probabilities this is

So this shows that condition 1 mandated minimum - meaning **100% successful choice** - only occurs 6.25% (red line) of the time without a shared group strategy but 42% (blue line) with a shared group strategy. This, to many dim-wits, would **sound like a convincing argument**. At condition 5 mandated minimum - meaning **0% successful choice** - i.e. every fails - only occurs 6.25% (red line) of the time without a group strategy but 25% of the time (blue line) with the shared group strategy. Now if anyone tells you they understand exactly how probability and choice work then they are **probably lying**.

You will notice that - on average (50%) - you get a higher success rate - 69% (red line) if you do not mandate a group choice strategy than if you do - 42% (blue line).

Notice **all humans will definitely fail for 25% of the possible combinations of the universe** using a mandated strategy.

This is where the **"better"**, **"Greatest Good"** and **"equality"** arguments take place. In the above graph there is no obvious "greatest good" - how would you define it - optimal "success" or avoiding total failure or something in-between? Equality of what exactly? Mandated? - Make everyone the same - call them all person 1 and give them box 1 to choose? Again a certain death strategy. Remember the definitions, measurements are highly uncertain and complex - all you have is a model of certainty which you think is telling you something. Don't let an expert tell you they know what is going on - because they don't.


**Average what** exactly - which numbers are "averaged" and compared? Binary extremists say "just give me the certain number". One answer is 'how about I give you some choices and options instead?"

Maths experts will step in and make up equations and start multiplying numbers together as if they know what is going on. The mistakes they make is missing where the infinites are (trying to multiply them) and coming up with a binary certain number.

The empaths will look at the Koala who keeps picking boxes but never finds the right kind of leaves to eat and say it is a catastrophe. There is no guarantee of leaves in the universe - that's is why adaptation exists. Limiting your diet to one type of thing is not a good survival mechanism.

I know let us call ourselves tribes - we can be tribe1 and then tribe 2 and tribe 3 and tribe 4 - and then they can all play the game as certain tribes? Whole tribes can be wiped out instead of the individuals - mob warfare. Again - the opposite of plurality.

Herd immunity is not mandated - it is the ability for people in the community to survive and adapt - a variation which is unmandated and not a fixed, binary certain, boxed and defined strategy.



Binary certaintists use numbers and probability to choose genetics - cloning of plants, animals and humans - all without appreciating the realities of chance, probabilities - nirvana, utopia, certain god, etc. They (binary extremists, zealots, Marxists, feminists, women (on average)) believe in the "Final Solution" like all good Nazis.

So to go through this a bit more - the original 100 prisoner game is reduced to 4 then I wrote out all the combinations and results of 4 prisoners playing the 4 box game.

The mandated strategy guarantees - not only a higher failure rate probability overall - but a **permanently enshrined species death** when the universe is in one of the 6 permanent fail states. This is not probability - this is certainty - when the universe is in those states (boxed - transfinite, bounded and constrained) - certain death is guaranteed.

Mandated certain death is called an "unintended consequence" - who would have anticipated that? Binaries, experts, zealots and the like have no understanding of anything much - at best they come up with the group mandate model which always guarantees certain death and then get surprised when it happens. We see this in liars and binary haters like **Bill Shorten** - who not only labeled those protesting against mandatory vaccines and lockdowns as "Right Wing Extremists" but then fails to answer a question in parliament as NDIS minister - about the side effects of the vaccine and the records so far - a fair question given that none of the vaccines have been tested and approved in anything other than a rushed and "emergency" process and there are some possibilities of sideeffects - what are they? What are the unintended consequences Bill? Bill binary extremist mob type and corrupt like the Greens/Labour/teals types who are currently destroying and stealing as much as they can for themselves, the donors, their friends and family. Rather than understand and learn they double down on their pig-ignorance, lies and corruption masked in virtue signaling and implemented as a MOB ATTACK on anyone who dares to question - like all the *mean girls*, scowling face, chortlers, snide remarkers, revelers and human scum who are the Green/Labour types. So Bill as commonwealth minister for NDIS - that is disabled and usually elderly people needing support and help - completely ignores any responsibility for his portfolio in insuring they are protected from potential side effects of a hastily approved mandated (workers and others) vaccine. Especially those with complicated genetic or other physical complications interacting with a vaccine - as well as those too intellectually impaired to be able to weigh up the choices - even if they were informed. The difference in the unmandated choice strategy in this box game - individuals always have a 50% chance - tending to transfinite infinity - of success of choice. Not only is it a lower probability of total failure - but it is not mandated certain failure - as long as some remain to choose again next time - then there is a chance to avoid total failure. Paul Erdos intuitively understood this when quizzed about Monty Hall but he was not able to detail the arguments.

To make it a bit clearer - I have taken the **transfinite infinity** of the definite arrangements of the possibilities in the 4 boxes (24 possible combinations) - the possible definite combinations - and replaced that with an **unbounded infinity** of possibilities of choice. I think I have moved one degree of freedom away from bounded and constrained. Yes - even with the 24 combinations of bounded and constrained options the universe could proceed infinitely through the 24 certain possibilities in infinitely many ways but the people cannot. The people are stuck in a choice strategy - whereas the unmandated group will always have a chance of success (tending to unbounded infinity).


Another way of looking at this is that the 16 box **model of possibilities** of choice is what you get with free choice on the 24 box **model of definite combinations**. I cannot connect the two models - they are independent as far as I can tell. i.e. any of the 24 combinations and 16 possibilities of choice are equally as likely. Hence the total figures represent the "on average" results.

I need to repeat this - the possible combinations of things is **not connected** to the possible choices people make - yet this is exactly the point that many humans **will assert that there is a connection** and that they KNOW what the connection is and how to optimize it - "greatest good".

I created another spreadsheet to highlight this. You will notice that no matter what the **infinity of possible arrangements of the 24 combinations of 4 numbers in 4 boxes** - there are only 16 possible scenarios. How often those arrangements occur is another question which I cannot answer but many assume to be "equal" (on average).

It is worth noting that any individual could choose correctly every single time the game is played for infinity. This is individual excellence over mandated group strategy - something the Chinese, feminists, Marxists, binary extremists, zealots do not understand or appreciate. The group can then learn from that individual. Individual excellence over group averages. ID 1 - scenario 1 all the time for infinity is possible.



To make it even clearer - the 24 possible combinations are not guaranteed to appear in infinity. It is possible only one combination will appear for ever. And, while we have the central limit theorem, doctrine of the mean, etc - it is only a theory. The other thing to realize is that any number of the 24 combinations may appear over time and then there might different rates of change and cycles through the combinations. You cannot tell. The infinity of 24 combinations appearing is unknown and never will be. At the same time the infinity of 16 choice outcomes may also appear in infinitely different ways. Hence multiplying two infinities together might seem to remove complexity but all it does is hide the uncertainty and complexity so you cannot appreciate it.

I have done a final spreadsheet to compare which is done in the classic Bayes way of multiplying probabilities. In this case what we do is set out the 16 possible outcomes and then calculate the probabilities for each mandated outcome and then add them up

All the probabilities are the same for each row for mandated group minimums of independent events - each time 4 people make 2 picks independently from 4 boxes.

- 100% 4 correct = 0.5\*0.5\*0.5\*0.5 = **0.0625**
- 75% 3 correct = 0.5\*0.5\*0.5 = 0.125
- 50% 2 correct = 0.5\*0.5 = 0.25
- 25% 1 correct = 0.5
- 0% none correct = 0.5\*0.5\*0.5\*0.5 = **0.0625**

But we have to recognize that these appear in multiple places in the 16 possible outcomes?? How do I do that? Do I add them up and divide by 16? Or is it already calculated and taken into account = e.g. 0.0625 is 1/16?

Here I have divided the sum of the rows by 16.

Is this correct? Have I done it correctly? What am I missing? I seem to just be making up numbers and calculations for the fun of it. Without understanding the meaning of it. De Moivre does these examples with dice rolls.

I know - maybe I have to calculate what "at least - mandated means". So if 4 people pick 2 boxes - each with a 50/50 chance then what does it mean to have at least one person pick correctly? Here is the problem - if I add up 4 0.5s I get 2. Then if I divide than by 4 I get 0.5 again.

The problem is that it is complicated - it is not easy to see all the possible combinations "at least 2", etc mandated. Some formulas can be used to do estimates - but they tend to hide the infinities and complexities.

So it is about the 16 **possibilities not about** the 50% multiplications? - that would leave me with only 5 possibilities (on average) - now you see where "On Average" comes in a lot.

- 100% 4 correct = 1/16 = **0.0625**
- 75% 3 correct = 5/16 = 0.3125
- 50% 2 correct = 11/16 = 0.6875
- 25% 1 correct = 15/16 = 0.9375
- 0% none correct = 1/16 = **0.0625**



To highlight this a bit more. The argument for plurality, less dogma, no mobs, no group mandate, freedom of choice, tolerance, appreciation of difference, respect of individuals, less totalitarian government, etc is an argument based on the reality of the world. The survival of life itself. The development of everything great and wonderful was not mandated as group choice. It was the different individual who invented it. Chinese , Russians, mobs, tribes, Marxists, fascists, communists, socialists, Zealots, Binary causists, feminists, women (on average), weak-minded men, virtue signalers, etc - do not understand this and never will.

Most mathematicians, scientists and thinkers do not understand this and most epidiomologists do not understand this either. They have no real appreciation of maths and complexity and uncertainty. If they claim they understand it - they are lying. If they claim they know what people "should do" as mandated - they are lying. At best all they can give is information not a "direction". They can persuade by information - not don a "white coat" and claim expertise on what everyone should choose to do.



People take responsibility for their own choices, learning as they develop. Avoiding doing this because they are "popular" or they are controlled "drama triangle/passive aggressive". With justice supporting choice and exploration - sustainability of life continues. Groups communicate, cooperate, trust other people choices for themselves.

### **Gamblers Fallacy - Doctrine of Chances - Doctrine of Choice**

Any roulette player (zero is the edge for the house), horse racing better, gambler on dice, cards, lotto, lottery (popular in England from 1690's) <u>https://en.wikipedia.org/wiki/Lotteries\_Act\_1710</u>, voting preferences, mortality rates, life insurance tables, etc - all have a theory. Many have a system. Many believe their system "works". This is how casino operators and race track book makers make their money (on average) - on the belief that gamblers have. The idea being that there a limited number of definite combinations and I can work out all the permutations and mandate a best choice strategy to win the game by using maths.

On simple example of the "edge" that games people give themselves over players is on the TV show "The Chase". Questions are asked of 4 players and the Game show expert. But when the final chase

is run - the 2 or more players who are left have to press the button, wait for their name to be called and then answer the question. This results in an extra second of time per question for their one minute allotted time. The Game's expert does not need to press a button or wait for their name they immediately answer the question when they like. This gives them a 20 to 30 second advantage in a minute over the team of players.

When tattslotto had less numbers (36?) people worked out that you could **cover the combinations** and increase your chances of winning - "guaranteed". You can always get a winner on a two horse race by covering the combinations - what you can't do is get your money back or cover the prize pool. Bookies stay in business for a reason. The value of the Expected sum. "Expectation" in de Moivre's words. In tattslotto you may will spend millions of dollars covering the combinations but if 100 random players all get the major prize as well as you - you get far less "winnings" than you were expecting or calculating.

He explains "without replacement' and "with replacement" in taking cards from a deck and how probabilities change - "dependent" events. He shows the example with throwing dice. Throwing 2 Aces (one) in a row. The immediate idea is that most people will assume that the events are independent and that it is simply 1/6 for each throw (hence 1/36 chance) - but the requirement "two in a row" means that you have **to look at all the possible combinations**. For example - in the following case he looks at throwing AT LEAST ONE ACE in two throws

Case 1.

To find the Probability of throwing an Ace in two throws of one Die. SOLUTION.

The Probability of throwing an Ace the firft time is 1/6; where-fore 1/6 is the firft part of the Probability required.

If the Ace be miffed the firft time, ftill it may be thrown on the fecond, but the Probability of miffing it the firft time is 5/6, and -the Probability of throwing it the fecond time is 1/6; wherefore the

Probability of miffing it the firft time and throwing it the fecond, is 5/6 \* 1/6 = 5/36 and this is the fecond part of the Probability re-quired, and therefore the Probability required is in all 1/6 + 5/36 = 11/36

Yes - The probability of throwing 2 aces in two throws = 1/6 \* 1/6 = 1/36 - but it is not obvious that you have seen or understood all the possible combinations.

An as explained in my spreadsheet - it is not so obvious. The other thing to realize is that this mainly a **COMBINATIONS problem** - not really an individual CHOICE problem. The individual is irrelevant of the throwing of the dice for repeated tries - all the combinations are already there - it will tend to binomial distribution - all things being **equal on average**. There are only fixed combinations. It is a

**fixed predetermined game** - time and sequence make no difference. **The probabilities will never change**. De moivre makes this very point - you can wait a lifetime to throw the next dice - the probability will not change. This is why the monty hall combinations have to be written out - it is a fixed game of combinations.

"Suppofe therefore that the Probability of throwing an Ace in four throws Vi'ith a common Die of fix faces be demanded. In order to anfwer this, it mufi: be confidered that the throwing of one Die four times fuccefTively, is the fame thing as throwing four Dice at once; for whether the fame Die is ufed four times fuc-cefTively, or whether a different Die is ufed in each throw, the Chance remains the fame; and whether there is a long or a fhort interval be-tween the throwing of each of thefe four different Dice, the Chance remains flili the fame; and therefore if four Dice are thrown at once, the Chance of throwing an Ace will be the fame as that of throwing it with one and the fame Die in four fuccefiive throws."

Where **CHOICE is actually taking place** is that it is possible that **any individual** can keep throwing ones for infinity by "chance" but **not on average** for the group of repeated tries. This is possible but the central limit theory (Gaussian) and observations over time push things towards the binomial distribution and the power law. De Moivre emphasizes the maths and calculations of that limit. Another Choice is that **you Choose 1 every time** - you have taken probability away from the process. You simply choose 1 every time. That is choice. Sometimes you make a mistake and choose 2. Choosing **not to play** and choosing to destroy the dice or write ones on each face. These are choices.

The trick is recognizing the rules - "at least 2 in a row" or Monty opens a door (he makes a choice for you - the probabilities have changed - revealed knowledge), mandated minimum, group outcome - mandate. This is like turning up to a dice game and **not knowing** that the person before you has thrown 10 aces in a row. If you knew this - would it change your probability? and if you did not know this what would it mean? i.e. your probability of throwing 2 in a row as a statement is different to the statement of the group throwing 12 in a row? (groups' previous 10 plus your 2?) is it only true because it is observed and if no-one observed it does not affect probability? None of this is well understood. This is when all the combinations have to be calculated - it is a group outcome (on average). It is set theory, central limit theorem, permutations

<u>https://en.wikipedia.org/wiki/Permutation</u> - essentially this is all based on the integer number line itself. The initial self-reference and recursion. The assumption is that each permutation has an equal chance of selection (on average over repeated tries) - it is only about adding up the numbers of combinations.

The Weak Law of Large numbers is not a proof either - it is observation (on average) <u>https://en.wikipedia.org/wiki/Law\_of\_large\_numbers</u>.

Once you start plugging numbers into formulas you are getting "averages".

Another problem is that the **ZERO CASE is not well catered for in the formula**. Multiplying and dividing by zero is a problem in maths - yet clearly there exists a permutation where no selected result is achieved. You get 4 fails in a row. Or fail to get any passes at all. A zero result for everyone. Instead you can express the idea as a 100% chance of failing rather than a zero percent chance of success. The two limiting permutations are transfinite infinity "wins" and transfinite infinity "fails" - each one permutation of transfinite infinity.

Nothing in real life is normally distributed in a group. There are variations and these come from choice - something other than the tendency to the mean (on average). Finding where your choice is being made is not such a simple thing - it is not easy to identify the choices you have or the choices you make and most of life is not tied up in fixed boxes, lottery numbers, labeled dice or cards.

#### **Tribes and Democracy - Athens**

Fairness - representation responsible accountable - involvement in the collection and cooperation.

Reducing the problems of tribalism, dominance and unfairness.

**Cleisthenes** changed the system around Attica so **Demes** <u>https://www.britannica.com/topic/deme-ancient-Greek-government</u> were formed to represent fixed areas which included the villages and countryside. This was a significant cultural shift away from Tribes, Families and city states. Locations represented people from many tribes and family groups and they had responsibilities for providing politicians, magistrates and soldiers for the greater collective. Although tribes and families still existed - a new structure was put in place to cut through the tribal and family lines. It also brought the entire land - countryside, farms and villages into the system - instead of just being dominated by city-states.

This location and area idea can be called an **idea of the West**. This was a big idea that turned into areas, borders, states and empires. One of the more wealthy areas in history was the "Papal States" of Italy - **Papal States** - Culture[756 to 1870] <u>https://en.wikipedia.org/wiki/Papal\_States</u> - which was balanced by other states around it - Florence, Venice , Sicily, Sardina, etc - so that **no one state dominated** the region.

Plato, Aristotle and Cicero expanded on the general themes of commonwealths and government.



A problem with these societies is that there are always groups/tribes **at the extreme** who fail to follow the general rules of the society and actively seek to corrupt, destroy, etc the society. The dilemmas discussed by Aristotle are usually at the extremes - the idea of certain "atoms" and vague some things - things on a continuum rather than extremely certain binary positions. E.g. indivisible versus divisible. **An initial self-reference, recursion type problem of definition and measurement.** 



Tribes and gangs tend to form into groups and seek to cause damage to societies and nations rather than contribute to society - they try to tear it down - "*lets burn the place down*" (as promoted by the ABC) and "*Kill all men*" (as promoted by the ABC and Melbourne politicians). It is not so much as alternative hypothesis, and debate - rather a mob-like tribal brutality and abuse. This typifies the behavior of Greens/Labour, ABC, binary extremists, zealots, causists, Blacks and Women (on average - entitled/victim - quotas/targets - wages, etc).

Worse yet, it occurs to me that what I am now about to tell will seem neither probable nor plausible to future generations, especially as time flows on and my story becomes ancient history. I fear they may think me a writer of fiction, and even put me among the poets.

However, I have this much to cheer me, that my account will not be unendorsed by other testimony: so I shall not shrink from the duty of completing this work. For the men of today, who know best the truth of these matters, will be trustworthy witnesses to posterity of the accuracy of my evidence.

Still another thing for a long time deferred my passion to relieve myself of this untold tale. "Now the populace from of old has been divided into two Factions, as was stated by me in the preceding narrative,1 and he now adopted one of them, namely the Veneti or "Blues,"2 of whom, as it happened, he had previously been an enthusiastic supporter, and thus succeeded in throwing everything into confusion and disorder; and thereby he brought p79 the Roman State to its knees.3 2 But not all the Blues saw fit to follow the will of this man, but only those who chanced to be militant. 3 And yet even these, as the evil developed, seemed to be the most temperate men in the world;4 for their sins fell short of their licence to commit them. 4 And of course the militant group of the Greens did not on their part remain quiet, but they too were constantly busy with crimes, as far as came within their power, although they were being punished continually, one at a time. 5 Yet this very fact always led them on to deeds of much greater daring; for men, when they unjustly treated, are wont to become desperate. 6 So at this time, while he kept fanning the flames and manifestly stirring up the Blues, the whole Roman Empire was agitated from top to bottom, as if an earthquake or a deluge had fallen upon it, or as if each and every city had been captured by the enemy. 7 For everything was thrown into confusion in every part and nothing thereafter remained fixed, but both the laws and the orderly form of the government were completely overturned by the confusion that ensued."

#### And the weak-minded men and other criminals joined in the spree of the gangs/tribes/mobs.

And **Justinian** offended not alone in that he refused absolutely to champion the cause of the wronged, but also because he did not object at all to making himself the avowed protector of the Factionists; 42 for he kept **issuing great sums of money to these youths**, and retained many of them about his own person, and some of them he even saw fit to **summon to the magistracies** and to **other stations of honour**."

Not in all cases, however, but only upon those reputed to be Greens or to be possessed of great wealth or those who in some other way **chanced to have offended the rulers**. 37 Furthermore, they were bitter against astrologers. 4 And while he seemed to have a *firm belief as regards Christ*, yet even this was for the ruin of his subjects. For he permitted the priests with comparative freedom to outrage their neighbours, and if they plundered the property of the people whose lands p159 adjoined theirs, **he would congratulate them**, thinking that thus he was **shewing reverence for the Deity**. 5 And in adjudicating such cases, he considered that he was acting in a pious manner if any man in the name of religion succeeded by his argument in seizing something that did not belong to him, and, having won the case, went his way. For he thought that justice consisted in the priests' prevailing over their antagonists."

The pious, sanctimonious, virtue signaling, liar, religious, zealot, corrupt, hypocrite, psychopath, violent, dictator (Green/Labour, binary zealots, etc)

"And he rendered judgment, not according to the laws which he himself had written, but according as he was influenced by the vision of a greater or more magnificent promise of money."

**Greed, corruption, courts** - just like the Canberra courts, family courts - all corrupted - all about the money and corruption.

"And practically all the soldiers at that time were abandoning their proper posts and, according to their own sweet will, walking in ways that were forbidden and had hitherto never been open to them to tread, and everything was being swept along pell-mell, not even retaining any proper designation of its own, and the commonwealth resembled a kingdom of children at play."

#### Police-state - tyrants breed tyrants

There was a certain Leon, a Cilician by birth, a man extraordinarily devoted to the love of money. This Leon came to be the mightiest of all flatterers and shewed a capacity for suggesting to the minds of stupid persons that which already had been determined upon. 17 For he had a kind of persuasiveness which helped him, when dealing with the fatuity of the tyrant, to accomplish the destruction of his fellow-men. This man was the first to persuade Justinian to sell legal decisions for money. 18 And when that sovereign had once decided to follow, in his stealing, the plan which has been described, he never stopped, but this evil kept advancing until it grew to a great size; and whoever was eager to lodge an unjust accusation against a citizen of the respectable sort proceeded straightway to Leon, and by promising that some portion of the disputed property should fall to both the tyrant and to him, he had forthwith won his case, however unjustly, before he left the Palace.12 19 And Leon succeeded in acquiring from this source a truly huge amount of money, and he came into possession of much land, and in so doing became the chief agent in bringing the Roman State to its knees. 20 Indeed there was no security for those who had entered into contracts, no law, no oath, no documents, no fixed penalty, no other resource at all except to fling out money to Leon and the Emperor. 21 Yet not even this process enjoyed the fixed approval of Leon's judgment, but he insisted upon getting money from the other side as well. 22 For since he stole constantly in both directions, he never suspected p177 that to neglect those who had put their confidence in him and to go against him involved any shame. 23 For provided only that gain accrue, he believed that no disgrace would attach to him in playing off both sides.

The Lawyers - the cabal - the legal system of our time - graft corruption and lies. Leons.

And many of the adulterers actually attained honour from this conduct. 26 Consequently **most men** thereafter, **though outrageously treated by their wives, were very glad to remain silent** and escape the scourge, granting their wives complete freedom by allowing them to think that they had not been detected."

"And four years later she succeeded in finding two members of the Green Faction in Cyzicus who were said to be of those who had risen against the Bishop.6 42 And she won over these men with flattering speeches and with threats, with the result that one of them, in terror and at the same time uplifted by hopes, laid the sacrilege of the Bishop's murder at John's door. 43 As for the other man, he refused absolutely to contradict the truth, though he was so racked by the torture that he was even expected to die immediately. 44 Therefore, a although she was unable, no matter what means she employed, to destroy John through this subterfuge, **she cut off the right hands of these two young men**, of the one because he had refused to bear false witness, and of the other in order to prevent her plot from becoming altogether manifest. 45 And though these intrigues were being carried on in the publicity of the market-place, Justinian pretended to know absolutely nothing of what was going on."

Rent-seekers, World Economic Forum, Jobs for Donors, bankers, financiers - corruption and abuse.

"Such was the state of affairs for the Romans, as p253 touching their magistrates. And many a time, when a hostile army of Huns had enslaved and plundered the Roman domain, the generals of Thrace and Illyricum, after purposing to attack the retreating enemy, recoiled when they saw a letter from the Emperor Justinian forbidding them to make the attack upon the barbarians, they being necessary to the Romans as allies against the Goths, it might be, or against some other enemy. 27 As a result of this, these barbarians used to plunder and enslave the Romans in those parts as enemies, and then, taking with them their prisoners and the rest of their plunder, they would retire to their own homes as friends and allies of the Romans. 28 And often some of the farmers of that region, moved by the loss of their children and women, who had been reduced to slavery, gathered in a body, attacked the retreating foe, and succeeded in slaying many of them and in capturing their horses together with all the booty; then, however, they found themselves involved in serious difficulties. 29 For certain men, sent out from Byzantium, saw fit to maul and mutilate their bodies and to impose fines upon them without the least compunction, until they gave up all the horses which they had wrested from the barbarians."

The popular dissensions, founded on the most serious interest, or holy pretence, have scarcely equalled the obstinacy of this wanton discord, which invaded the peace of families, divided friends and brothers, and tempted the female sex, though seldom seen in the circus, to espouse the inclinations of their lovers or to contradict the wishes of their husbands. Every law, either human p362 or divine, was trampled under foot, and as long as the party was successful, its deluded followers appeared careless of private distress or public calamity. The licence, without the freedom of democracy, was revived at Antioch and Constantinople, and the support of a faction became necessary to every candidate for civil or ecclesiastical honours. A secret attachment to the family or sect of Anastasius was imputed to the Greens; the **Blues were zealously devoted to the cause of orthodoxy and Justinian**, and their grateful patron protected, above five years, the disorders of a faction whose seasonable tumults overawed the Palace, the Senate, and the capitals of the East."

They grow fat on the labours of other, like a calf on grass. They do not understand that the needy exist. Their thought, day and night, is to know who to catch in their net: our rich men. As for the judges, they allow themselves to bribed with gifts. Deception and hypocrisy, anger, malice and harshness, these are their own."

The pair in process of time gradually became more expert in doing harm, and through underhand and crafty eavesdroppers, who had the evil habit of lightly adding to their information and wanting to learn only what was **false and agreeable to them**, they **fastened upon innocent victims false charges** of aspiring to royal power or of practising magic."

Deluded narcissistic tyrannical psychopaths worked as husband and wife teams. As we see now with Green/Labour types, ABC, media, etc.

Cicero on the Republic book 2 [2] Cato used to say that our constitution was superior to those of other States on account of the fact that almost every one of these other commonwealths had been established by one man, the author of their laws and institutions ; for example, <u>Minos</u> in Crete, <u>Lycurgus</u> in <u>Sparta</u>, and in Athens, whose form of government had frequently changed, first <u>Theseus</u>, and later <u>Dracon</u>, <u>Solon</u>, <u>Cleisthenes</u>, and many others ; and last of all, when the State lay bloodless and prostrate, that learned man of <u>Phalerum</u>, <u>Demetrius</u>, revived it again. On the other hand our own commonwealth was based upon the genius, not of one man, but of many, it was founded, not in one generation, but in a long period of several centuries and many ages of men For, said he, there never has lived a man possessed of so great genius that nothing could escape him, nor could the combined powers of all the men living at one time possibly make all necessary provisions for the future without the aid of actual experience and the test of time .

For the result of these methods must be that not only the tyrant's rule will be more honorable and more enviable because he will rule nobler subjects and not men that have been humiliated, and will not be continually hated and feared, but also that his rule will endure longer, and moreover that he himself in his personal character will be nobly disposed towards virtue, or at all events half-virtuous, and not base but only half-base. Nevertheless oligarchy and tyranny1 are less lasting than any of the constitutional governments. For the longest-lived was the tyranny at Sicyon, that of the sons2 of Orthagoras and of Orthagoras himself, and this lasted a hundred years.3 The cause of this was that they treated their subjects moderately and in many matters were subservient to the laws, and Cleisthenes because he was a warlike man was not easily despised, and in most things they **kept the lead of the people by looking after their interests**. At all events it is said that Cleisthenes placed a wreath on the judge who awarded the victory away from him, and some say that the statue [20] of a seated figure in the market-place is a statue of the man who gave this judgement.

" In 1694 the first state lottery (known as the 'Million Lottery') was instituted, and formed the pattern on which a further 42 such lotteries up to 1768 were held. Managers, or Directors, were appointed by letters patent to produce books of numbered tickets, mostly costing £10, but in some lotteries costing 1 guinea, £3, £5 or £100, which were delivered to Treasury appointed Receivers. These Receivers sold tickets, delivering one part to the buyer, and returning the rest, signed by the buyer, to the Managers with an account for the money received. The Managers detached a second part of the ticket, rolled it up and locked it in a box while the third part remained as a counterfoil. In a second box was locked another set of tickets, numbering the same as those in the first box, which were previously divided into blanks and prizes. The draw was carried out by drawing tickets successively from the first and second boxes and pairing them off, holders of tickets from the first box drawn immediately before a prize or 'fortunate' ticket from the second box being allotted the appropriate prize. In the £10 and £100 ticket lotteries, all purchasers were guaranteed some return, either as a prize or as an annuity, although not the full return of their original stake. Fortunate ticket holders received annuities or prizes in addition. In the lotteries for which tickets cost less than £10, purchasers were not guaranteed any return, and only fortunate ticket holders won annuities. The Managers printed lists of the winning ticket numbers and the holders' names, and transferred the original lists to the Exchequer. The holders exchanged their own ticket for

orders for payment on the Bank of England. This first lottery in 1694, for which 100,000 £10 tickets were offered, led to the establishment by its subscribers of the Million Bank.
