

The Greeks had their philosophers (-800 BCE) but the Vedas around northern Pakistan, Afghanistan (-3000 BCE) morphed into many ideas Brahman, Bon, Janism, Hinduism, Zoaroastianism, Buddhism). The Chinese had ideas Confucius, Tao (-500 BCE).

The **idea of wisdom** had been held in esteem for some time in many places. The pig-ignorant Greeks tyrants who sentenced Socrates to death for asking questions and **teaching the youth to ask** 

questions - had no idea of wisdom. The pig-ignorant tyrant bully boy soldier who killed Archimedes as he was working on a problem - had no idea of wisdom - he just wanted to assert himself- his authority - his ability to kill people - like any "good" barbarian and tribal binary certain type we see around us now.

Between the East and the West is a place called the middle east - it may also be called the middle west - in the middle between the extremes. Yuan Chuang seemed to have a didactic memory, educated, was a physically impressive human and robust enough to survive long journeys on horseback and foot through some of the toughest areas on the planet. This was not a "stroll in the park". Not everyone would have the constitution strong enough to take on this journey - but the people he met along the way understood, valued and appreciated those who did. Hundreds of named Chinese journeymen died on the road to wisdom - many more unnamed journeymen died on that journey and because of the journey.

His **knowledge was tested** everywhere he went - the wisest in the community would come and meet to talk and discuss ideas and the written words. Wisdom was recognized - as was the need to keep learning - because there was an idea of "higher" knowledge. This idea of a "higher learning" was an idea of the middle (not the east or the west) but seemed to be embraced strongly by "the east".

His ability to discuss and debate was tested everywhere he went. The idea of discussion and debate was valued - especially as the **new visitor** to the area may have ideas and stories to help you and your tribe on your search for wisdom and the new visitor was also keen to learn from you and observe your world - a shared learning experience. Much of this was based on learning how to question things.

Perhaps more than one preface would be necessary for this book; and after all it might still be doubtful whether any one could be brought nearer to the experiences in it by means of prefaces, without having himself experienced something similar. It seems to be written in the language of the thawing-wind: there is wantonness, restlessness, contradiction and April-weather in it; so that one is as constantly reminded of the proximity of winter as of the victory over it: the victory which is coming, which must come, which has perhaps already come.... Gratitude continually flows forth, as if the most unexpected thing had happened, the gratitude of a convalescent—for convalescence was this most unexpected thing. "Joyful Wisdom": that implies the Saturnalia of a spirit which has patiently withstood a long, frightful pressure—patiently, strenuously, impassionately, without submitting, but without hope—and which is now suddenly o'erpowered with hope, the hope of health, the intoxication of convalescence. What wonder that much that is unreasonable and foolish thereby comes to light: much wanton tenderness expended even on problems which have a prickly hide, and are not therefore fit to be fondled and allured. The whole book is really nothing but a revel after long privation and impotence: the frolicking of returning energy, of newly awakened belief in a to-morrow and after-to-morrow; of sudden sentience and prescience of a future, of near adventures, of seas open once more, and aims once more permitted and believed in. And what was now all behind me! This track of desert, exhaustion, unbelief, and frigidity in the midst of youth, this advent of grey hairs at the wrong time, this tyranny of pain, surpassed, however, by the tyranny of pride which repudiated the consequences of pain—and consequences are comforts,—this radical isolation, as defence against the contempt of mankind become morbidly clairvoyant, this restriction upon principle to all that is bitter, sharp, and painful in knowledge, as prescribed by the disgust which had gradually resulted from imprudent spiritual diet and pampering—it is called Romanticism,—oh, who could realise all those feelings of mine! He, however, who could do so would certainly forgive me everything, and more than a little folly, boisterousness and "Joyful Wisdom"—for example, the handful of songs which are given along with the book on this occasion,—songs in which a poet makes merry over all poets in a way not easily pardoned.—Alas, it is not only on the poets and their fine

"lyrical sentiments" that this reconvalescent must vent his malignity: who knows what kind of victim he seeks, what kind of monster of material for parody will allure him ere long? Incipit tragædia, it is said at the conclusion of this seriously frivolous book; let people be on their guard! Something or other extraordinarily bad and wicked announces itself: incipit parodia, there is no doubt....

## **Mary Wollstonecraft**

I had briefly examined Mary some years ago but dismissed her because the feminists had claimed her as a feminist. A bit like how some others have demonized individuals as "Nazis". It is difficult to categorize people after their life - to dismiss them and define them using our conceptual frame and words from our time. It is better the read their work and see what you can learn for yourself from it.

The child had some tenderness of heart; but so accustomed was she to see every thing give way to her humour, that she imagined the world was only made for her. If any of her playfellows had toys, that struck her capricious, sickly fancy, she would cry for them; and substitutes were in vain offered to quiet her, she must have the identical ones, or fly into the most violent passion. When she was an infant, if she fell down, her nurse made her beat the floor. She continued the practice afterwards, and when she was angry would kick the chairs and tables, or any senseless piece of furniture, if they came in her way. I have seen her throw her cap into the fire, because some of her acquaintance had a prettier."

Not only under the lash of my task-mistress, but the drudge of the maid, apprentices and children, I never had a taste of human kindness to soften the rigour of perpetual labour. I had been introduced as an object of abhorrence into the family; as a creature of whom my step-mother, though she had been kind enough to let me live in the house with her own child, could make nothing. I was described as a wretch, whose nose must be kept to the grinding stone—and it was held there with an iron grasp. It seemed indeed the privilege of their superior nature to kick me about, like the dog or cat. If I were attentive, I was called fawning, if refractory, an obstinate mule, and like a mule I received their censure on my loaded back. Often has my mistress, for some instance of forgetfulness, thrown me from one side of the kitchen to the other, knocked my head against the wall, spit in my face, with various refinements on barbarity that I forbear to enumerate, though they were all acted over again by the servant, with additional insults, to which the appellation of bastard, was commonly added, with taunts or sneers. But I will not attempt to give you an adequate idea of my situation, lest you, who probably have never been drenched with the dregs of human misery, should think I exaggerate."

## The Passive Aggressive Binary Switch Technique



Questions arise in life and while we know that Death is "Bad", everything else (infinities) is avoidance of death rather more correctly described as "**Not Certain Bad**". Inside the box are all the individuals who might have different ideas and answers to "My Opinion".


That is the first binary switch technique - to swap **NOT** of **Certain Bad** (Death) with a new concept we invented called "The answer" - which starts out as only "Good" but then becomes "**Certain Good**" (in a god-like way) in the same way that Death is Certain Bad. **Binary certainty Bad/Good**.

This is done to avoid the infinity of things which are not "Certain bad" - the ingrained habit avoiding infinity and not knowing where your infinities are until it becomes an unnoticed binary habit. (The way we do things around here)

The first major delusions are that there is such a thing as certainty and there is such a thing as Certain Good. No case for absolute certainty can be proved - certain truth - certain - wrong, etc. This


leads to a collapse in some human minds - to nihilism. Hence the idea of Hypothesize and Belief/Faith. I hypothesize there is some certainty. I believe some things are certain. It is not a fact that some things are certain. It is a fact that some people believe in certain things. (me now)

**My opinion** then becomes **grouped with others** in a mob like popularity way and alternatives are removed - there is now only Certain Good, My Opinion (the Mob - The Tribe) and the Other individuals. This is called **Popularism** - if your Opinion is declared "Popular" then mobs form around that opinion as a "Certain Good" idea. This is based around the idea of "A little bit of knowledge and learning can be dangerous" - you might think you know something and rather than testing it with the scientific method - you test it with how popular it is - how many people think like you do.



Pythagoras was popular and developed a cult around himself and pretended to know things, a Popular cult, pontificating on everything, fooling people with magic tricks, etc - until he and his followers were hounded out by people sick of his lies and pretense. Many people claim this Popularism technique - even scientists say they are "Popular" - everyone agrees with me and my opinions therefore my Mob/Tribe are "Right" and "Good". So rather than say "I have an idea, it seems to work, I may be wrong" or test your hypothesis for falsifiability you declare it as certain "Good". The other part of this is the Corruption model - where the individual has overcome some of the corruptions (Ignorance, Fear, capability) but then fails at hypocrisy - which is a threat to their sunk cost investment in "their opinion" and then comes the adoption of a popular mob like good/bad model of Virtue Signaling to the Mob to be popular. This later morphs into total Self interest (extreme narcissist) and Bad Acting.



These techniques of grouping your opinions with others is part of the **grouping things** of same/different and is the basis and habitual binary sorting technique for form hierarchical schemas - the binary tree of thinking. In "Topics" Aristotle call grouping things *Genus* or *Classification* - we make links with *property* or *attribute* (e.g. white tree) and the *definition* is the thing defined (*recursive* - which he fails to understand). Aristotle fails to see or highlight the link between *Universal* and *Particular* (as a continuum rather than binary) - which in my models is the plurality curve between **group** and **individual** - **although he mentions plurality several times**. Aristotle also makes a distinction between *properties/attributes* and *accident*. This is a continuum of **relevance** - where he also fails to grasp the continuum - .i.e. they are two extremes of a binary comparison *attributes/accident*. The Apple was upside down, red, liked, smelly, cut in pieces, etc. Different

properties are more *accidental* than *essential* in its *definition*. In the middle somewhere like a plurality curve. For example the <u>amount of light emitted</u> by an apple is conceptually relevant to an apple - but makes very little difference to its definition - yet for a star - it is an *essential attribute* rather than an *accidental attribute*.

I imagine Aristotle would have observed the sophists lecturing about things and describing things associated with many irrelevancies - in a humorous, provocative or even ignorant way. *The black coal was sweet to the taste and invoked a wild imagination in me*. Whereas *black coal burns and produces heat* - seems more "essential" and have less "accidental" properties. None of my criticism or evaluation of his work makes it any less important and useful. We all should have something to argue against - even if it is only our parents.

This is part of the Sunk Cost bias and the Confirmation Bias because Humans are generally Fat, Dumb and Lazy. The mental effort to process your idea was a significant cost and as you get older you are less likely to modify or develop your ideas. Children are much better at letting go Bad ideas - they learn their lessons. Lately though, in our society, schools are encouraging children to not learn anything themselves but to be told what "Certain Good" is - in a *Didactic* way - and be indoctrinated to do only "Certain Good". Historically there are many examples but an early example of this may be the ancient Greek teachings of Sparta (the permanent soldier of Good) compared with the teachings of Athens and the Plato's Apology. This Certain Good teaching is the basis for Marxism, Communist

China many dim-wit tribal countries (binary) and totalitarian regimes. The draconian dogma of "Certain Good". No longer will only be "Popular" but also mandated as "Popular" - "You will enjoy our dogmatic definition of Certain Good - take the knee".

The next major step of the binaries is to use the standard grouping habit and avoidance of infinities habit to make everyone and everything a defined certain group - binary certain. They hate infinities, uncertainties and complexity.

Individuals are removed and every individual is allocated to a Group/tribe by the binary tribal types - you belong to "that tribe". This has been observed and described as groupthink, mobthink and many similar terms by many thinkers over the years. 

Certain Good gets dogmatically bounded and constrained by the Popular Mob in the same way that "My opinion" was dogmatically bounded and constrained by Mob popularity - the Tribe - Tribalism. So the **individual has been removed** and everything is tightly bounded, constrained and dogmatically defined in a Draconian way by corrupt lawyer types and other "My opinion" types.



The "Others" become simply a **multiple group of tribes** as defined by the tyrant psychopath **"Diverse"** overlapping tribes. This they will call certain "Diversity" - diversity of tribes/mobs/groups/identity. The next step for the binaries - having established a binary framework of Good/Bad and Groups/Tribes - is they then frame everyone and everything into this model. Everythinjg is declared - by them - to be Good or Bad in very simplistic fat, dumb, lazy groupthink kind of ways. The main point to note at this stage is that you are **ALWAYS BEING FRAMED BY THE BINARY EXTREMIST. They always use group terms. The individual disappears unless singled out for personal attack. Like a pack of hunters will single out animals from a herd for the kill.** 


That is all that goes on in their head. **You are the declared perpetrator** if you do not support their declarations of certain good or certain bad. You are *"either with us or against us"* says the binary mob - i.e. with us (the tribe) in our declarations of certain Good or with us in our declarations of certain Bad.

- We all want to be "Good" don't' we?????
- We all don't' want to be "Bad" Don't we?????

Let that sink into your brain - 70% of the population of world habitually adopt this framing strategy.

We know that mobs/tribes/binaries can be aggressive - we see that in politicians, ABC feminists, board, management and staff, Magistrates in Canberra courts, bullies, tyrants and psychopaths everywhere. As idiots and undeveloped humans - their weak schemas represent a SUNK COST of effort that they are desperate to maintain and they will kill anyone who threatens their dim beliefs or their power and corruption. They never escaped the cave or developed any understanding of the world. It is not that they are "simple" people it is they are tribal/violent people. Barbarian tribes dominated humanity for thousands of years - large walls and barriers (Gorgon Wall, Hadrian's Wall, Great Wall of China, etc) were built to try to keep them from destroying civilization.

You can see the general models of grouping and the **destruction of the individual** but I find it interesting to observe out of the binary positioning pattern the **re-emergence of the "Special Individual"** out of the grouping technique - The **tyrannical narcissistic binary extremist** themselves, of course - but then they anoint others (and themselves) to be **special** - part time heroes - and the full on declared individual victim - "Welcome to the big stage everybody - put your hands together and applaud - the **Declared Victim** - Hooray" . Individuals to "look up to", "heroes of the State" and individuals to "feel sorry for". See *social justice warriors*.



What we see here is the primitive form of the **binary switch technique** between **individuals and groups**. Individuals are selected by the tyrannical psychopath binary extremists to be declared as certain victims or certain heroes under the binary framing technique of Good/Bad. They generally select themselves first **as qualified to declare** who are Good and who are Bad individuals. We saw this with the Australia Day awards - not awarded for service but for "Good/Bad" tribal identity. This


is common throughout history but **David Anderson** as editor of the ABC - has directed his staff not to interview "Bad people" and only interview "Good people" - this is his stated and published editorial policy for all ABC staff. Politicians do this with their own constituents - rather than meet with everyone they represent they only meet with people who agree with them and support them. Andrew Leigh and Andrew Barr **refuse to discuss anything or meet with me** and the women politicians only work for women - they do not meet or discuss issues which are not about women or designed to help women tribes. Same for Black politicians and other "identity" types etc. That's why we have taxpayer funded Black TV and Radio channels for example - full on tribal all the time.

So Good people are declared as those who are "Special Victims" or "Special Heroes". That is the editorial policy of the media, politicians universities - etc - this is the standard Good/Bad overlay on the group/Individual selection policy - designated Heroes or designated Victims. So in David Anderson's model it is Good to be either a victim or a hero but the others (perpetrators) or generally "Bad" or as one ABC employee said to me when I repeatedly wrote to them "We don't know who you are" - i.e. they had not classified me as either a Good or Bad individual and I was already excluded for being a white male based on group identity and therefore I am not one of the specially selected individuals.


The other thing to note with the ABC and David Anderson is they also use the GROUP IDENTITY - tribal/mob - frame as well - so if you do not belong to the "Good" groups then you are cancelled and called "bad groups". So the deluded tyrannical binary extremist applies both individual and group framing techniques for Good/Bad. So being classified as a "White male" you do not belong to the correct tribes and are considered the "perpetrator" and "Bad" in a group sense. We see the reaction to this by weak minded-men in particular - the sycophants and sentient pet types - who rather than assert their individuality and lack of dogmatic group identity - become pawns and sentient pets (woof, woof, oink, oink) of the tyrants and extreme tribal binary extremist mobs. They do whatever the Tyrant tells them to do. E.g. "I am a white male so I must take the knee"

You will note that the vast majority of people - even though stuck in level 2-3 thinking - generally do not claim to be either be in "Special groups" or "Special individuals" - or if they do - they keep it at a family and community services level - not at the national or international level - these binary extremist groupthink types tend to become the narcissistic tyrannical deluded dogmatic psychopaths ostentatiously in charge of things while the general population tends to get on with their own lives in the community. Vain-glorious "virtue" (Good) signalers.



So - do you see the binary overlay of Good/Bad extremes? all the time on groups? and individuals? and the mob idea that if you are an individual and disagree with the binary then they attack you as a perpetrator?

This **binary switch technique** is used by level 2 thinkers all of the time - they simply cannot regularly operate at level 3 thinking. They are **binary extremists**.



They never openly (it is hidden away in their dark cave) realize the idea of infinity of opposites to things declared (what is the opposite of Apple?) and they tend to switch between extremes. Hence my Focus model - level 2 thinkers see the model to know it exists but they switch backwards and forwards between extremes.

Level 3 thinkers see the focus model (see Corruption – Extremists <a href="https://humanistman.com/wp-content/uploads/2020/01/Corruption-Extremists-Feedback.pdf">https://humanistman.com/wp-content/uploads/2020/01/Corruption-Extremists-Feedback.pdf</a>), understand it, try to eliminate their biases, recognize the infinity- continuum idea and recognize the exploration required rather than the binary certainty. Another sign of level 3 thinking is the ability to become less certain about the binary Good/Bad overlay. Continuums are accepted and explored.

The next stage after the tribal violence and tribal aggression is the **passive aggressive game**. This is a pretense that they are engaged in a discussion somehow and are not tribal. The reality is that their techniques have changed but they are still fully binary and tribal. Their delusion is that they think they have "developed" beyond binary thinking and the Good/Bad overlay by not killing you outright in a primitive tribal way.

Let us examine the Penny Wong, Tanya Plibersek, Dan Andrews, ABC, the Project, Russian and Chinese dictators. Passive aggressive techniques - demonizing.

Most smug Melbourne types think they live in the best city on the planet and are the best people in the world. This is not only ignorance - it is **arrogance** and **smug superior attitude** they cultivate and re-enforce amongst themselves. See China, Russia, etc. Many tribes do this. In the individual it is

appalling behaviour but when whole groups do it - society starts to break down. The ABC and The Project TV shows full of "commentators" - for example - regularly abuse, parody, chortle, sneer, laugh, and belittle individuals in a constantly abusive and **sadistic judgmental** way - calling out the mobs/tribes - always making fun of others and portraying themselves as morally or intellectually superior. Greens/Labour politicians and their supporters do this all the time.

The ABC, Project, Greens/Labour, Feminists, Women (on average - quotas, targets, permanent victim narrative) and many organizations - declare their pig-ignorance by judging "others" as "inferior" to them. Not only on Morals, Intelligence, Life Experience, Travel, Success, etc - but any measure they care to name - by any and every measure they see themselves as superior. This is a **Delusion** and tribal and mostly based on a **deep sense of insecurity and fear** of being found out for their own failings (a **binary avoidance technique**). They declare themselves "Certain Good" in every measure or **if not on every** measure then - "on average" - on average they are better than the "others" - binary certain **relatively "better"** - "Greater Good". *At least I am better than you are.* The corollary of "a race to the bottom" (relativism) "At least I am no worse than Hitler"

The passive aggressive uses the binary switching games to align themselves with the notion of Victim/Hero - they are both the victim of those who question them - so they are an individual victim belonging to the group of "all victims" and then you are the perpetrator as an individual or a group if you question the binary certain declaration of "Victimness". They are heroes for the cause of "victims". This is Greens/Labour, women (on average - quotas, targets, etc), Dan Andrews, Mathew Keen, etc. "How dare you insult the victims - take the knee"

This **declared binary certain victim state** allows extreme violence under the notion of "Passive Aggressive" i.e. they cut your head off while declaring to the Mob/Tribes that the "Victim and Victims" have finally rid the world of certain evil and binary certain perpetrators. Evil has been vanquished by the heroic victim. "I was simply defending myself against certain evil" Then you see that smug face that Penny Wong, Chris Bowen, Green activists use to display how proud they are of "overcoming" evil by abusing people, destroying things, verbally attacking, refusing services, cancelling and being violent. Many women operate in this constant manipulative abusive sadistic state as the "common scold" of the declared victim/hero. We also see it in many "hero" activists type organizations. This has been legislated and mandated for women as "entitled Homicide" when they kill their husbands saying "I was the real victim of killing him - he forced me to kill him" - in an insane feminist way.

The current Minister for Home affairs - a rabid man-hating feminist - Claire O'Neil is an example. She does not mind being called a rabid feminist - she is proud of her feminism and working for all women's causes and ignoring anything to do with men. She is **vehement and committed to her cause** of feminism and will demean and attack anyone who gets in her way. Many women think like this and use their positions to constantly re-enforce this message and act on their tribal biases.

She loves being tribal and binary certain in her thinking. She sees herself as a hero for "Victims" (women) - this is publically declared by her and many others like her every day in every way in all organizations, courts, universities, schools, parliaments, media, politicians etc. "isn't about time we had a black, jewish, female, trans, gay, etc High Court Judge - see how good we are?"

Medibank data was hacked. We no longer have anyone with any skills because Women, Blacks and other identity types (see Google and James Damore

https://en.wikipedia.org/wiki/Google%27s\_Ideological\_Echo\_Chamber ) have been promoted into positions rather than selecting people on merit with skills. Like "Quotas" for political parties, universities, Airline Pilots (isn't about time we had more black, jewish, female, trans pilots?), courts, Boards, management, science, etc.

So when questioned about what she is going to do, Claire then aligns herself with the victims and how much she cares for the victims - and that she herself is part of the culture of victims - then HEROICALLY attacks the individuals and those who question her actions and choices in dealing with the issue as the responsible minister and demonizes them - demonize those who question.

"Don't upset the apple cart" "Don't tell the emperor they have no clothes"

So now the person who questions her is declared as bad as the Data hackers themselves because they refuse to claim her as a hero and fails to do what she says for the "victims"- in a binary certain drama groupthink kind of abusive passive aggressive way. I have written directly to her over the years - but she - like the rest of man hating binary feminists in Greens/Labour refuse to engage or respond. They double down on their binary certainty and victim/hero abusive demonization games.

"How dare you question me when so many victims are suffering - you Cad - don't you have any decency!!".

"With Respect" - says Richard Marles (passive aggressive) "now is not the time to talk about how the Greens/Labour culture bullied a politician to death"

"I think people have moved on from wanting to know how corrupt I am - it is only Hubris" (John Howard)

"Women are the greatest victims of everything - with respect - we should be concentrating on them - why do you hate women so much Jon? - why don't you care for victims? - What are you, a perpetrator? - you are hiding your own evil Jon otherwise you would support our cause" (feminists and weak minded men)

"Take the knee, boy, and promise that you will not hurt women - take the knee"

"60% women in the public service - up from 40% based on constant bias and corruption and "positive" discrimination is NOT ENOUGH - there is still more work to be done - HOW DARE YOU!"

"You may hate women and blacks - Jon, you bigot, racist, incel and misogynist - but we love discriminating for women and blacks over white men. It is very popular. If the mob attacks you then you deserve it - you are probably a criminal even if we cannot prove it or it is an outright lie. You are still evil in our eyes.". Andrew Leigh (to me in public), Andrew Barr, Magistrate Robert Cook and rest of the Canberra courts, Universities, Schools, Politicians, ABC, Commonwealth government (office of women, voice, money for blacks, etc), Feminists, Blacks, Women (on average - bigots, bias, quotas, targets, wages, houses, victim narratives), weak minded men (heroes, virtue signalers), dimwits, smuglifunts and other binary extremists cogitatively challenged humans.

"But what about the children," (the permanent victims) - "what will the children do if you put their mothers in jail for the crimes they committed - after all - beheading people for binary zealot religious causes wasn't a crime - Hitler did it - it was his fault - we were only the train drivers, the mothers, the fathers who went along (oops)" - let other family members look after them - the ones who did not behead people - their fathers perhaps? - the ones who are not binary zealots, beheaders and murderers? WHAT - A NEW STOLEN GENERATION!!! Fathers stealing their children???

"But a mother's love and care is **sacred** you cannot deny a mother their children can you? - I gave birth to that child - do you have any idea how difficult that is - how could you - you are a man" - Family courts, etc

"But we feed and nurture children, we have breasts - how can deny how great our skill is in raising children - you hater - you bigot" - women (mothers) on average - quotas, victims, wages, etc

"But I am black - how could you know what you and your tribe have done to me and my tribe ...."

"But I am holy and full of morality - how could know anything about what I have been through...."

"But don't you know" (bottom lip quivering) "how much I have been through" (tears starting to well-up) "How difficult it is for me" (the other women gathering around adoringly) "How all of us feel" (the mob cries - tears outrage and tantrums everywhere - in unison - like how women menstruate together in cycles) "how could you" (the perpetrator) "allow this to happen to me" - any women caught out lying, cheating, stealing, committing crimes, working at the ABC as biased bigots, as feminists for the "cause" everywhere, making false allegations in domestic violence - family violence - criminal cases and the media, manipulating weak-minded men and gathering the mobs. Always remember who the declared victim is.

Take the knee, turn off your brain, submit to my authority.

Now I will emphasize the technique used by Dan Andrews, ABC, feminists, Green/Labour types - the binary zealots demonization technique. Watch the binary switches taking place between Group/ Individual and Good/Bad

- 1. You must realize that any question is a full-on frontal attack on their smug certainty their zombie dream state hence the violence and abuse.
- 2. Your question becomes "Grouped" instead of it being a question of an "individual" you become grouped into "far right extremists" You are **immediately de-humanized** from being in an **individual** to being a group. "*People like you might not like women but we love discrimination for women*" (Andrew Leigh and other tribal fuckwits)
- 3. They might declare they are "Good" people or they belong to right tribe on the "right side of history" (this step is optional)
- 4. They themselves then become an Individual a **special individual** under attack by **your group** your group is attacking them because of the "question" you dared to ask. How dare your tribe attack me little innocent me all by myself being attacked by a whole tribe **I am the victim here** of you and **your tribal attacks**. How unfair for me as a single **individual** like me to be under attack from a **whole tribe** of haters and abusers.
- 5. They then invoke the individual victim and **call out the Mob of other tribal types** to protect the victim themselves from personal attack from the "Bad" tribe (chortle, sneer, abuse,

- mock, attack, stick the boot in, etc) come one everyone **signal your virtue** signal your goodness by protecting me the victim.
- 6. Then rather than attack the group as tribal warfare between two tribes (Us, the good guys) and "far right extremists" that **they grouped** you into "white man", "racists", "hater", "Binary", etc they choose to **attack you personally as an individual** while simultaneously accusing you of tribalism and groupthink.

Individual to individual, Individual to group attack (the question), Group (of good tribe) attacked by Group (of bad tribe), Individual (of good tribe) attacked by Group (of bad tribe), all individuals (from Good Tribe) DEFENDS against Individual (from Bad tribe) by killing them.

**The passive aggressive binary approach.** You get framed from individual to group of Bad people back to individual perpetrator for the Wolf pack to attack. They de-humanize you while claiming **entitled victim** status.

You will notice that I have described the Marxists, Feminist, Socialist, Communist, etc general technique.

# Complacency - Self Hypnosis - Dream State - Zombie Brain - Delusion - Psychopathy - I Share My Dreams

When you see Richard Marles, Penny Wong, Mark Butler, Mark Dreyfuss, Tony Burke, Andrew Leigh, Andrew Barr, Tanya Plibersek and the other Greens/Labour type in public display and in parliament - you will see them operating in a kind of dream state. They are dozy and dreamy and smugly, laugh, chortle, cheer and abuse - like a mob in a half-awake/half asleep kind of way. A kind of walking dead/zombie state that Delores O'Riordon (an exceptional human) <a href="https://en.wikipedia.org/wiki/Dolores">https://en.wikipedia.org/wiki/Dolores</a> O%27Riordan sung so well about in "Zombies".

**They resort to their lowest level of operation** in a Fat, Dumb, Lazy kind of complacent way. This is slightly different but similar to the **full on attackers and abusers** - the narcissistic psychopaths, manipulators and schemers at the ABC, Guardian, Office of Women, "Human" rights, Universities, Greens/Labour, Canberra courts (Robert Cook, Edwards, Walker and the feminists) - who are **fully switched on** and **focused on** torture, abuse attack and demeaning people in a **sadistic**, psychopathy (like feminists and women who make false accusations - for example).

This **dream and delusion state** you can see the psychopathic murderers, soldiers with guns, leaders with too much power, ABC board and management, United Nations, the wealthy State employees and grafters (the oligarchy), Women (on average - quotas, victims, "believe all women and their dream state and delusions") etc. The instinctive lazy heroic reaction the habitual "Hero" abusing others - the habitual "victim". The **habitual deluded role-play** instead of engaging with reality and life.

Little children (2-3 year olds) develop these **imagination and play-time** skills very early and these skills are useful when constructing abstract schemas, planning and anticipating choices rather than having to physically test every option. But you see the problem don't you? If you actually do not make choices and do difficult things then your play-time imagination get re-enforced into some kind of **compelling delusion**. You are less connected with the world and reality. You are **not interacting** 

with people and things around you in a "real" and "truthful" way. You are not getting any reality feedback.

We see this in women influencers who excessively sculpture their visions of themselves - using photo filters, technology, medicine, etc - no awareness of the world and obsessed about self - the complete narcissist in a dream state. Their "lived experience". A revolutionary invoking statement like "let them eat cake" delivered to starving people is not a statement of malevolence - it is a statement of emptiness of self-absorption, of delusions and detachment from any type of reality.

You see it in their eyes - this **complete absence of humanity** - the silly girl greeny protestors blocking roads and glueing themselves to things - a zombie mind state - an emptiness - a lack of humanity, a lack of awareness of anything else but themselves and their dream state. Banal.

Now - I do not know about you - but when you are in your most sleepy state - when you are having your deepest dreams - you feel happy and relaxed (I know I do - some people enjoy self-hypnosis and chanting themselves into a dream state) - mostly as **a feedback mechanism from your body** and brain while the lower level functions explore and do repairs on parts of your body - especially the brain - a tidy up processing time which allows you to **eventually WAKE UP** and **NOTICE the NEW WORLD WHICH AWAITS YOU**. Some people even eventually come out of comas.

So humans are wired to enjoy the Dream State - to appreciate the warm comfort on the zombie brain and delusions. It helps us repair and take a break from the constant anxiety of life (especially for women).

So when you find someone **stuck in this habitual dream state** - it is **very difficult to penetrate their delusions** - especially when they are fat, dumb and lazy - and do not have to do much to sustain themselves or their family. They react violently and adopt an angry state. They are spoiled and do not have to work too hard or take on too many problems. They become totally self-possessed. People who are a constant stressed and anxious state are the opposite - they are only too keen to **learn about reality and truth** to help them make better decisions. **Their lives depend upon it.** 

The Americans know about torture techniques as do the Russians and many others. Keeping someone in a cell where they cannot sleep and then when they do finally fall asleep then **waking them up the instant they do - is a form of torture**. This is why Richard Marles, Penny Wong, Tanya Plibersek - the greens/Labour, ABC board management and staff, Feminists, women (on average - quotas, targets, wages), and weak minded "virtue signaling" men - stuck in this habitual and comfortable "dream state" become so violent , angry and abusive - like children who need their sleep - and they see you as a "torturer" of their "happy dreams" ( it does not even need to be utopia - it is just "Their dreams" - what they themselves are dreaming about).


wants to go to explore a "popular" holiday destination?) - rouse the thinkers and historians - check the idea - scrutinize it - see if it stands up to reality.

Marriage is an idea that we have when young and then reality hits along the way as you grow and learn. The intimate discussions and communication with your partner help you manage your dreams and reality in a truthful way. You get better at it the more your practice. You become less deluded.

## **Privacy**

In Australian we have a **Privacy Act**. As George Orwell predicted it has become a weapon for **removing the citizen's privacy** for the 'Greater Good' as declared by the state - the elite politicians and the grifting legal class scum. So rather than help ensure privacy for the individual - the legislation mandates exactly - in dogmatic legal draconian detail - how individual's privacy is removed.

This is the general problem that dim-wits in politics fail to grasp - they tend to mandate everything in legal detail rather than knowing when to NOT legislate things. The tyrant always wants to judge everyone and everything in a totalitarian draconian way. In Khan's tents you could not touch the line on the doorway - you have to step over it otherwise it was a great insult and punishable.

In Totalitarian and Tyrannical states - the police and state enter your house whenever they like - i.e. they act like legal criminals. ## **Digital Identity**

The replacement of hard copy documents - like drivers licenses, passports, permits, birth certificates with things called "digital identity" owned and control by computers and networks systems (soon to be DNA signature and Microchips for dogs and cats - now humans)

"Computer said you don't exist" Prove yourself. Migrants, criminals, fake news, information bots, trolling bots, etc.

Individual humans cease to exist except as their "digital record" further de-personalization of human contact between individuals. Everyone becomes a tyrant for the authoritarian state. The Matrix.

Vaccine Mandate Passports - insane - actual insanity by so-called scientists and health officials - right up there with sacrificing chickens to appease the Gods or Sacrificing your first born child to the volcano. The delusion that vaccines **stop you from getting infected** and hence the spread of infections in communities. Insane. Deeply and widely held pig-ignorance and delusion and unrelated to reality, history or measurements in any way.

To put this idea of vaccines into more context - great news was made when a politician asked if the Vaccine company had tested its vaccine for reduction of transmission in groups. I **classify the question as stupid** because it is obvious that it is not the purpose of a vaccine. The Vaccine may protect **individuals** from infection effects and outcomes (on average - with side effects) - not groups. i.e. it is not the purpose of vaccines to protect groups nor is it possible in any realistic way based on the complexity of life - to protect whole groups from viruses. It is a very **popular delusion** to think so. Health Officials and so-called scientists repeat this delusion around the world.

This morphs into a draconian mandated insanity that we have see in recent years (and still continuing) - the idea that whole groups can be "kept safe" from life itself if only you can be draconian and authoritarian enough. Binaries struggle with complexity and uncertainty and delude themselves that the world is binary - it is the only frame they have.

Stupid humans have always bought into this idea. **Snake oil** salesmen would travel the small towns selling the **miracle cures** for life itself.

- Will rubbing that oil into my bald head make my hair grow back Yes sir!
- Will it help my chickens lay eggs Yes sir!
- Will it help my lumbago? no doubt!
- Will it improve my marriage? you will need to buy two for that
- Will it keep me safe? that's what I am selling everything to ease your anxiety
- Why is your snake oil better that sacrificing chickens to the Gods? Well this is a scientific product based on years of research and trusted, I have a white coat, it is the most popular product, it is new and improved, the ABC has endorsed and promoted it as "truth"

Credit card companies Google, Facebook, service providers, retail, banks, insurance companies, governments - all seek to "know their customer" in invasive detail - use your data, profit from your information and deny your privacy and ignore the idea of treating you as an "individual" - instead you are treated as an "Average" - a statistic in some grand delusional utopian dogmatic scheme - and abstract group term like "Perpetrator" or "Questioner" (someone who questions) which women (on average) so like to use.

So they can treat you as a group - "white men" for advertising or as credit agencies do - classify each individual's reputation and trustworthiness based on data, average, data matching, technology and all of the mistakes and errors that brings - guilty until proven innocent in a kind of mob/groupthink/tribal abusive data matching digital identity totalitarian way.

## **State Controlled Corruption**

If your own corruption body does not investigate you then by default you are not corrupt and therefore free to act as corruptly as you like. As simple as ABC. Corruption is now legislated, controlled and mandated by local, state and commonwealth governments like "Human Rights" "Truth" "Voice" "Speech" "offense" (18C) in an insane Orwellian way.

This single example of a **double NOT** of **Not for self and Not for others** is a **deliberate level of vagueness** - deliberately designed to allow most level 2 thinkers to start to explore the level 3 thinking. i.e. I think it **should allow at least 90% of the population** to understand and explore - even women (on average)

Evil comes from a failure to think. It defies thought for as soon as thought tries to engage itself with evil and examine the premises and principles from which it originates, it is frustrated because it finds nothing there. That is the banality of evil." — Hannah Arendt, Eichmann in Jerusalem: A Report on the Banality of Evil

They only people more insane than Anthony Albanese, Chris Bowen, Penny Wong, Tanya Plibersek, Mark Dreyfuss and the rest of the Greens/Labour types are those who believe anything they do or say - delivered in that faux gravitas, pontification, smug, self important, performance, stylized, delusional, psychopathic, MANDATED, BINARY EXTREMIST, tribal and virtue signaling way - "Oh Look - See how we have SOLVED Corruption? "Corruption is under state control"

No individual needs to be alarmed when the state (on average) runs things.

Many years ago schools, universities and communities used to have "citizenship" awards - children and young people who were not necessarily the most talented, sporty, good looking or educated but represented a way of behaving in a way that was recognized and seen to be supportive of the community in general way without virtue signaling. Some are killed in their own embassies, chopped in little pieces and carried out in suitcases - ordered by celebrity powerful elites and Human Rights and other award winners. The ABC - for example - expects to get human rights and journalism awards for lying and propaganda that it produces every day as it defames people, manufactures false narratives and propaganda, divides Australia by tribalism, demonizes groups and individuals - e.g. "far right extremists", "White men" and does everything it can to undermine and corrupt the role of the justice system. No corruption Commissioner will ever "investigate" the ABC - because it is all in plain sight - every day across the country. The way we do things around here - how can that be corrupt?



Much of the media resorts to tribalism and personal attack - especially as the level of education drops - e.g. blacks and women are made "professors" based on their identity and tribe - not skills - merely pretending to black or a woman is enough to get into the right "tribes" so you attack and demean "others" in a binary certain way.


The ABC is fully and obviously biased and corrupt yet no-one will do anything about it. The same with many mainstream media companies in USA. David Anderson is Corrupt and runs the ABC corruptly because he thinks it is a vehicle for his 'Good" ideas - the "right" people - the "Good" people - not the baddies. This is the same for the court system, human rights, politics, "Office of Women", "Voice for Blacks", charities , etc - the "right" kind of people get support and services - "others" are demonized and attacked. No matter what state agency gets setup - it gets corrupted and taken over by deluded narcissistic binary zealot self-absorbed psychopaths like David Anderson, Helen Watchirs, magistrates, Feminists and other corruptions.

## **Austrac - Data Matching**

There are many government agencies with data collection and data matching as their main focus to target individuals and look for criminals. This is one technique of keeping crime under control in large societies. An extension of this idea is to stop all crimes before they start - i.e. be able to detect potential criminals before they commit a crime using expensive technology, propaganda, mind control, data collection and data matching - in a kind of full on totalitarian, authoritarian **treat everyone as potential criminals** kind of way.



This has been displayed in narratives in books, plays and movies - many about historical regimes - but also about hypothetical and possible future worlds - Where hypervigilant authoritarian states implement large police forces to demonize and attack individuals as potential criminals - "keeping us safe". This is Andrew Barr's domestic violence laws of immediate criminal guilt (orders made by a court official) assigned to men **based on any allegation by any woman** - even if the man is out of the country and unaware of any allegation. This is also how the ABC operates and is the general mindset of women (on average - victims, quotas, targets, wages, etc) and weak-minded men. This mindset of operating in society where **people are treated as potential criminals** is **very corrosive** of the **idea of trust** - which is the basis for fair dealing, trade and most our day to day dealings with each other in society.



While people who "look different" or are the "outsider" in behaviour might be treated with suspicion - usually the human technique of killing all "outsiders" is not a very successful evolutionary technique for survivability of a species - for example. Generally the human idea - even for very primitive societies - is to allow each individual to build respect and trust from others and in themselves - by doing things which are part of the community - for example. Like working, making things, helping others in the community - being productive in some way.


So a person is not judged by how "Good" they are as a person - but what they do as an Individual in the community. Not everyone can "do" things - some struggle and need help. This is the basis of the victim narrative. There is a tendency for some to look down of individuals and judge them - to be judgmental about them - without understanding the individual circumstances and complexities - this is called a "Rush to Judgement" - usually by smug smart-arse binary types playing moral posturing and relative comparison games based on their need for Declaring the delusional "Good" - their "Virtue". To some extent - the fact that the community is made up of individuals doing things at all - is something to be appreciated and understood and then discussion can be had about the jobs that the community needs done.

So humans generally adopt a communication and cooperating approach to developing mutual trust. Like building things and helping develop the nation. Things like the "raising a barn" in a small community helps build a sense of community and trust. Building bridges - making paths and roads - investing in schools, libraries, shared town squares, parks, etc.

Humans prefer to operate in a community based on Trust, with individuals being responsible and accountable.

For example things like defensive walls, or shared public meeting houses and locations go back in history many thousands of years. The idea of a school is a big idea - a school for learning in a dialectic way rather than a propaganda machine in a didactic rhetorical sophist kind of way. This requires some understanding the idea of education a process. It is worthwhile to examine Aristotle's (a student and learner of Plato and Socrates) writings - as he helped establish some early famous schools and libraries - to get some ideas around thinking and learning about things.

So rather than treat everyone as potential criminals - explore the possibilities of everything else that is **Not Bad**.



It is not an easy thing to help people learn because the tendency is to give in to dogmatic certainty "the way we do things around here".

So we end up **somewhere in the middle** again where we try not to frame everything as "Certain Bad" - even though we know death is Bad. "Thalt shall not..." (do Bad things as designated by the tyrant at the time)

We also try not to frame everything as "Certain good" - "Be Good and Virtuous". Both extremes are delusions and end up producing psychopaths, liars and bad actors (communists, fascists, socialists, politicians, feminists, legal types, draconian types, etc) - the binary certain extremists.

Both **Nietzsche** and **Wollstonecraft** were observers of humanity who witnessed death and widespread ignorance in their times. Both tried to revive a sense of humanity in different ways - Mary mainly by reason and sense, Fred tried many methods but with Zarathustra he tried to open human minds to wonder, interest and journey. Poets, artists and the troubadours of southern France mocking the binary extreme zealot elites in some of the dark times of the middle ages - also tried to show things to humans other than death. Logic, science, art, law, education, medicine, etc - so many different things shown by so many outstanding humans to be interesting and worthwhile investigations. Standing up to zealots and binary extremists has a long history and those who do a remembered long after the tyrant their decedents have faded to the nothingness where they arose.

So the problem for learners is being able to give some kind of ideas for the student to grab on to. A selection. This is usually by example - we show them - "the way we do things around here" but only for small things at a time - small steps to build confidence and enquiry. Reading, Writing, Numbers, Talking, doing things. We usually do this learning with a group or societal framework of choices - the tasks which need to be done - farming, sheep herder, builder, fisherman, boat builder, roads, bridges, food, water, schools, books, plays, art, medicine, science, etc.

So we help develop the dialectic- enquiry, learning and improvement abilities - of our students and encourage this in an ongoing way.

**And** there are other ideas of reducing crime as well - usually done in a mix or a balance between extremes based on a situation basis rather than dogmatic certainty. A kind of "Human toolset" which can be used at different times depending on the circumstances - requiring some thought, learning, debate and discussion.

So while the idea of "keeping us safe from criminals" (and other barbarian hoards) has some kind of societal cost "defensive walls", "trained army" (see the history and archeology of the world from 12,000 BC onwards) - there is also some aspirational stance above "not death". See **Dan Dennet's** work in particular **Intentional Stance** https://en.wikipedia.org/wiki/Intentional stance

So while it might be a good idea to have some skills in Data Matching - there is tendency for any part of society - in a tribal sense - to want to dominate or take over other parts of society. So the tendency for AUSTRAC is to become ever more AUSTRACY. Like **itself on a feedback mechanism**. This leads to creeping totalitarianism data collection and data matching like the **know your customer** legislation based on keeping us all "safe" from terrorists and criminals by giving up all privacy.

### The ends justifies the means?

If you examine team dynamics and team management models you can see the **attempts to recognize everyone's practical strengths** while not allowing one set of "expertise" to dominate or **demonizing those who do not have your skills** <a href="https://www.teammanagementsystems.com/tms-profiles/team-management-profile-tmp/">https://www.teammanagementsystems.com/tms-profiles/team-management-profile-tmp/</a>

This works with things like meetings with accountants, lawyers, doctors, politicians, law enforcement, health, business, community, etc groups and allowing any one group to dominate the debate. Another issue is the **partial satisfying technique** (on average - average changes) - giving **everyone a little of what they want** - a kind of **creeping idiocy** - making "everyone a little happy and everyone a little sad".

Sometimes things need to be disbanded entirely or reduced - to change. For example all politicians seem reluctant to get rid of the Office of Women or the Human Rights agency (they believe they are full of virtue and "goodness") - despite the fact that they are fully biased, tribal, corrupt, expensive, incompetent and a waste of time and money. More than that - they give false sense of security because they actually **do not deal with the main issues** at all - they become a smug autocratic totalitarian tribe operating within their own tribal mindset. Outsourcing thinking itself to a government agency who habitually ignores you and **demonizes you** for questioning. **George Orwell** and **Hebert Spencer** wrote in detail about these kinds of problems. Many others have written about this as well - Sometimes the topics are Management theory, Sociology, Political "Science", Bureaucracy, Teamwork, Economics.

"The business of any writer, and especially of the philosopher, is, as they say, to discover, utter, and diffuse truth and adequate conceptions. In actual practice this business usually consists in warming up and distributing on all sides the **same old cabbage**. Perhaps the result of this operation may be to fashion and arouse the feelings; though even this small merit may be regarded as superfluous, for "they have Moses and the prophets: let them hear them." Indeed, we have great cause to be amazed at the pretentious tone of those who take this view. They seem to suppose that up till now the dissemination of truth throughout the world has been feeble. They think that the warmed-up cabbage contains new truths, especially to be laid to heart at the present time. And yet we see that what is on one side announced as true, is driven out and swept away by the same kind of worn-out truth. Out of this hurly-burly of opinions, that which is neither new nor old, but permanent, cannot be rescued and preserved except by science" ..." But a further difficulty lies in the fact that man thinks, and seeks freedom and a basis for conduct in thought. The inner voice must necessarily collide or agree with them. **Man cannot be limited to what is presented to him, but maintains that he has the standard of right within himself.** He may be subject to the necessity and force of external authority, but not in the same way as he is to the necessity of nature; for always **his inner being says to him** how a thing **ought** to be, and **within himself he finds the confirmation or lack of confirmation of what is generally accepted**."

"The words "God giveth truth to his chosen in sleep" have been applied to science; hence every sleeper has numbered himself amongst the chosen. ## **Data Matching Technology**

DSS, Teradata, Netezza, Austrac, ATO, SAS, computers, analysts - ethics sensible timely natural justice - elapsed time - the legal of concept of too much time has passed to accurately determine anything.

Technology advances and exceeds the capacity of the human brain to make appropriate and balanced use of it. The Rock (of certainty) becomes the tool for everything in the way the hammer becomes the dogmatically certain binary tool for everything until you break so many things AND you realize that there might be a better way - the question you ask yourself.

### **Statute of Limitations**

This is part of the problem of the binary extremists using the All or Nothing binary switch depending on if it is themselves or someone else they are dealing with - Hypocrisy and corruption by those binaries in power. Pushing boundaries and testing constraints are what children are supposed/aught to do.



This is a widespread delusion.** The main thing keeping anyone safe is their ability to engage with other individuals on a human level - some might call this "society" or "community" - where individuals routinely engage in communication, cooperation, trust, see justice being done and see some sense of "sustainability". The thing about this general model is that it **recognizes the Human Condition** - that people make mistakes but they can rejoin the community if they re-establish and continue trusted individual interactions - we can all potentially become **rehabilitated to humanity**.

The idea that anyone "should/aught" understand legislation has gone now - replaced by you need to pay someone lots of money (lawyers and other scumbags) to tell you what the legislation means. The grafters, grafters and non-producers of society - a bit like the "temple" caste and other elites who want to control everyone else's lives and get paid enormous amounts of money to do so.

Most organizations I have dealt with lack the staff numbers or capability to understand very much at all about anything and this gets worse as more legislation is passed and grows in complexity. This is to be expected when feminist lawyers and other dim-wits are the tribal zealot types (Zali Steggle/Greens) drafting the legislation in the first place. **How would a binary know what makes "good legislation"?** 



In other words the tyrannical abuser and psychopath is rewarded and encouraged. We see this in people like Penny Wong, Tanya Plibersek, Tony Burke, Mark Butler, Andrew Leigh, Andrew Barr, Canberra courts, Melbourne courts public service and Police - most the Greens/Labour types - not only the feminists binary zealots - but also the weak minded men and criminals seeking to further their own advantage at the expense of the people they swear to serve.



At one end is the bare minimum rules and regulations enabling society to survive and prosper. I am currently dealing with the corrupt and incompetent ACT Magistrates court and their staff - 4 years is long time with no help from Ombudsman, review boards, any of my elected representatives or interest by the media. This is not unusual or unexpected - no white man gets support in this tribal feminist dominated binary zealot society we are currently in. Principles are gone - **humanity is not even a memory of an idea.** 

I am also dealing with some clubs in the area who I belong to who refuse to let me see their constitution (it is not publicly available) and abuse and ignore me for daring to ask. 


#### The Mass Delusion of Certain Good

Another binary switch technique is between the **All or Nothing** type of approach. Aristotle calls it the "Whole or Part", "in a certain respect or absolutely", "Particular/Universal" kind of idea and alludes to a lack of understanding of plurality. If a person makes a mistake in their life then **they are Bad**. If you make a mistake in life - you **did a Bad thing** - then all is forgiven and things move on. This is the Human condition - we all do bad things and we are **grateful** and **appreciate** to be able to learn from our own - but also other people's - mistakes - doing bad things. If we **survive** doing a Bad thing then we learn. If we observe Bad things from others and learn then we **appreciate more** about Bad things. We can discuss and learn with others around us. Doing Bad things - as humans do from time to time (no matter how we choose to define "Bad") - does not make you permanently a "Bad Person" - despite what the binaries say - despite the constant blame and guilt trips by the Mobs - despite the propaganda by the ABC, Schools, Universities and other permanent victim narratives - despite the hate and tribal divisive campaigns of the narcissists and binary extremists - despite the feminists, (women on average - quotas, targets, permanent victim narrative) the blacks and virtue signalers and other binary extremists.



We learn and get less Bad and more not Bad. See Meta Frame 10. Binaries struggle with this model and use the binary switch technique between Group terms and the Individual. For example - the individual's whole life - past, present and future is judged as binary certain Bad based on one choice or action depending of the judgement of the Binary Extremist/Mob. This technique was explored after world war 2 when Hanna Arendt examined the Nuremberg trials of the behaviour of individuals who performed some of the most atrocious acts in human history - as bad as the Khans, Christians (crusades), Japanese (Nanking), Muslims (everywhere) and other binary tribal zealot types throughout history. Hanna coined the term "the banality of evil" - which itself caused a mob uproar around the world. The unitary and binary thinkers (level 1 ("the mob united will never be defeated"), 2 thinkers ("are you with us or against us?Yes/No?" "Are you on the "right" side of history?") - mobs, tribes, extremists, women (on average - quotas, targets, wages, victim), etc) - were outraged that there was not a binary certain answer to where this "evil" was and that the idea that evil (Badness) was everywhere in everyone really upset those people who constantly deluded themselves - in a binary certain way that they were "Good" and "Not Bad" (simultaneously). The deluded binary extremist narcissists. They think at level 2 and fail to understand the Not, Not infinities or the ideas of the 4 box model (level 3 thinking) - or as Aristotle observed in On Sophistical Refutations "because men lack the power to keep their eyes at once upon what is the same and what is different." http://classics.mit.edu/Aristotle/sophist\_refut.1.1.html



The "others" are generally seen as the perpetrators/"potential criminals" or the "outsider" to the tribe and are framed by the binaries in to certain good/ certain bad or certain hero/ certain victim depending on how the binary tyrant feels at the time.


Much of Aristotle's work of sophistry is about the ignorance of the basics of the frame of information and logic - you can assert something and then linking that with other information like certain opposites and groups is **not understood as a technique**. "The right way, then, is either to divide apparent proofs and refutations as above, or else to refer them all to ignorance of what 'refutation' is, and make that our starting-point: for it is possible to analyse all the aforesaid modes of fallacy into breaches of the definition of a refutation."

In this case the "Certain Good" opposes the "Certain bad" idea which is the "devil", "evil" and "evil" choices and actions. So the technique of finding a single fault with someone you want to attack is aligned with the Ad-Hominem attacks we see in binary types everywhere - especially in politics and the media where places like the ABC spend most of their time on political campaigns for "Certain Good" by "poisoning the well" and digging up the 'dirt' either for blackmail of for public mob vigilante actions by the rest of the binaries. Feminists, Communists, Fascists and other extremists do this.

A big Delusion is that they are themselves "Certain Good" - "Certain Heroes" - and that the ends justifies the means. (Lord Acton) People like Anthony Albanese says things like "Whatever it takes" - as an extreme statement - meaning destroying anyone who dares to question their insanity and delusion that they are "Certain Good" and "Certain Heroes"

'And we must remember that [Hitler and Mussolini's] faithful followers, among them the diligent executors of inhuman orders, were not born torturers, were not (with a few exceptions) monsters: they were ordinary men. So we see the binaries hiding their corruptions under the guise of self or popularly **asserted** *Virtue* and *Moral superiority* and *Greater Good*. So to use some of Aristotle's conceptual frames - Some of my absolutely asserted premises are:


- 1. I declare (ego, subject) there is such a thing as a thing (not-ego, object initial self reference, recursion declared is thing declared)
- 2. This is such a thing a thing as same thing and different thing (Difference Comparison)
- 3. There is such a thing as thing and Not thing (Not)
- 4. There is such a thing as infinity (repeated process not,not, 1+, etc)
- 5. There is such a thing as definition and measurement used together

Where Aristotle explains the idea of "a certain respect" or "like" or "partially" - "similar" - we are starting to look at the continuum between two things opposing each other usually postulated as binary opposites. "Those that depend upon whether something is said in a certain respect only or said absolutely, are clear cases of ignoratio elenchi because the affirmation and the denial are not concerned with the same point. For of 'white in a certain respect' the negation is 'not white in a certain respect', while of 'white absolutely' it is 'not white, absolutely'. If, then, a man treats the admission that a thing is 'white in a certain respect' as though it were said to be white absolutely, he does not effect a refutation, but merely appears to do so owing to ignorance of what refutation is."

White in a certain respect
(somewhere in the middle)

White Not White

NOT White in a certain respect
(They think it is a new idea – a different point)



While I take Aristotle's point regarding "certain respect" and the tendency of binaries thinking they have "refuted" something by operating at binary extreme levels - I think I would have emphasized that the binaries were failing to see a continuum and that terms like "like", "similar", "a bit", "some way", "in part" are there to help explore the continuum between the absolute certain binary extremes.

Notice: The comparison process is different to the declaration process. The declaration process - This is an apple - these are the infinite nots of apple - is a plurality curve of measurement and definition.

To declare something and to define something - you have abstracted a definition of apple out from an infinity of things in your universe to declare it as an apple . This is a major process.

The **comparison process** compares two things on a continuum - usually looking like a gaussain comparison still using the meta frame of measurement and definition. The comparison process does not use the idea of NOT its uses the idea of *somewhere in the middle then* - somewhere *closer or further away* - somewhere where **other continuums might be brought into the discussion** to talk about as well.


Aristotle calls these things *attributes* rather than *absolutely asserted premises* (the declaration - the *is*). This difference is emphasized by Aristotle in many places.

- There is **such a thing as white** is **declared** and it's not is explored on the plurality curve as a definition and measurement of White.
- The **whiteness** (as declared) *attribute* of a THING is explored on the Guassian curve.


This recognition of these two different processes is something many people have trouble with in conversation and debates. Usually people skip the first step of establishing the declaration sufficiently and proceed straight to comparisons. Advanced thinkers can recognize the two processes simultaneously and adjust the schemas of definition and comparison during the same discussion.

Aristotle tries to explain the difference and help people focus on each separate issue to improve communication and shared understanding. You will note that there is still a tendency for binaries to operate at the extremes on the comparison curve as well - definitely white/definitely not white - as a comparison technique which avoids the comparison continuum and makes binary statements. Draco , dogma, legal scumbags, etc.

Imagine the concept "Big" as declared. People habitually skip straight to relative comparisons rather than explore definition and Big no longer has a definition on it's own - it is always an absolutely undefined attribute of a thing and more things compared on a continuum. Relativism.




**To explain a bit more** about this comparison technique - I can show you the number line **can be** put on the Definition X axis as a series of Defined things and Nots. 1 is NOT 2 and 2 is not 3 and 3 is not 4,etc



Another thing to highlight is that the simple processes of definition serve as a general model for many things. You will remember that when we talk about **definition** and **measurement** that we talk about both things at the same time - how something is **defined** and how it is **measured**. This is what we declare. This is the **basic duality**. So the definition of the concept of unity, the number 1 - is about as binary as you can get - this is 1 - this is Not 1. Then the addition process + and so on. **Measurement** immediately confronts us with **Precision** and **Accuracy** - which for units - again is a simple and binary as it gets - but for the continuum of the number line we are dealing with the infinities of measurement, *infinitesimals* - the continuum of measurement.

So the binaries are stuck in binary thinking and declare that there is such a thing (absolutely asserted premise - Aristotle) as "Certain Good" (their other main delusion). This is a historically difficult idea that humans have struggled with - especially the dim-wits, binary extremists, communists, religious zealots, women (On average - quotas, targets, permanent victims) and weak minded men. They cannot talk about definition and measurement so they become tyrants of certain good.


Humans have an idea of certain Bad - and that idea is under constant discussion - for example killing people you disagree with or do not understand does not seem to be (based on history) a good survival mechanism. Yet cooperating, communicating through the ideas of Bad and Not seems to be a better approach.



The other issue here which emerges is the idea of some kind reality - some balanced "Truth" which moves beyond 4 boxes and binary thinking into exploring the continuum through dialogue and debate. There is utility (John Stuart Mill) in hypothesizing (Socratic dialogues) about Truth even if the binaries are not up to it and want to shut down debate.

The idea of overcoming delusions - waking up - seeing the world as it is - noticing - observing - exploring. This could be an important "aught" (David Hume, Immanuel Kant).

# **Public Virtue Signaling - The Messiah Complex**



The opposite of individual privacy is the grand public display. The need for the crowd of adoring fans. The eyes glaze over - reality disappears to be replaced by a fog of delusion. The sublimation of the ego to a deluded super-ego - the spoiled brat, the celebrity, the indulged, the unfettered child. The "Good" - Gods of certain "Good"

Reality had by-passed their development - a lack of awareness of the human condition. Ultimate goodness manifested in themselves. Mary Wollstonecraft saw it in the women and men around her. Chris Bowen, world leaders - doing "great good" in a shared mass delusion and greed and corruption lifestyle.

I see it is a delusion and failure to see the world in some balanced (brain hemispherically) way. We agree on that - that brains have different emphasis and sometimes are damaged - his message is important - yet we differ because I am less "fatalistic" - in a "certain destiny" kind of way. Destiny and fate has far more to find from investigation from the maths, physics, science side - quantum

level and astronomical - and hence a general abstraction of the idea of "individual destiny" is tied into many more complex things. Fate, Chance, probability, uncertainty, choice, etc.

We are in a tyranny now - it is too late - the mobs control everything and the banal go along with it.

The **Opposite of Humility,** appreciation and gratitude. It may be **Schizophrenia** and disportionality based on **excessive dogmatic certainty** and lack of integration (via a focus model - for example - comprehensive - cohesive) by an **over-active left brain** of **immediate narcissism** (*anger*, *self-righteous*, *disgust and denial*).

#### Individuals are quiet, silent and asleep to what is happening. WAKE-UP ZOMBIES!


**Intuition and Imagination are dead!** Call me Nietzsche if you like.

I understand everything Iain is saying and why he is saying it. Few of you will be able to get even close to having any idea of what he is talking about. Some of you will pretend like sophists - some of you will demonize like tribal feminists. Most of you will ignore and fail to understand the meaning of it.


### Binary Switch Mob Brain - Destroying the Individual From Within

It has taken me some time to be able to focus on and explain how this works so you can understand. To do this I have had to explore many things and talk to many people and asses their reactions and responses while using my schemas and ideas. I watch others and read many things.

We see Andrew Leigh and Andrew Barr, Anthony Albanese, etc switch to that "Mob Voice" that I have previously described - they gather an imaginary "mob" around them when they speak and become aggressive, smug or morally superior. They gather an imaginary "force" around them - a constant supportive delusion - a warlike tribe ready to attack.




I have noticed this as I have spoken to some of the clubs around Canberra about privacy and my data being kept on their systems. Many Individuals - particularly the pumped up managers - the ones with the most expensive suits and haircuts - the ones with who carry a large ego around and inflict it on others - they seem to be the most abusive and aggressive - they seem to me to be at least as psychopathic as Magistrate Brewster and Magistrate Cook - a kind of pumped-up abusive posturing like we see in Penny Wong, Tanya Plibersek, Andrew Leigh, Andrew Barr, Anthony Albanese, Mark Dreyfuss, Mark Butler, Chris Bowen and all the Greens/Labour women, ABC board management and Staff and Women in the media and universities generally (on average).



The Non-Tribal human is more authentically aware of themselves and their surroundings and are on a journey. The Smug tribal type tends to bullying and tribal mob attacks on anyone who threatens their certainty. **No question.** 

Maybe deep insecurity and dysfunction - anxiety and fear - a failure to embrace being an individual and being responsible and accountable for their own personal behaviour without the protection of "the mob". A failure to "launch" - babied and Mothered too much - a Nanny state - spoiled brats - complacent - Fat, Dumb and Lazy. Or maybe the most ignorant and mentally dysfunctional - yet these are the types who **generally seek help** not double down on their smug certainty. Who needs an **individual Telos** when the mob looks after everything? *Mummy can't I just keep playing the drama triangle - I love it so much - Yes, my Boy, stay my little hero for the rest of your life.* **Keep me** "safe" - Until I decide to accuse you of "coercive control" and kill you.



So to **become an individual** means letting go of that child-like dream and delusion state - the happy face disappears to replaced by a more realistic and comprehensive view of the world which is integrated with self and reality. The smug safe cocoon of childhood falls away as one starts on the journey towards being something else - maybe an individual?

Carl Jung's *Individuation* idea can help with this - Scott Jeffrey helps explore - <a href="https://scottjeffrey.com/individuation-process/">https://scottjeffrey.com/individuation-process/</a> - becoming an individual in a non-binary sense - is not about "destiny" as such but is a form of development where multiple schemas are successfully incorporated into the ego - including overcoming the binary Good/Bad binary certainty. Yet the idea of "destiny" may help people as a starting idea for their journey.

You notice that the **individual me** seems to **have more to deal with** (the universe and self) than the **tribal me** (dealing with real or imaginary tribe). The individual Me seems to be able to step out of themselves and explore the universe and see towards themselves at the same time - a kind of awareness of the world around them and an awareness of the frames they are in.

You see that **Smug tribalness** in Penny Wong, Tanya Plibersek and the mean girls, Greens/Labour types - they all **smile and nod at each other** (Chris Bowen smiles at himself as he speaks imagining how happy he and the rest of the tribe is - like Kamala Harris, like Penny Wong, Like Anthony

Albanese, etc ) and reinforce tribal feedback mechanisms of personal attacks on others and smug tribal rewards and supports for themselves.

I am not sure what "humanity" is but I am certain it is something other than absolutely "tribal". (me, now)

Women/Blacks and other tribal identity types seem to always expect the "mob" to be on their side as a group and they recruit weak-minded men (heroes and virtue signalers) to join their tribe - that is to say - women (on average) cannot seem to escape mob think to become an individual. Few seem to be able to **NOT be tribal** - and hence are constantly biased and corrupt in any job in society they are in. And they puff up and stroke men who behave in the same tribal way and attack those who don't.

Jordan Peterson's **self authoring idea** might help people and maybe he is thinking around the same ideas as I am. I cannot tell because we don't discuss things I can only go by what he writes and says. When he is constantly asked about why men and boys seem attracted to his ideas - the point that seems to be missed is that women are attracted too. (Why not ask if Jews, Chinese and Muslims and all the other tribal classifications - if you are going to use binary terms?) But another thing to notice is that fewer women (on average) tend to **want to think** about these things. This is the really sad thing - that females - especially young girls - seem to really struggle with learning anything or taking responsibility and accountability for themselves and prefer tribal, abusive manipulation rather than authentic education and discovery. Scientists have to be "mandated" as quotas for women, Grants of money for scientific ideas have to be "mandated" for women/blacks/gays/trans/etc regardless how good their ideas are so they can **delude themselves that they are scientists** - and they believe this delusion -

#### They believe:

"there is merit in mandated groupthink and tribalness." The word merit no longer means anything other than Tribalness.

Mary noticed this - as others have done throughout history. Maybe women (on average - quotas, targets) struggle more than men to reach individual maturity as a human and tend to (on average) stay stuck in a narcissistic deluded psychopathy of toxic man-hating victims and "common scold" we see throughout history. I suggest that Germain Greer was hoping that women would choose to become authentic human individuals rather than stuck in toxic tribal groupthinking abuse.

When I went to the local club to ask about privacy - as I have done for many weeks now - they refuse to meet or say that they will not meet. A kind of **permanent limbo** - neither refuse to talk or actually agree to talk. Instead I have to go back and keep asking. Now they bait me and get girls and little boys to say absurd thing to try to get a reaction - try to get me to become angry abusive so they can declare themselves the victim of my questions. The manager comes up to say he does not know - and things like *why don't you take up gardening or golf* - a kind of personal and constantly personally demeaning avoidance of dealing authentically with the question.

When I see the little girls start to adopt the victim language "I am trying to help you" I immediately say "You are not the victim here" and ask to see the manager so there are other witnesses. So three of them then explain how helpful they are by all not answering any questions or arranging a meeting or not arranging a meeting with the privacy officer. They all say now that the application form for membership - when you apply to become a member - that you must abide by the "Australian Constitution" and therefore refuse to give me a copy of the "Club's constitution". The little girl said "it's obvious isn't it?" This type of insanity occurs at other clubs at well where I ask to see the constitution or have tried to seek to have a discussion about privacy by following their own contact and discussion procedures that they proudly display. A Public delusion and blatant lie - a pretence - a statement of engagement - we care and are listening - we want to assist our members, etc. "I have listened, I have answered, you have already met, the issue has been resolved, nothing to see here, why are you attacking us? etc"

So every time I go in they have a new plan of personal attack and avoidance.

**YET, there is hope**. At several clubs I ask the same questions there are these young men lower managers - who do not immediately attack. These young men who listen - think and engage with the ideas - while not necessarily jumping to an aggressive or defensive stance. They do not necessarily solve the issue and many of them do not have authority to decide or Act - but at least they engage rather than demonize and attack.

Teaching women and blacks how to be tribal entitled victims. Fostering resentment and entitlement in primary school onwards and binary thinking - gender, blah.

Bjorn Lomborg, and many others, demonstrate that humans are generally living in the safest, best time on earth in history, Stephen Pinker before him - also did the same kind of analysis and reached similar conclusions. We have never been safer and more secure yet the hysteria from women and other tribal types and role players in the drama triangle - seems to be constant and unchanging. The constant demand for attention as the permanent entitled victim is never ending from women (on average). For Henny Penny <a href="https://en.wikipedia.org/wiki/Henny Penny">https://en.wikipedia.org/wiki/Henny Penny</a> everything is a catastrophe and an urgent crises - regardless of reality or facts. Narcissism psychopathy and attention seeking victim narrative dominates the drama triangle binary tribal types regardless of the reality of the world. A kind of permanently deluded state of mind which no reality can penetrate. The grafters and grafters (lawyer scum, politicians, ABC, etc) feed into this system

Causual demonization and tribal thinking - indoctrination and propaganda - repeating the narrative and slogans. Most women in the media repeat the narratives and propaganda given to them - especially as it ties in with the natural narcissism and victim idiotology. They repeat word salads and simple notions which demonize men and boys every day in every way without thinking. The habitual propaganda is more safe and smug than thinking.

Cooing and stroking the hero man - Scott Morrison, Anthony Albanese, magistrate Robert Cook, Deputy registrar Edwards, magistrate Brewster - all the feminists lawyers barristers and legal staff are always in full-on attack and biased mode against men. Lorriane Walker and the rest of the feminists in the Canberra legal system, Melbourne, high court, family court and other courts around Australia.

### Forgiveness and Gratitude - the Human Condition

My partner gave me some ideas. Australia is virtue signaling a "Voice" for blacks as part of the historical tribal victim narrative - a racial based group to divide the nation. This idea could spread world wide. We know Fiji, New Zealand and America are fully tribal in their constitution and government - why not other countries as well? Britain could create a "voice" for british people and immigrants and other non-racial british could pay reparations for their invasions - especially those of Roman decent and the Vikings - the reparations could all be based on racial lines designed and legislated by a "racial equality and reparations" group run out of the United Nations headed by Chris Bowen (world leader of tribal "justice"). The same for Jews and Palestinians, Egyptians could have a separate voice for "Egyptians" and "others". The Mongols could assert their tribal specialness and the Han Chinese could be subservient and pay reparations. Is the current Chinese "dear leader" a Mongol - is he racially entitled to be the "Dear Leader"?

So rather than being grateful and appreciating your life you could be in a constantly legislated mindset of grievance, hate and racial division. Forgiving the human condition in general to work on "better" things. Maybe to do something other than wallowing in entitled grievance.

### Why do you think it is a Good idea?

This must be one of the most difficult questions of all time. It invites the Fat, Dumb and Lazy human to think and thus expend energy. It asks them to collect their thoughts and ideas and mount some kind of argument and possibly engage in a debate. They might be proved wrong but they might learn something as well. Why do you think it as a **God** idea or an idea of **God**.

The tendency I have observed is that hardly any human answers this question at any stage during their own lifetime - not even in their own mind. They avoid it, double down and attack anyone who poses this question. Throughout history and written records I have explored - there are pockets in time and space where a few individual humans can do this but for much of time and for much of humanity it is not only absent but any re-emergence of debate is jumped on by violent and pigignorant mobs. (fascists, communists, Marxists, socialists, ABC, Feminists, binaries, zealots, Senate, Women (on average - quotas, victims, etc).

The Canberra courts will not respond to me. ABC will not answer this question. No politician will answer this question. 5 years of trying and nobody will answer the question.

It does not matter what words come after those 9 words.

"To be a bigot", "To be corrupt", "To give more money to women than men", "To kill people", "To lock people up", "To demonize people", "To steal", "To lie", "To abuse other humans", "To remove the presumption of innocence", "To be tribal", "To ban all meat", "To run propaganda campaigns", "To misuse public money", "to declare an emergency", "To eliminate all carbon", etc.

But even the Barbarian tribal chiefs were prepared to have some kind of discussion - so there is some kind of human who is worse than a barbarian horde. Those who cannot discuss anything - they kill and attack the question and the messenger.

A quick look a Jordon Peterson's recent youtube clip - "God Exists", Meaning, Service, Divine, 'Good", **The Question**, "No Good" equals belief, Death of "Divine" https://www.youtube.com/watch?v=iozl992R OQ

A point where Jordan Peterson and I disagree is positing things he values in the idea of "God" - certain good - a good idea. I posit the good idea - independently of the certainty he is searching for. Then the idea is to discuss the idea - not "where" the idea came from. This is an idea of "the west".

#### **Socrates - The Art of the Question**

I realize now what Plato was showing about Socrates - he was explaining the art of Socrates but there is a lot more going on.

Socrates had reached the point where he realized that the best way to deal with the widespread ignorance and behaviours he was observing around him was to engage people personally with questions. So when he says *I know little - and I know that I know very little -* he is awake and aware of his own lack of knowledge and he observes many around him who seem to lack this awareness. This is a powerful and repeated message.

This level of awareness and being comfortable with ignorance but still keen to learn is a type of continuing curiosity in the world - rather than a smug complacency and a shutting down of questions.

So then the question becomes - why was Socrates asking questions and helping the youth to ask questions? Why was he *curious*?

- Was he trying to embarrass people with "gotcha" type questions to attack them and belittle
- Was he trying to show clever he was?
- Was he trying to learn from others?
- Was he trying to demonstrate and teach people how to ask questions?
- Was he trying to show that asking questions helps people learn?
- Was he setting an example because that he thinks that is all we can do in the end?
- Was he denying that the god of certainty (binary) exists by asking questions?
- Was it "worse" to ask questions of the Certain "Good"
- Was he authentic or an evil manipulator of others?


"I came across a man who has spent a **world of money on the Sophists**, Callias, the son of Hipponicus, and knowing that he had sons, I asked him: "Callias," I said, "if your two sons were foals or calves, there would be no difficulty in finding some one to put over them; we should hire a trainer of horses, or a farmer probably, who would improve and perfect them in their own proper virtue and

excellence; but as they are human beings, whom are you thinking of placing over them? Is there any one who understands human and political virtue? You must have thought about the matter, for you have sons; is there any one?" "There is," he said. "Who is he?" said I; "and of what country? and what does he charge?" "Evenus the Parian," he replied; "he is the man, and his charge is five minæ." Happy is Evenus, I said to myself, if he really has this wisdom, and teaches at such a moderate charge. Had I the same, I should have been very proud and conceited; but the truth is that I have no knowledge of the kind."

I have taken my Chinese traveler, **Xuanzang**, around my Maps to verify places, roads and dates but most of the books talk about his observations about Buddhism. He learned from others everywhere he went - he stayed and studied all over India - where people where studying and learning so that he could learn. Once he had passed their tests he moved on to the next places to learn more. China was in famine and turmoil and things seemed wrong to him so he set out with some serious intent on a long a difficult journey through dangerous and deadly places to places of wisdom so he could learn.

In a place in Kamurapa, Bangaldesh - he too calls himself ignorant - *modest learning* - yet he has given his life to find knowledge.

# **Sophistry**

You are too stupid to know how stupid you are.

The idea of language is not the same as the language of ideas. (me, Now)

Aristotle might call me a sophist - which I think he is using the word in a demeaning way. People who pretend to know what they are talking about and teach others without having any real idea of the problems with their logic, reasoning, ideas, etc - a kind of pretended "wisdom" - the "learned idiot" - a shutting down of questions and a failure to understand. This is not the authentic Fool who does not pretend to be an expert. See Zen and the Art of Golf <a href="https://humanistman.com/wp-content/uploads/2021/07/Zen-and-the-Art-of-Golf.pdf">https://humanistman.com/wp-content/uploads/2021/07/Zen-and-the-Art-of-Golf.pdf</a> nor is it the real expert who realizes he understands very little after all.

These "sophists" were the teachers around at his time - so he obviously had time to examine and explore all the mistakes and pontifications. I need to examine his ideas and check them against mine. His contemporaries included: **Xenophon**, Archytas, **Plato**, Cyrus the Younger, Demosthenes, Menaechmus, Ptolemy I Soter, Seleucus I Nicator, **Alexander the Great**, Pytheas of Massalia - but also the Sophists and other intellectuals who flourished 150 years before Aristotle's time Anaxagoras, Sophocles, Zeno of Elea, Pericles, **Protagoras**, Herodotus, **Gorgias**, Euripides, Artaxerxes I, **Socrates**, Thucydides, Democritus, Hypocrates, Aristophanes.

Aristotle had a lot of writing to be able to study and fellow thinkers to discuss things with in Athens. See the **Lyceum** <a href="https://en.wikipedia.org/wiki/Lyceum">https://en.wikipedia.org/wiki/Lyceum</a> (classical) (Lat, Long) 37.97489, 23.74328

Aristotle is writing in a way that many of you will have no idea about. Firstly he has witnessed enough of discussions and debates to understand how people do things, he has participated in those discussions and explored many ways to help improve them, he is fully aware of how much he knows and does not know compared to those around him, he takes on a responsibility to write down his ideas and explain them to others, he provides multiple layers of abstractions and classification schemas to explore the idea, he provides examples from his time to illustrate the ideas, he provides narratives along with the classifications to help clarify his ideas.

These techniques may well have been second nature to Aristotle but they serve as an example to others to explore as a **meta frame** of **communication of ideas**. With Prior Analytics and Posterior Analytics he has taken on the complexity of humanity - seeking to abstract and communicate his schemas as best he can. He worked on this over his life to try to make it coherent and comprehensive. This was not the work of a teenage brat ejaculating immature outrage, tantrums and smug idiotic certainty.

"Now for some people it is better worth while to **seem to be wise**, than to be wise without seeming to be (for the art of the sophist is the semblance of wisdom without the reality, and the sophist is one who makes money from an apparent but unreal wisdom); for them, then, it is clearly essential also to seem to accomplish the task of a wise man rather than to accomplish it without seeming to do so. To reduce it to a single point of contrast it is the business of one who knows a thing, himself to avoid fallacies in the subjects which he knows and to be able to show up the man who makes them; and of these accomplishments the one depends on the faculty to render an answer, and the other upon the securing of one. Those, then, who would be sophists are bound to study the class of arguments aforesaid: for it is worth their while: for a faculty of this kind will make a man seem to be wise, and this is the purpose they happen to have in view."

Proof, Refutation, Contradiction, Assertion, Exploration of ideas, belief, truth, form, expression, fallacy, didactic (unquestioned assertions) and dialectical argument (questioned and discussed),

"Those that depend on whether an expression is used **absolutely** or in a certain respect and not strictly, occur whenever an expression used in a particular sense is taken as though it were used absolutely, e.g. in the argument 'If what is not is the object of an opinion, then what is not is': for it is not the same thing 'to be x' and 'to be' absolutely. Or again, 'What is, is not, if it is not a particular

kind of being, e.g. if it is not a man.' For it is not the same thing 'not to be x' and 'not to be' at all: it looks as if it were, because of the closeness of the expression, i.e. because 'to be x' is but little different from 'to be', and 'not to be x' from 'not to be'. Likewise also with any argument that turns upon the point whether an expression is used in a certain respect or used absolutely. Thus e.g. 'Suppose an Indian to be black all over, but white in respect of his teeth; then he is both white and not white.' Or if both characters belong in a particular respect, then, they say, 'contrary attributes belong at the same time'. This kind of thing is in some cases easily seen by any one, e.g. suppose a man were to secure the statement that the Ethiopian is black, and were then to ask whether he is white in respect of his teeth; and then, if he be white in that respect, were to suppose at the conclusion of his questions that therefore he had proved dialectically that he was both white and not white. But in some cases it often passes undetected, viz. in all cases where, whenever a statement is made of something in a certain respect, it would be generally thought that the absolute statement follows as well; and also in all cases where it is not easy to see which of the attributes ought to be rendered strictly. A situation of this kind arises, where both the opposite attributes belong alike: for then there is general support for the view that one must agree absolutely to the assertion of both, or of neither: e.g. if a thing is half white and half black, is it white or black?"

#### (opposites and Not)

"Other fallacies occur because the terms 'proof' or 'refutation' have not been defined, and because something is left out in their definition. For to refute is to contradict one and the same attribute-not merely the name, but the reality-and a name that is not merely synonymous but the same name-and to confute it from the propositions granted, necessarily, without including in the reckoning the original point to be proved, in the same respect and relation and manner and time in which it was asserted. A 'false assertion' about anything has to be defined in the same way. Some people, however, omit some one of the said conditions and give a merely apparent refutation, showing (e.g.) that the same thing is both double and not double: for two is double of one, but not double of three. Or, it may be, they show that it is both double and not double of the same thing, but not that it is so in the same respect: for it is double in length but not double in breadth. Or, it may be, they show it to be both double and not double of the same thing and in the same respect and manner, but not that it is so at the same time: and therefore their refutation is merely apparent. One might, with some violence, bring this fallacy into the group of fallacies dependent on language as well." (group from individual)

The refutation which depends upon the consequent arises because people suppose that the relation of consequence is convertible. For whenever, suppose A is, B necessarily is, they then suppose also that if B is, A necessarily is. This is also the source of the deceptions that attend opinions based on sense-perception. For people often suppose bile to be honey because honey is attended by a yellow colour: also, since after rain the ground is wet in consequence, we suppose that if the ground is wet, it has been raining; whereas that does not necessarily follow. In rhetoric proofs from signs are based on consequences. For when rhetoricians wish to show that a man is an adulterer, they take hold of some consequence of an adulterous life, viz. that the man is smartly dressed, or that he is observed to wander about at night. There are, however, many people of whom these things are true, while the charge in question is untrue. It happens like this also in real reasoning; e.g. Melissus' argument, that the universe is eternal, assumes that the universe has not come to be (for from what is not nothing could possibly come to be) and that what has come to be

has done so from a first beginning. If, therefore, the universe has not come to be, it has no first beginning, and is therefore eternal. But this does not necessarily follow: for even if what has come to be always has a first beginning, it does not also follow that what has a first beginning has come to be; any more than it follows that if a man in a fever be hot, a man who is hot must be in a fever.

The refutation which depends upon treating as cause what is not a cause, occurs whenever what is not a cause is inserted in the argument, as though the refutation depended upon it. This kind of thing happens in arguments that reason ad impossible: for in these we are bound to demolish one of the premisses. If, then, the false cause be reckoned in among the questions that are necessary to establish the resulting impossibility, it will often be thought that the refutation depends upon it, e.g. in the proof that the 'soul' and 'life' are not the same: for if coming-to-be be contrary to perishing, then a particular form of perishing will have a particular form of coming-to-be as its contrary: now death is a particular form of perishing and is contrary to life: life, therefore, is a coming to-be, and to live is to come-to-be. But this is impossible: accordingly, the 'soul' and 'life' are not the same. Now this is not proved: for the impossibility results all the same, even if one does not say that life is the same as the soul, but merely says that life is contrary to death, which is a form of perishing, and that perishing has 'coming-to-be' as its contrary. Arguments of that kind, then, though not inconclusive absolutely, are inconclusive in relation to the proposed conclusion. Also even the questioners themselves often fail quite as much to see a point of that kind.

Such, then, are the arguments that **depend upon the consequent and upon false cause**. Those that depend upon the making of two questions into one occur whenever the plurality is undetected and a single answer is returned as if to a single question. Now, in some cases, it is easy to see that there is more than one, and that an answer is not to be given, e.g. 'Does the earth consist of sea, or the sky?' But in some cases it is less easy, and then people treat the question as one, and either confess their defeat by failing to answer the question, or are exposed to an apparent refutation. Thus 'Is A and is B a man?' 'Yes.' 'Then if any one hits A and B, he will strike a man' (singular), 'not men' (plural). Or again, where part is good and part bad, 'is the whole good or bad?' For whichever he says, it is possible that he might be thought to expose himself to an apparent refutation or to make an apparently false statement: for to say that something is good which is not good, or not good which is good, is to make a false statement. Sometimes, however, additional premisses may actually give rise to a genuine refutation; e.g. suppose a man were to grant that the descriptions 'white' and 'naked' and 'blind' apply to one thing and to a number of things in a like sense. For if 'blind' describes a thing that cannot see though nature designed it to see, it will also describe things that cannot see though nature designed them to do so. Whenever, then, one thing can see while another cannot, they will either both be able to see or else both be blind; which is impossible.

Those that depend upon whether something is said in a certain respect only or said absolutely, are clear cases of ignoratio elenchi because the affirmation and the denial are not concerned with the same point. For of 'white in a certain respect' the negation is 'not white in a certain respect', while of 'white absolutely' it is 'not white, absolutely'. If, then, a man treats the admission that a thing is 'white in a certain respect' as though it were said to be white absolutely, he does not effect a refutation, but merely appears to do so owing to ignorance of what refutation is.

The clearest cases of all, however, are those that were previously described' as depending upon the definition of a 'refutation': and this is also why they were called by that name. For the appearance of

a refutation is produced because of the omission in the definition, and if we divide fallacies in the above manner, we ought to set 'Defective definition' as a common mark upon them all.

Those that depend upon the assumption of the original point and upon stating as the cause what is not the cause, are clearly shown to be cases of ignoratio elenchi through the definition thereof. For the conclusion ought to come about 'because these things are so', and this does not happen where the premisses are not causes of it: and again it should come about without taking into account the original point, and this is not the case with those arguments which depend upon begging the original point.

Those that depend upon the assumption of the original point and upon stating as the cause what is not the cause, are clearly shown to be cases of ignoratio elenchi through the definition thereof. For the conclusion ought to come about 'because these things are so', and this does not happen where the premisses are not causes of it: and again it should come about without taking into account the original point, and this is not the case with those arguments which depend upon begging the original point.


It is, too, altogether absurd to discuss Refutation without first discussing Proof: for a refutation is a proof, so that one ought to **discuss proof** as well before describing false refutation: for a refutation of that kind is a merely apparent proof of the contradictory of a thesis. Accordingly, the reason of the falsity will be either in the proof or in the contradiction (for mention of the 'contradiction' must be added), while sometimes it is in both, if the refutation be merely apparent. In the argument that speaking of the silent is possible it lies in the contradiction, not in the proof; in the argument that one can give what one does not possess, it lies in both; in the proof that Homer's poem is a figure through its being a cycle it lies in the proof. An argument that does not fail in either respect is a true proof.

It is no true distinction between arguments which some people draw when they say that some arguments are directed against the expression, and others against the thought expressed: for it is absurd to suppose that some arguments are directed against the expression and others against the thought, and that they are not the same. For what is failure to direct an argument against the thought except what occurs whenever a man does not in using the expression think it to be used in his question in the same sense in which the person questioned granted it? And this is the same thing as to direct the argument against the expression. (Ideas to be understood - as opposed to words trying to express an idea)

- **10.** Attacking the *expression* or the idea/thought the pedant and time waster instead explore the meaning of words and ideas are the same time.
- **11. Examinations Yes/No** Binary **examinations** using multiple binary extremes So then clearly the art of examining **does not consist** in **knowledge of any definite subject**. For this reason, too, it deals with everything: for every 'theory' of anything employs also certain common principles. Hence **everybody, including even amateurs**, makes use in a way of dialectic and the **practice of examining**: for all undertake to some extent a **rough trial of those who profess to know things**...These, then, are the types of sophistical refutations: and that it belongs to the dialectician to study these, and to be able to effect them, is not difficult to see: for the **investigation of premisses** comprises the whole of this study.

- 12. Staying on Topic. Distractions. What has that to do with the original subject? Deliberate rabbit holes designed to induce fallacy and discredit the person... Moreover, argue from men's wishes and their professed opinions. For people do not wish the same things as they say they wish: they say what will look best, (Virtue signal hypocrisy) whereas they wish what appears to be to their interest: e.g. they say that a man ought to die nobly rather than to live in pleasure, and to live in honest poverty rather than in dishonourable riches; but they wish the opposite. Accordingly, a man who speaks according to his wishes must be led into stating the professed opinions of people, while he who speaks according to these must be led into admitting those that people keep hidden away: for in either case they are bound to introduce a paradox; for they will speak contrary either to men's professed or to their hidden opinions. Opposites not binary mutually exclusive false dichotomy Some questions are such that in both forms the answer is paradoxical; e.g. 'Ought one to obey the wise or one's father?' and 'Ought one to do what is expedient or what is just?' and 'Is it preferable to suffer injustice or to do an injury?'

Our programme was, then, to discover some faculty of reasoning about any theme put before us from the most generally accepted premisses that there are. For that is the essential task of the art of discussion (dialectic) and of examination (peirastic). Inasmuch, however, as it is annexed to it, on account of the near presence of the art of sophistry (sophistic), not only to be able to conduct an examination dialectically but also with a show of knowledge, we therefore proposed for our treatise

not only the aforesaid aim of being able to exact an account of any view, but also the aim of ensuring that in standing up to an argument we shall defend our thesis in the same manner by means of views as generally held as possible. The reason of this we have explained; for this, too, was why **Socrates** used to ask questions and not to answer them; for he used to confess that he did not know.

It is, then, an **affection for the whole human race** that makes my pen dart rapidly along to support what I believe to be the cause of virtue: and the same motive leads me earnestly to wish to see woman placed in a station in which she would advance, instead of retarding, the progress of those glorious principles that give a substance to morality. My opinion, indeed, respecting the rights and duties of woman, seems to flow so naturally from these simple principles, that I think it scarcely possible, but that some of the enlarged minds who formed your admirable constitution, will coincide with me." .." Contending for the rights of women, my main argument is built on this simple principle, that if she be not prepared by education to become the companion of man, she will stop the progress of knowledge, for truth must be common to all, or it will be inefficacious with respect to its influence on general practice. If children are to be educated to understand the true principle of patriotism, their mother must be a patriot; and the love of mankind, from which an orderly train of virtues spring, can only be produced by considering the moral and civil interest of mankind; but the education and situation of woman, at present, shuts her out from such investigations."

So what are the problems with education and the situation with women - we ask.

"Consider, I address you as a legislator, whether, when men contend for their freedom, and to be allowed to judge for themselves, respecting their own happiness, it be not inconsistent and unjust to subjugate women, even though you firmly believe that you are acting in the manner best calculated to promote their happiness? Who made man the exclusive judge, if woman partake with him the gift of reason?

In this style, argue tyrants of every denomination from the weak king to the weak father of a family; they are all eager to crush reason; yet always assert that they usurp its throne only to be useful. Do you not act a similar part, when you FORCE all women, by denying them civil and political rights, to remain immured in their families groping in the dark? For surely, sir, you will not assert, that a duty can be binding which is not founded on reason? If, indeed, this be their destination, arguments may be drawn from reason; and thus augustly supported, the more understanding women acquire, the more they will be attached to their duty, comprehending it, for unless they comprehend it, unless their morals be fixed on the same immutable principles as those of man, no authority can make them discharge it in a virtuous manner. They may be convenient slaves, but slavery will have its constant effect, degrading the master and the abject dependent."

She is describing the **Tyrant** - the do-gooder - the virtue signaler - in this case it is the MAN/Hero - doing certain good for the perceived victim/woman - the chaste - the protected. The deluded binary tribal type. Remember, at this time there were only too many women ready to play this binary drama triangle game for their own means - Mary wasn't one of them. Education and an enquiring mind helped but that still does not overcome the binary extremist's drama triangle groupthink.

"Let there be then **no coercion ESTABLISHED** in society, and the common law of gravity prevailing, the sexes will fall into their proper places. And, now that more equitable laws are forming your citizens, marriage may become more sacred; your young men may choose wives from motives of affection, and your maidens allow love to root out vanity."

"The conduct and manners of women, in fact, evidently prove, that their minds are not in a healthy state; for, like the flowers that are planted in too rich a soil, strength and usefulness are sacrificed to beauty; and the flaunting leaves, after having pleased a fastidious eye, fade, disregarded on the stalk, long before the season when they ought to have arrived at maturity. One cause of this barren blooming I attribute to a false system of education, gathered from the books written on this subject by men, who, considering females rather as women than human creatures, have been more anxious to make them alluring mistresses than rational wives; and the understanding of the sex has been so bubbled by this specious homage, that the civilized women of the present century, with a few exceptions, are only anxious to inspire love, when they ought to cherish a nobler ambition, and by their abilities and virtues exact respect."

Mary is a humanist arguing for being **educated as HUMANS** not as *alluring* women. Education for all regardless of tribe. What we have now is the opposite of what she wanted - Women and Blacks are deemed SPECIAL in the education system - the very problem she was describing.

"My own sex, I hope, will excuse me, if I treat them like rational creatures, instead of flattering their FASCINATING graces, and viewing them as if they were in a state of perpetual childhood, unable to stand alone. I earnestly wish to point out in what true dignity and human happiness consists—I wish to persuade women to endeavour to acquire strength, both of mind and body, and to convince them, that the soft phrases, susceptibility of heart, delicacy of sentiment, and refinement of taste, are almost synonymous with epithets of weakness, and that those beings who are only the objects of pity and that kind of love, which has been termed its sister, will soon become objects of contempt."

Mary observes the **permanent child/victim narrative** and how women fall into it.

"The civilization of the bulk of the people of Europe, is very partial; nay, it may be made a question, whether they have acquired any virtues in exchange for innocence, equivalent to the misery produced by the vices that have been plastered over unsightly ignorance, and the freedom which has been bartered for splendid slavery. The desire of dazzling by riches, the most certain pre-eminence that man can obtain, the pleasure of commanding flattering sycophants, and many other complicated low calculations of doting self-love, have all contributed to overwhelm the mass of mankind, and make liberty a convenient handle for mock patriotism. For whilst rank and titles are held of the utmost importance, before which Genius "must hide its diminished head," it is, with a few exceptions, very unfortunate for a nation when a man of abilities, without rank or property, pushes himself forward to notice. Alas! what unheard of misery have thousands suffered to purchase a cardinal's hat for an intriguing obscure adventurer, who longed to be ranked with princes, or lord it over them by seizing the triple crown!"

Mary notices the corruption, lies, dogma, totalitarianism, virtue signaling and cancel culture.

"Besides, nothing can be so prejudicial to the morals of the inhabitants of country towns, as the occasional residence of a set of idle superficial young men, whose only occupation is gallantry, and

whose polished manners render vice more dangerous, by concealing its deformity under gay ornamental drapery. An air of fashion, which is but a badge of slavery, and proves that the soul has not a strong individual character, awes simple country people into an imitation of the vices, when they cannot catch the slippery graces of politeness. Every corps is a chain of despots, who, submitting and tyrannizing without exercising their reason, become dead weights of vice and folly on the community. A man of rank or fortune, sure of rising by interest, has nothing to do but to pursue some extravagant freak; whilst the needy GENTLEMAN, who is to rise, as the phrase turns, by his merit, becomes a **servile parasite** or vile pander."

Mary understands the human condition and sees what is around her - the deception, the pretence the avoidance of reality based on manners and virtue signaling - *servile parasite* in my language is the *sentient pet of the feminists* (woof, woof). Andrew Barr, Andrew Leigh and the rest of the Greens/Labour. She is scathing, honest and direct in her assessment of what she sees around her. The idea that humans - regardless of their gender - can become embroiled in theatre - in displays - without connection to reason or reality.

"It is the pestiferous **purple** (Troy, Helen of Troy, the colour of royalty, roman emperors, popes - the grand display) which renders the progress of civilization a curse, and warps the understanding, till men of sensibility doubt whether the expansion of intellect produces a greater portion of happiness or misery. But the nature of the poison points out the antidote; and had Rousseau mounted one step higher in his investigation; or could his eye have pierced through the foggy atmosphere, which he almost disdained to breathe, his active mind would have darted forward to contemplate the perfection of man in the establishment of true civilization, instead of taking his ferocious flight back to the night of sensual ignorance."..

"Standing armies can never consist of resolute, robust men; they may be well disciplined machines, but they will seldom contain men under the influence of strong passions or with very vigorous faculties. And as for any depth of understanding, I will venture to affirm, that it is as rarely to be found in the army as amongst women; and the cause, I maintain, is the same. It may be further observed, that officers are also particularly attentive to their persons, fond of dancing, crowded rooms, adventures, and ridicule. Like the FAIR sex, the business of their lives is gallantry. They were taught to please, and they only live to please. Yet they do not lose their rank in the distinction of sexes, for they are still reckoned superior to women, though in what their superiority consists, beyond what I have just mentioned, it is difficult to discover.

The great misfortune is this, that they both acquire manners before morals, and a knowledge of life before they have from reflection, any acquaintance with the grand ideal outline of human nature. The consequence is natural; satisfied with common nature, they become a prey to prejudices, and taking all their opinions on credit, they blindly submit to authority. So that if they have any sense, it is a kind of instinctive glance, that catches proportions, and decides with respect to manners; but fails when arguments are to be pursued below the surface, or opinions analyzed.

May not the same remark be applied to women? Nay, the argument may be carried still further, for they are both thrown out of a useful station by the unnatural distinctions established in civilized life. Riches and hereditary honours have made cyphers of women to give consequence to the numerical figure; and idleness has produced a mixture of gallantry and despotism in society, which leads the very men who are the slaves of their mistresses, to tyrannize over their sisters, wives, and

daughters. This is only keeping them in rank and file, it is true. Strengthen the female mind by enlarging it, and there will be an end to blind obedience; but, as blind obedience is ever sought for by power, tyrants and sensualists are in the right when they endeavour to keep women in the dark, because the former only want slaves, and the latter a play-thing. The sensualist, indeed, has been the most dangerous of tyrants, and women have been duped by their lovers, as princes by their ministers, whilst dreaming that they reigned over them."

Mary is making very keen observations about the value of education and learning over moral posturing, performance, life experiences and opinions. It is worth reading her work.
