Preamble

This “thing” influenced the whole region - England, Flanders, Frisians, Netherlands, Denmark, Norway, Sweden. Treaties, Trust, Contracts and fair dealing mattered. Excessive Religion did not. This event resulted in a series of Polish–Teutonic Wars throughout the 14th and 15th centuries. In the 15th century, the towns of Prussia rapidly grew economically. However, this was not followed by an increase in their political influence. The rule of the Teutonic Knights was seen as more and more anachronistic – taxes (customs) and the system of grain licenses (every trader had to pay large fees for the privilege of trading grain) were hindering economic development in the province. At the same time the nobility wanted a larger say in the running of the country and were looking enviously at neighbouring Poland, where the Polish nobility enjoyed wider privileges. The Knights were also accused of violating the few existing privileges of the nobility and the cities. Craftsmen were discontented because of competition from so-called partacze, or artisans settled by the Knights near their castles. Kashubians, Poles, Germans, and Prussians were slowly melting into one nation, and as national differences disappeared, the common goals of all the ethnic and social groups of Prussia became more prominent, and the Prussian estates leaned increasingly towards Poland.*

Poland was entering a golden age https://en.wikipedia.org/wiki/Polish_Golden_Age Polish Golden Age (Polish: *Złoty Wiek Polski*) was the Renaissance period in Poland and the Grand Duchy of Lithuania, roughly corresponding to the period of rule of the **King Sigismund I the Old** (1506–1548) and his son, **Sigismund II Augustus**, the last of the Jagiellonian Dynasty monarchs, until his death in 1572.[1][2] Some historians argue that the Polish Golden Age continued into the mid-17th century, when the Polish–Lithuanian Commonwealth was ravaged by the Khmelnytsky Uprising (1648–57) and by the Swedish and Russian invasion. During its Golden Age, the **Commonwealth** became one of the largest kingdoms of Europe, stretching from modern Estonia in the north to Moldavia in the east and Bohemia in the west.

Germany, Ukraine, Romania, and the Balkans were still heavily involved in dealing with Barbarians and Spain, Italy, France were heavily involved in Religious tribalism and excessive Authoritarianism. Venice had sold its “principles” to the Ottomans for trade and money. Spain and Portugal were forming world wide alliances and disrupting the muslim dominated Indian Ocean trade. The American Tribes, West Indian, South American, Pacific Islander, Aborigines, African tribes - were killing and eating each other (as usual) in constant tribal warfare, raiding, stealing, raping, etc - kind of way. China was doubling down on Ming Controls and Chinese individuals were leaving to settle in other places and become pirates to disrupt Ming (take the knee) controlled trade.

For centuries various tribes had migrated to safe haven enclaves in cities, and country areas like Switzerland Alps (various religious groups), Northern Spain (Cathars and others), the Nile <https://en.wikipedia.org/wiki/Makuria> Makuria Kingdom, Ethiopia, Yemen and other places - all trying to avoid the conflicts and excesses. The Jewish tribes seemed to be the most successful in profiting from both sides of any conflict and were able to work with all the kings at war with each other and formed Jewish enclaves in cities in Spain, Italy, France and other areas - and hence became rich as a group. For example in many areas the Jewish enclaves had access to their own wells and water and kept to themselves which resulted in less plague deaths. Jewish enclaves became targets for those intent on tribal warfare and religious intolerance. There are examples of respected and tolerant leaders - the memories and stories lived on - especially those who protected people from mob violence https://en.wikipedia.org/wiki/John_I,_Duke_of_Brabant **John I of Brabant**, also called *John the Victorious* (1252/1253 – 3 May 1294) was Duke of Brabant (1267–1294), Lothier and Limburg (1288–1294). During the 13th century, John I was venerated as a folk hero.[1] He has been painted as the perfect model of a brave, adventurous and chivalrous feudal prince https://en.wikipedia.org/wiki/John_II,_Duke_of_Brabant John II (27 September 1275 – 27 October 1312), also called **John the Peaceful**. In 1309, the **Crusade of the Poor** besieged the castle of Genappe in Brabant because it was **sheltering Jews**. John sent an army that defeated the crusaders, who incurred heavy losses.[2] John, who suffered from kidney stones and wanted his duchy to be peacefully handed over to his son upon his death, in 1312 signed the famous **Charter of Kortenberg**. John died in Tervuren in 1312.[3] He was buried in the St. Michael and Gudula Cathedral in Brussels.

https://en.wikipedia.org/wiki/Charter_of_Kortenberg is an agreement signed and sealed on September 27, 1312, in the abbey of Kortenberg by John II, Duke of Brabant and representatives of the cities of Brussels, Antwerp, 's-Hertogenbosch, Tienen and Zoutleeuw. Creation of the document is of historical and political importance because it retains agreements between inhabitants of a territory with a ruler who had absolute power. This reflected the start of a current that would later be labeled by historians as Brabant's Constitutionalism because residents without control had claimed

rights and powers, and had them recorded in writing, which are somewhat comparable to what have come to be called civil and political rights centuries later. In this process, the first simple rules were created for what would develop into a legal order that is now called democratic rule of law.

Many places legislated against specific religions - muslims, catholics, protestants, jews, etc. Religious persecution was widespread e.g. special taxes or special tax EXEMPTIONS (as we have now in Australia).

I hypothesize part of the thinking of the Jewish tribes might have been something like “We are the victims of everyone so let us profit as much as we can and keep our tribe successful”. Hannah Arendt may have some more insight on this. The Jewish tribes were some of the first religious tribes to migrate to the Americas. In later times, enclaves in South America migrated to enclaves in north America. Many religious tribal groups moved to north America the same way muslim tribes moved through South East Asia.

Sticking to the rules of law and treaties was important. People remembered and things were written down. Stability was maintained, Anxiety was reduced, Trust was increased by local treaties and the Papal Bulls and dogma from the Church in Rome was less relevant in northern Europe - but the Papacy still held great power over world decisions about colonization, discoveries and agreements.

The ottoman, muslim, khans, Turkomans were at war between themselves and between Europe and the Balkans. People traded with people - even while at war with each other or their alliance partners - not only Venice and other temporary war alliances but also the English trading companies https://en.wikipedia.org/wiki/Levant_Company *The Levant Company was an English chartered company formed in 1592. Elizabeth I of England approved its initial charter on 11 September 1592 when the Venice Company (1583) and the Turkey Company (1581) merged, because their charters had expired, as she was eager to maintain trade and political alliances with the Ottoman Empire.[1] Its initial charter was good for seven years and was granted to Edward Osborne, Richard Staper, Thomas Smith and William Garrard with the purpose of regulating English trade with the Ottoman Empire and the Levant. The company remained in continuous existence until being superseded in 1825. A member of the company was known as a Turkey Merchant.*

Spanish Netherlands wars had a 12 year truce because there was not enough money left to pay the soldiers to keep fighting. https://en.wikipedia.org/wiki/Twelve_Years%27_Truce *The Twelve Years' Truce was a ceasefire during the Eighty Years' War between Spain and the Dutch Republic, agreed in Antwerp on 9 April 1609 and ended on 9 April 1621.[1] While European powers like France began treating the Republic as a sovereign nation, the Spanish viewed it as a temporary measure forced on them by financial exhaustion and domestic issues and did not formally recognise Dutch independence until the Treaty of Westphalia in 1648.[2][3] The Truce allowed Philip III of Spain to focus his resources elsewhere, while Archdukes Albert and Isabella used it to consolidate Habsburg rule and implement the Counter-Reformation in the Southern Netherlands*

Thus in the century between 1450 and 1550 Western civilization found itself in intimate and continuous contact by personal intercourse or literary remains with ten living and dead civilizations (Classic, Syriac, Orthodox, Russian, Iranian, Arabic, Hindu, Chinese, Mexican, Andean) as well as with many primitive cultures. It had lost the sense of being itself a universal civilization. It saw it-self as but a small portion of a world of great variety. Its importance became relative, just as the importance of the world itself came to be relative after the astronomy of Copernicus, Bruno, and Galileo had superseded that of Ptolemy and Dante.

People valued agreements.

It declared that all magistrates in the provinces making up the Union of Utrecht were freed from their oaths of allegiance to their lord, Philip, who was also King of Spain.

But prior to all that there was a history of towns people having rights and negotiating agreements with Ruler and Kings - especially when the Rulers were far away in other regions.

https://en.wikipedia.org/wiki/Magdeburg_rights set of town privileges first developed by **Otto I, Holy Roman Emperor** (936–973) and based on the Flemish Law,[1] which regulated the degree of internal autonomy within cities and villages granted by the local ruler. Named after the German **city of Magdeburg**, these town charters were perhaps the most important set of medieval laws in Central Europe

https://en.wikipedia.org/wiki/L%C3%BCbeck_law developed at **Lübeck**, which became a free imperial city in **1226** and is located in present-day Schleswig-Holstein. It was the second most prevalent form of municipal law in medieval and early modern Germany next to the Magdeburg Law. Lübeck Law provided for municipal self-government and self-administration yet did not negate dependence upon a lord, be it a bishop, duke, king or, in Lübeck's case, an emperor. Instead, it allowed the cities a certain degree of autonomy and self-reliance in legislative, judicial and executive matters. While these authorities were vested in the city council (Rat), the members of which could be elected by co-option, the Lübeck Law represents a significant modernization of governance in that a class of burghers, as opposed to nobles, were responsible for the day-to-day affairs of governing

https://en.wikipedia.org/wiki/Danzig_law Danzig Law were the statute books of the Holy Roman Empire and of other Hanseatic cities, especially Lübeck. The merchant city received Lübeck law in **1226**. In the 15th century, the Prussian Confederation was founded to oppose the policy of the Teutonic Order. The Prussian Confederation supported accession to Poland, triggering the Thirteen Years' War. During that time, **Danzig** continued with its own set of law system, which its **self-government**.

Over a period of many hundreds of years towns had learned to interact and cooperate - business and families flourished. They had built trust, communication and cooperative agreements around documents, contracts, families, trade and defence networks. Then the religious tribal zealots and barbarians started to attack. Spanish inquisition, Spanish soldiers, religious zealots - tribalism

became more rampant and atrocities became more common and remembered. The English and the Dutch (most of the northern areas - Hanseatic League) were working out their common areas of agreement and support and what the problems were. It wasn't just the brutality - Elizabeth was not fond of the brutality of the sea raiders and refused them access to ports - but she herself was brutal some times (Settlement of Ireland https://en.wikipedia.org/wiki/Plantations_of_Ireland) - it was something else - it seems to me like the middle ground was being explored more. There were always brutal individuals but some idea of principles for groups was emerging. Treaties, discussion, agreements went hand in hand with war and argument - after many hundreds of years practise between what was essentially a complicated network of families, trade networks and business partners - people were starting to learn how to behave and question the idea of behaviour. Books, etc were printed and read. So instead of forgetting history and the recent past they were able to remember and re-read what happened and learn from it. So Bede's observation about people forgetting history was being overcome by a shared knowledge of the world and history in books, libraries, treaties, agreements, etc - especially in England, Scotland and northern Europe.

People were getting a wider context of the world through space and time and willing to fight for individual freedoms.

https://en.wikipedia.org/wiki/Free_imperial_city *self-ruling city that had a certain amount of autonomy and was represented in the Imperial Diet.*[1] *An imperial city held the status of Imperial immediacy, and as such, was subordinate only to the Holy Roman Emperor, as opposed to a territorial city or town (Landstadt) which was subordinate to a territorial prince – be it an ecclesiastical lord (prince-bishop, prince-abbot) or a secular prince (duke (Herzog), margrave, count (Graf), etc.). The evolution of some German cities into **self-ruling constitutional entities** of the Empire was slower than that of the secular and ecclesiastical princes. In the course of the **13th and 14th centuries**, some cities were promoted by the emperor to the status of Imperial Cities (Reichsstädte; Urbes imperiales), essentially for fiscal reasons. Those cities, which had been founded by the German kings and emperors in the 10th through 13th centuries and had initially been administered by royal/imperial stewards (Vögte), gradually gained independence as their city magistrates assumed the duties of administration and justice; some prominent examples are Colmar, Haguenau and Mulhouse in Alsace or Memmingen and Ravensburg in upper Swabia.*

The battle was part of an expedition by an English fleet initially led by Sir Walter Raleigh, and then by Martin Frobisher and John Burrough. The expedition involved the capture of a number of Portuguese and Spanish ships including the large Portuguese carrack Madre de Deus, after a long naval battle off the island of Flores in the Azores. The expedition, particularly the capture of the great carrack, was a financial and military success. Chess <http://billwall.phpwebhosting.com/articles/oldtexts.htm> may have originated in India with Elephants as pieces but the version of Western Chess we see now with Kings, Queen, Knights, Bishops and Rooks (beserkers) becomes even more popular in the 1500s. Even the pawn can become anything it wants when it finally crosses the field of battle. The **Lewis** Chess pieces were found in the outer Hebrides and date to around the 1200s.

*In 1283 **Libros del Axedrez dados y tablas** (Book of Chess and other games) was written for King Alfonso X (1221-1284), King of Castile. It was the first encyclopeida of games in European literature. The first of the 7 parts of the Alfonso manuscript is devoted wholly to chess, and contains 103 problems. It also includes descriptions of several chess variants....In 1474 William Caxton (1422-1491) published the **Game and Playe of the Chesse** in English. It was translated from Jehen de Vignay's French version of the Innocent Morality. It was the 3rd book printed in English, after the Bible and The Recuell of the Historyes of Troye, and the first English book published in England. It was the first printed book in English to make extensive use of woodcuts for pictures.*

However, he banned the game for those who were not wealthy or well to do" because "Bowyers, Fletchers, Stringers and Arrowhead makers" were **spending more time at recreational events such as bowls, instead of practising their trade**. Henry VIII requested that anybody who wished to keep a green should pay a fee of 100 pounds. However, the green could only be used for private play, and he forbade anyone to "play at any bowle or bowels in open space out of his own garden or orchard". **King James I** issued a publication called "**The Book of Sports**" and, although he condemned football (soccer) and golf, he encouraged the playing of bowls"

*that nothing should be permitted which might disturb the worshipers when engaged in divine service; that it should be left to each man's conscience whether he should take part in the **accustomed sports** when service was over; that all parishioners were to attend their own parish church; and*

those who refused to do so were to be debarred from engaging in the subsequent diversions.[6]

*James based the substance of his subsequent declaration on these points; but his publication of the **Book of Sports in the following year led to new disturbances**. Morton's own dealings with nonconformist clergy were marked by moderation*

And after His returne, Hee farther saw that His loyall Subiects in all other parts of His Kingdome did suffer in the same kinde, though perhaps not in the same degree: And did therefore in His Princely wisdom, publish a Declaration to all his louing Subiects concerning lawfull Sports to be vsed at such times, which was printed and published by His royall Commandement in the yeere 1618. In the Tenor which hereafter followeth..... And as for Our good peoples lawfull Recreation, Our Pleasure like is, That after the end of Diuine Seruice, Our good people be not disturbed, letted, or discouraged from any lawfull recreation, Such as **dauncing**, either men or women, **archery for men**,

*leaping, vaulting, or any other such harmlesse Recreation, nor from **hauing of May-Games, Whitson Ales, and Morris-dances**, and the setting vp of **May-poles** & other sports therewith vsed, so as the same be had in due & conuenient time, without **impediment or neglect of Diuine Seruice**: And that **women shall haue leaue to carry rushes to the Churches for the decoring of it**, according to their old custome. But withall We doe here account still as prohibited all **vnlawfull games** to bee vsed vpon Sundayes onely, as **Beare and Bullbaitings, Interludes**, and at all times in the meaner sort of people by law prohibited, **Bowling**.*

*And likewise We barre from this benefite and liberty, all such known recusants, either men or women, as will abstain from comming to Church or Diuine Seruice, being therefore **vnworthy of any lawfull recreation after the said Seruice, that will not first come to the Church and serue God**: Prohibiting in like sort the said Recreations to any that, though conforme in Religion, are not present in the Church at the Seruice of God, before their going to the said Recreations. Our pleasure likewise is, That they to whom it belongeth in Office, shall present and sharpely **punish all such as in abuse of this Our liberty, will vse these exercises before the ends of all Diuine Seruice for that day**. And We likewise straightly command, that euery person shall resort to his owne Parish Church to heare Diuine Seruice, and each Parish by it selfe to vse the said Recreation after Diuine Seruice. Prohibiting likewise any Offensiuie weapons to bee carried or vsed in the said times of Recreations. And Our pleasure is, That this Our Declaration shall bee published by order from the Bishop of the Diocesse, through all the Parish Churches, and that both Our Iudges of Our Circuit, and Our Iustices of Our Peace be informed thereof.*

What we see here is the **Draconian detail** and **totalitarian approach** all dressed up as a “good” idea to **allow people to play games** - as long as the games are the approved games of the king of the day. Bowls is “evil”. We also see a kind a “Social Credit” system that China is implementing now. The idea that as long as you “serve God” and the “right zealot’s cause” then you are allowed some time off from work. The king then also allows the local sherrif, judge, bully and abuser (Like we see in the Canberra Magistrates and court system now) to run the place and punish anyone they choose for not “obeying the law” and “serving God” in the right kind of way. This strict rule is dressed up as “Liberty” and “Freedom” and a “good idea” and represents the start of **Purtitanism** and the “calling out of people” for not obeying the law or being heretics or witches. So while individual detailed Maps were being developed by workers in Majorca, Lisbon, Seville , Dieppe https://en.wikipedia.org/wiki/Dieppe_maps and Asia - by the 1500s the Flanders was becoming a center for cartography and these were being made **publicly available** for a price. This was significant difference to the idea of spying and intelligence - where in many ways - the detailed knowledge of places, currents, winds was the key information for sailors to have some advantage over others.

With the growth in printing - not only were more books available but more types of printed things in more languages and styles were becoming more widespread. Music, Poems, Maps, Cards, Pamphlets and Plays.

Petrucci's printing method produced clean, readable, elegant music, but it was a long, difficult process that required three separate passes through the printing press. Petrucci later developed a process which required only two passes through the press. But it was still taxing since each pass required very precise alignment for the result to be legible (i.e., so that the note heads would be correctly lined up with the staff lines). This was the first well-distributed printed polyphonic music. Petrucci also printed the first tablature with movable type. **Single impression printing**, in which the staff lines and notes could be printed in one pass, first appeared in **London around 1520**. Pierre Attaignant brought the technique into wide use in **1528**, and it remained little changed for 200 years.

Fair Play

The idea of fair play and fair dealing with each other can be seen from trade and the consequences were the many wars fought over trade when deals were not fair.

As well we can see the **Cathars** removing daily dogmatic devotion to god to **fair dealing during your life** with resolution at the end of life.

We also have the field of medieval battles where chivalry developed and Jousting where a good fight was not murderous barbarianism but a display of a “good fight” played fairly followed by feasts, performances, poetry, songs, dances and celebrations. Fair play is not a concept that Ottomans, Muslims and other barbarians understand - especially when they fill themselves with “the cause” https://en.wikipedia.org/wiki/Ballaban%27s_campaign_of_1465 *Ballaban Badera had been given command of two separate forces to march against Skanderbeg in 1465. The first was defeated at Vaikal. But the Albanian victory came to a great cost. Many of Skanderbeg's most trusted lieutenants had been captured and sent to Istanbul. They were **given the choice of converting to Islam or of dying**. All of them chose the latter and their bodies were mutilated and thrown to the dogs.*

Fair dealing was very strong in northern Europe especially amongst the merchants and townspeople in Flanders, Brabant, Belgium, Netherlands - general areas - from about 1200 onwards. Cooperation and fair dealing was valued. People who were fair dealers were appreciated and valued. People remembered the **treaties and agreements which had been made** - the treaties - and **how they had ensured peace and prosperity**. This morphs into the ideas expressed by later philosophers as the

“social contract” e.g. Thomas Hobbes - Leviathan (1651)

Saints, Heroes, Victims, Wars and other lies.

Having gone through the stories of many places, people, wars and saint/hero stories - I can see the drama triangle and binary classification system into the Hero/Victim/Perpetrator classifications. You are either with us or against Us, Us/Them, "Others" and other groupthink which binary type extremists - Religious fanatics, Zealots, Women (On average - victim narratives, wages (averages - Katy Gallagher 60% means "equality", 70% means more "equality" and diversity as well), groupthink) and weak minded men (virtue signaling heroic - "crusaders" for the "cause").

While the idea of hagiographies <https://en.wikipedia.org/wiki/Hagiography> (idealized biographies) has been around for a long time - so has the demonization of "others" into permanent evil stereotypes - "Hitler", Devil, "Voldemort" (Tanya Plibersek), "Far Right extremists" (Bill Shorten) "#@!!s" (Noel Pearson). The Greens/Labour men and women in Australian politics spend most of their time labeling themselves as "heroes" and anyone who dares to question their deluded narcissistic tyranny as "Voldemort" or "Evil". This technique is repeated throughout history - the Spanish Inquisition, Witch trials, Heresy in general, Jihads, etc - many examples mainly around their Moral or Intellectual superiority. Barbarians did not play that game so much as physical superiority and better killing techniques entitled them to take over the world - like we see in the thinking of the Chinese and Russians today. Both of these extreme patterns fail to recognize the inherent value of individual humans and the possibilities of creative choices people can make.

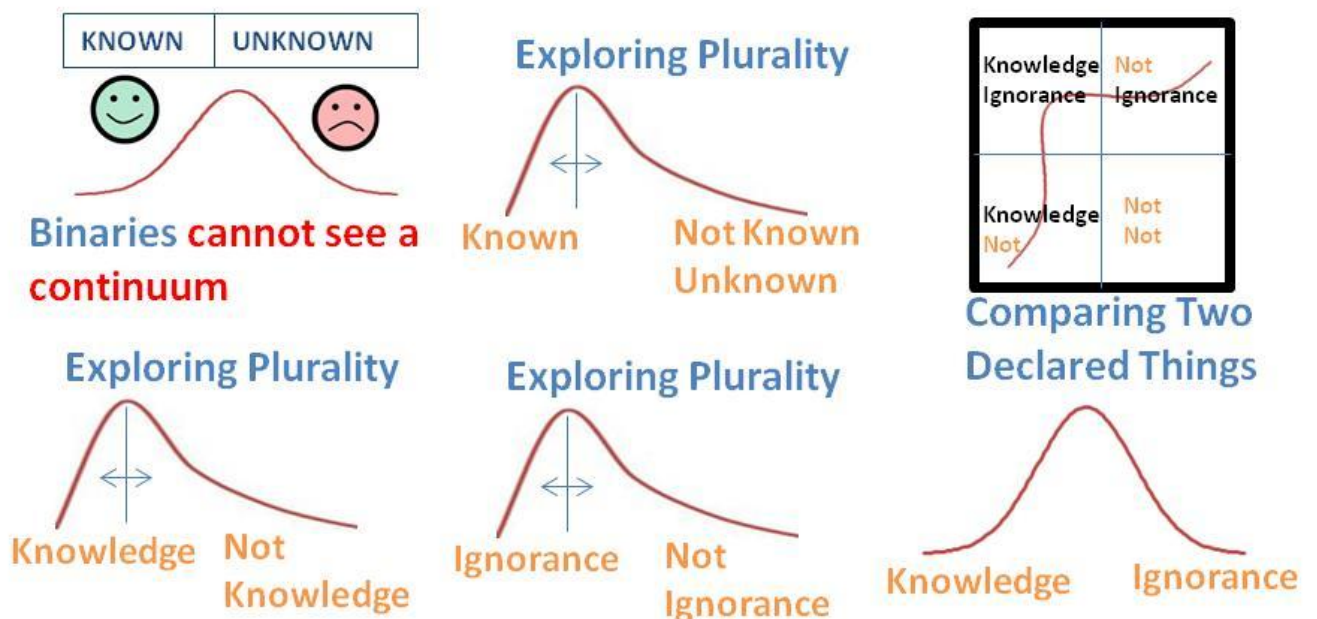
What we see with the "entitled" narrative and especially the "entitled victim" narrative so common with women, Blacks and religious fanatics is violence, death and torture around "the end justifies the means". The "end" is usually presented as "the certain End" - "The War to end all wars" or the "Chosen ones in heaven", "an endless supply of slaves and virgins", Burning Books, Heretics, Torture, Guantenemo Bay, etc.

This **certain God** delusion dominates more than 70% of the world's population and very few people can seem to escape the habitual binary classification systems.

The Inquisitors and witch-hunters of today are the same as the zealots of the past - many notable e.g. https://en.wikipedia.org/wiki/Nicholas_Jacquier **Nicholas Jacquier** - Jesuit, Inquisitor, Witch hunter (the list is endless) but large percentages of the population back then were as binary, pig-ignorant, deluded, violent and smugly vain-glorious as we see in women politicians, all female activists, blacks, binary extremists, weak minded men, ABC board management and staff, Helen Watchirs "Human Rights" (for women), Canberra courts, etc. With their delusion comes lies, bigotry, corruption, nepotism and the jihad of insanity of all tyrants - Andrew Barr, Dan Andrews, NZ, Canada and Australian politicians, councils, state premiers, etc.

Some Greeks and Romans wrote about things other than the Hero/Perpetrator/Victim drama triangle. People like Dante and Erasmus wrote about other things as well.

Lying seems be a recent human development located in the PFC and has some purpose <https://www.scientificamerican.com/article/the-art-of-lying/> . It may also help with **Memory** and **Imagination** - the ability to Imagine things is sometimes a very creative exploration. But also too the ability to forget things can help - i.e. the ability to NOT **ALWAYS DWELL ON YOUR MISTAKES** - a **partial** forgetfulness is a way of moving forwards, learning and improving. I think it has something to do with the avoidance of binary certainty - so in the same way as I explain that **Knowledge and Ignorance** are very tightly coupled - see **What Were you Thinking – 1500s – Part1** <https://humanistman.com/wp-content/uploads/2023/10/What-Were-you-Thinking-1500s-part1.pdf>



So too I think the concepts of **True and False** are very tightly coupled. But there is something different between that and a **deliberate lie** and **deception** that we see Women in Domestic violence cases, Family court, Greens/Labour politicians and ABC board management and staff. This is not a simple misunderstanding of what Truth is - but **a full on orchestrated deception and lies maintained over a long period of time**. Blacks and Women activists do this constantly like many other tribal jihadists. They double down on their lies and deception in a delusion that they will never face the

truth. This is related to the cave of certainty, shining a light, looking more broadly, getting a greater context, getting a greater understanding and exploring the issue. Here too the binary extremist types become stuck thinking something is either fully true or fully a lie and **true/false binary extreme** and they seem to mandate "Truth" in an Orwellian style - very much like Greens/Labour, Black Women activist fuckwits in the Public services and Australian Government today. Their habit is the deliberate lie or "play acting" delusions we see in hysterical women and others who "see things" and "hear voices" and "feel upset". One lesser known example is Leicester Boy Witch Trial - War[1616]

Leicester Boy Witch Trial - War[1616] https://en.wikipedia.org/wiki/Leicester_boy_trial *The Leicester boy trial was one of Leicester's most notorious witchcraft cases, in which a thirteen-year-old boy publicly accused 15 women of causing a possession within him. The case took place in **Husbands Bosworth**, a small village not far from Leicester in 1616. John Smith fell into a series of violent fits, not even several men could hold him down. He made strange noises, and, as noted in a letter from Alderman Robert Heyrick to his brother Sir William,[1] he would beat himself with inhuman strength, yet somehow remain unharmed. He gave extensive details on their familiars. The two judges, Sir Humphrey Winch and Sir Ranulph Crewe quickly condemned the women, rounding all 15 of them up. **Nine of them were tried, found guilty and hanged for allegedly possessing John Smith. The other six were placed in prison to wait their turn.** None of them were named before being hanged. **King James I happened to be passing through about a month later, and heard what was going on. He called for John Smith to be questioned, and had little trouble determining the child was fraudulent. He broke down, and confessed the truth.** Of the six women who had been imprisoned, only five of them were released, as one of them died inside. According to a timeline, the woman who had died told the jailer she was working with the witches against Smith the day before she died. She had begged him not to say anything because the witches would harm her.*

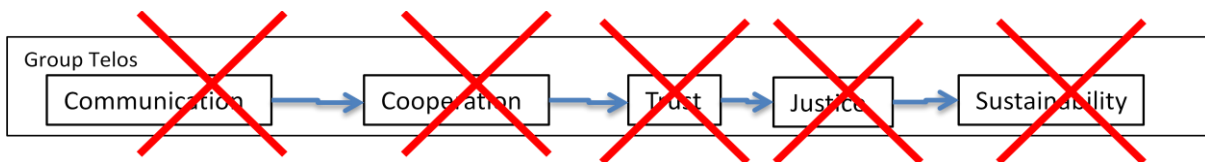

False witnesses were usually subjected to the punishment for the crime the false accused. E.g. making false or improvable accusations for rape would get you the same sentence as committing the rape itself. No woman now is ever tried for lying or making improvable or false accusations. People (Blacks, Women - victim narrative and groupthink) are now given Australia Day awards and money from taxpayers - not just for hyperbolic positioning - but for outright lying (Katy Gallagher - for "the cause").

This **Leicester Boy Witch Trial** was a sign of the Jacobean era and the rise of Puritanical zeal and was a precursor to Salem and other later witch trials - but the willingness of these esteemed judges to believe the boy's deliberate lies is what we see now in the ABC, Family courts and the Canberra Magistrates court. Andrew Barr has legislated that no trial is necessary orders are made in absentia based on allegation alone - all men are guilty as charged when an allegation of violence has been made. See the ACT Legislation on Violence. Canberra Judges - Magistrate Robert Cook - not only believes lies and false accusations from women but he also puffs himself with virtuous self-righteous pride as he attacks and demeans those he condemns. These deluded "heroes" for the "cause" are everywhere - in Canberra courts, family courts, politics, ABC and many places around Australia. So deliberately lying has always been "fun" for children and many others (narcissistic deluded psychopaths - Greens/Blacks/Feminists/Women (on average) - religious extremist types). But it is the

“heroic” fuckwits in the Inquisitions, Politics and courts around the country which turn these things into the destruction of society we see around us now. 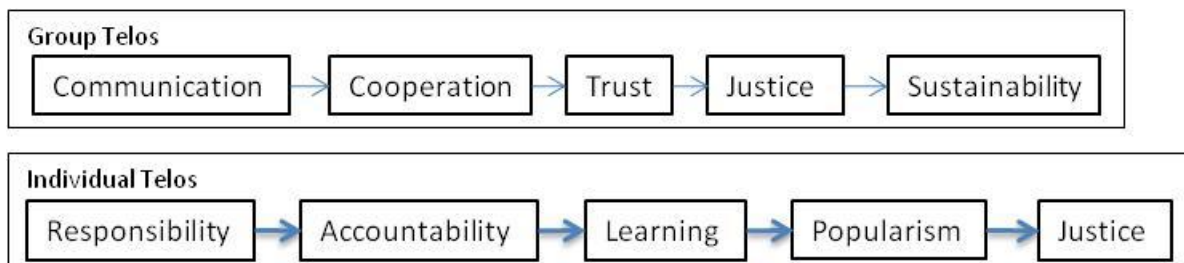


Hyperbole, exaggeration and other terms might describe the general technique of moving from between extremes as we discuss things and we reach some level of **Size** (range of **definitions** of things) and **Measure** (number of) things in agreement between the two extremes.

Maybe not everything is extremely good or bad. So maybe there is some hope left after all?

But we also see a technique of abstracting out some “principles” of agreement. “burning people at the Stake” is agreed in principle to be a bad idea. Cutting people’s heads off and holding them up laughing and chanting **god is great** is also a “Bad idea”. Inviting women (ISIS) and children into the country who cheer this on pretending they are “victims” might not be a good idea in principle. Some people might see these principles of general agreement as a sign of “Civilization” - some base level principles of behaviour which represent the content of human character - this discussion continues as part of the ongoing human condition and the constant desire for a dogmatically certain utopia is a delusion which many people hanker for.

Maybe having a generally agreed group telos is a good idea?



Or should the binary totalitarian draconians stick to their certain bibles?

To start with - Is communication a good idea in principle?

I have put many wars on my Map simply at face value as a data collection exercise. I am not going to dogmatically rule on them one way or the other until I have collected all the information and have as much context and corroborant information as I can. For example it is well known that many European Families completely manufactured the family histories to portray themselves as heroes and saviours and claim to be fighting heroically in many battles - these lying techniques date back thousands of years. Rich people paying for books to be written , other books to be burned, statues to be built and paintings to be painted has to be seen in context. I mean - **why bother** reading someone's auto biography?

Once I have collected the asserted information I can then try to make sense of it for my purposes. My purposes have nothing to do with binary extremisms - so I will be searching for some meaning and learning.

During the wars of the summer of 1465, Dinant celebrated a false rumour that Charles had been defeated at Monthéry by burning him in effigy and chanting that he was the bastard child of his mother Isabella of Portugal and John of Heinsburg, the previous Bishop of Liège (d. 1455). On **25 August 1466**, Charles marched into Dinant, determined to avenge this slur on the honour of his mother, and **sacked the city, killing every man, woman and child within.***

In the Middle Ages, the **city was unashamedly prosperous**: an annual fair was organised there, markets were set up, and brass was worked. This prosperity came to an abrupt end one day in 1466... The hereditary enemy of Liège, **Charles the Bold, sacked the city. Dinant never recovered.** The surviving craftspeople took refuge in Liège and in Mézières: these exiles were to contribute towards the prosperity of the French town.*

<https://en.wikipedia.org/wiki/Dinant> *Its strategic location on the Meuse exposed Dinant to battle and pillage, not always by avowed enemies: in 1466, Philip the Good, Duke of Burgundy, uncle of Louis de Bourbon, Prince-Bishop of Liège, and Philip's son Charles the Bold punished an uprising in Dinant during the Liège Wars, by **casting 800 burghers into the Meuse and setting fire to the city.** The city's economic rival was Bouvignes, downriver on the opposite shore of the Meuse.*

But **Dinant** seems mostly remembered for the 1914 war

The massacre was another reprisal against anticipated civilian resistance and was the largest of the German war crimes perpetrated during the invasion, which became collectively known as the **Rape of Belgium***

But **Charles the Bold** would be remembered for his slaughters and massacres - especially by family friends and allies of those he had brutalized. He united the Swiss in such a way that they had never been united before - because of his lack of human decency, observing the basic rules of war and sheer brutality. https://en.wikipedia.org/wiki/Battle_of_Grandson **Battle of Grandson** was fought on

2 March **1476**, during the Burgundian Wars, and resulted in a major defeat for Charles the Bold, Duke of Burgundy, at the hands of the Old Swiss Confederacy....After the battle, the Swiss troops came upon the bodies of their countrymen still hanging from trees in Grandson. An eyewitness, Peterman Etterlin, described the scene:

There were found sadly the honorable men still freshly hanging on the trees in front of the castle whom the tyrant had hanged. It was a wretched, pitiable sight. There were hung ten or twenty men on one bough. The trees were bent down and were completely full. [H]ere hanged a father and a son next to each other, there two brothers or other friends. And there came the honorable men who knew them; who were their friends, cousins and brothers, who found them miserably hanging. There was first anger and distress in crying and bewailing.

Charles had attempted to break the will of the Swiss by killing any of their countrymen whom he could apprehend. Instead, he united them as never before. When the Burgundians met the Swiss at the Battle of Morat (Murten in German) in **June 1476, the Swiss annihilated his army**. And then finally at Nancy https://en.wikipedia.org/wiki/Battle_of_Nancy **5 January 1477** .. A halberdier quickly swung at the Duke's head and landed a deadly blow directly on his helmet.[7] He was seen to fall but the battle flowed on around him. It was three days until the Duke's disfigured body was finally found and positively identified amongst the detritus of the slaughter. Most of Charles' army was killed during the battle and their retreat. Only the few who retreated over 50 km (31 mi) to Metz survived.[8] Contemporary chronicles record that the killing of retreating soldiers continued for three days after the battle and that for 5–6 leagues (15–18 miles [24–29 km]) the road was covered with the dead. Some of the soldiers who reached Metz were still so afraid of the pursuing army that they threw themselves into the icy moat in the hope that they could swim to the city

I rely on other people to have done the research from source material - but I can observe my reactions - **I think that the idea of massacres of whole towns and villages is a bad idea**. But maybe Charles had a series of motives. Greed, Power, revenge, money and narcissistic self-righteousness. Maybe he was insane or "Evil". Maybe he saw himself as "the victim" and "entitled". Maybe he was "righteously entitled" But it is difficult to tell what he was thinking. But then I can look at the people around me now - the Greens/Labour types - Katy Gallagher, Tanya Plibersek, Mark Dreyfuss, Bill Shorten, Mark Butler and the other lying, bigoted, tribal and corrupt members of the Greens/Labour Party, Blacks, feminists, zealots and see some parallels and know that I am observing something which echoes throughout human history.

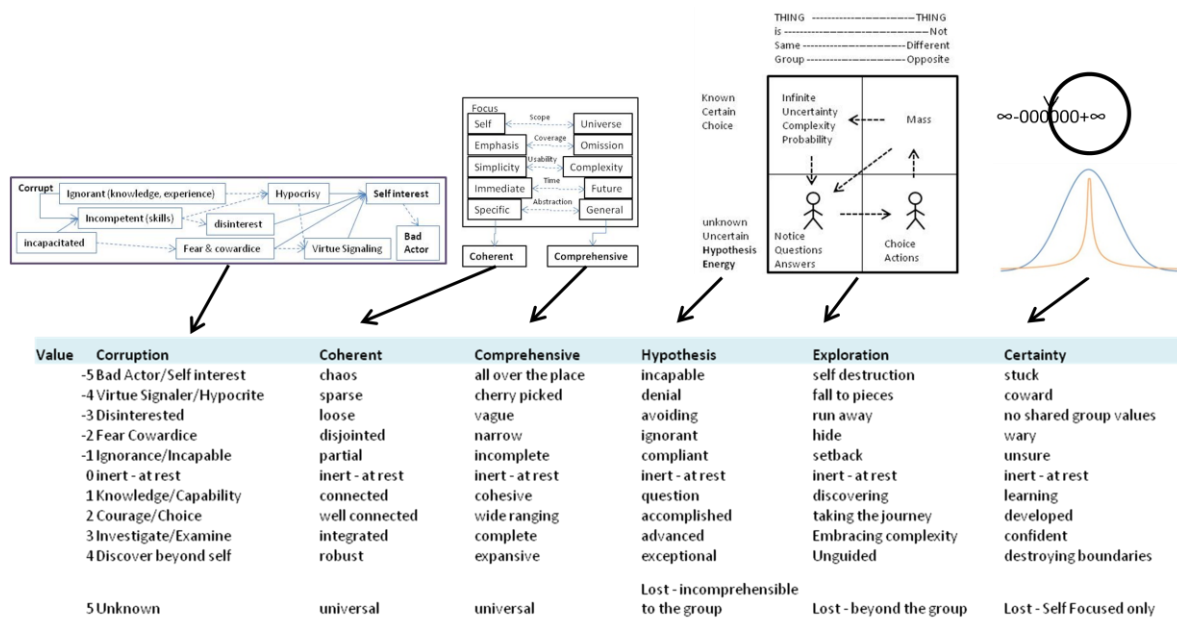
Was Genghis Khan all Bad?

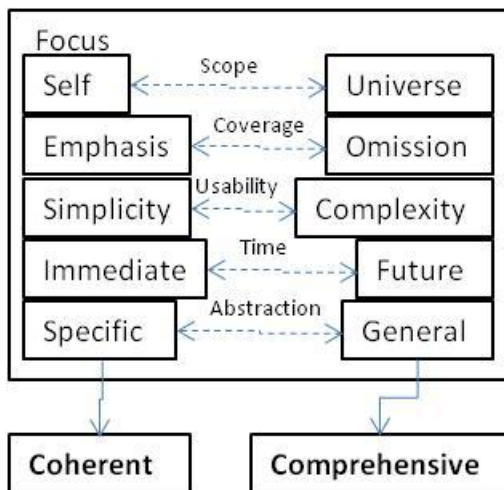

And this does not include “how many people you murdered” or “how many sins did you commit” because I see that as a general corruption. Sins of ignorance, incompetence, lack of knowledge, “virtue signaling”, etc. Self-Interest/Bad actor types have no care for other human lives in any way. 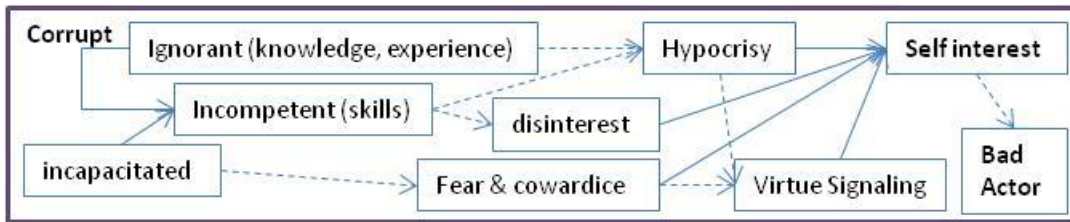
- We should emphasize the Good things about Genghis and ignore the rest

But, here, there was no room or recognition for independent national states with equal and personal rights. This recognition, opposed by the Roman[p. 24] Church, is the real basis of international law. The Reformation was the means by which the personality of the peoples, the unity and independence of the state were first openly admitted. On this foundation, mainly at first in Protestant countries, the new science developed rapidly. Like the civil state and the Christian religion, international law may be called a peace institution.

Grotius, Puffendorf and Vattel.

*In the beginning of the seventeenth century, **Grotius** laid the foundations of a code of universal law (De Jure Belli et Pacis, 1625) independent of differences of religion, in the hope that its recognition might simplify the intercourse between the newly formed nations. The primary object of this great work, written during the misery and horrors of the Thirty Years' war, was expressly to draw attention to these evils and suggest some methods by which the severity of warfare might be mitigated. Grotius originally meant to explain only one chapter of the law of nations:[27] his book was to[p. 25] be called **De Jure Belli**, but there is scarcely any subject of international law which he leaves untouched. He obtained, moreover, a general recognition for the doctrine of the Law of Nature which exerted so strong an influence upon succeeding centuries; indeed, between these two sciences, as between international law and ethics, he draws no very sharp line of demarcation, although, on the whole, in spite of an unscientific, scholastic use of quotation from authorities, his treatment of the[p. 26] new field is clear and comprehensive. Grotius made the attempt to set up an ethical principle of right, in the stead of such doctrines of self-interest as had been held by many of the ancient writers. There was a law, he held, established in each state purely with a view to the interests of that state, but, besides this, there was another higher law in the interest of the whole society of nations. Its origin was divine; the reason of man commanded his obedience. This was what we call international law.[28]*

Grotius distinctly holds, like Kant and Rousseau, and unlike Hobbes, that the state can never be regarded as a unity or institution separable from the people; the terms civitas, communitas, coetus, populus, he uses indiscriminately. But these nations, these independent units of society cannot live together side by side just as they like; they must recognise one another as members of a European society of states.[29] Law, he said, stands above force even in war, "which may only be begun to pursue the right;" and the beginning and manner of conduct of war rests on fixed laws and can be justified only in certain cases. War is not to be[p. 27] done away with: Grotius accepts it as fact,[30] (as Hobbes did later) as the natural method for settling the disputes which were bound constantly to arise between so many independent and sovereign nations. A terrible scourge it must ever remain, but as the only available form of legal procedure, it is sanctioned by the practice of states and not less by the law of nature and of nations. Grotius did not advance beyond this position. Every violation of the law of nations can be settled but in one way—by war, the force of the stronger.

*In our own day, however, it has become apparent that nations may, under conceivable circumstances, be infected with the madness which was once thought to be the monopoly of monarchs. The poison of war is seen to have penetrated still more deeply than in Rousseau's time could have readily been thought possible. And, with this, it is manifest that the hope of finally abolishing war is indefinitely diminished. By a flash of insight, Rousseau himself, in later years, caught a glimpse of this possibility. When reminded that, with all his eloquence, he would never induce monarchs to adopt the scheme of a lasting peace, 'Not I,' was his answer; 'but they will find themselves forced to it one day. Their subjects will perhaps at last get tired of shedding their blood for their diversion.' 'But, when the monarchs cease to fight, will not the nations still continue?' 'Much less so, I hope; for nations will fight only for their real interests, and for large ones, while kings do so from mere pride; because they are surrounded by men who love war, and because they always abuse the power entrusted to them.'*¹

The argument which lies at the root of the whole treatise may be stated very briefly. The first step, the misery and waste of war, will be disputed by none. Under present conditions—even' apart from the wanton barbarities practised by Germany—they are a hundred times greater than they have ever been before. And the waste of war, as Rousseau insists, is to be measured not only 'by those who are killed, but by those who are not born'; as well as by the economic loss, the devastation of agriculture and industry, which is recognised, at least 'from the lips outwards, by all.

The second step is perhaps less certain of acceptance. It is that, under existing circumstances, the perpetual recurrence of war is a thing natural and inevitable, and will continue to be so, so long as each State retains its absolute independence of the others; so long, in Rousseau's language, as' all of them remain to each other in the 'state of nature.' In forming themselves into the separate groups, known as States, men have, in fact, 'done either too much or too little. They have put an end to private wars, only to kindle national wars a thousand times more terrible. They have given their love to their fellow-citizens, only to declare themselves the enemies of the whole race.'

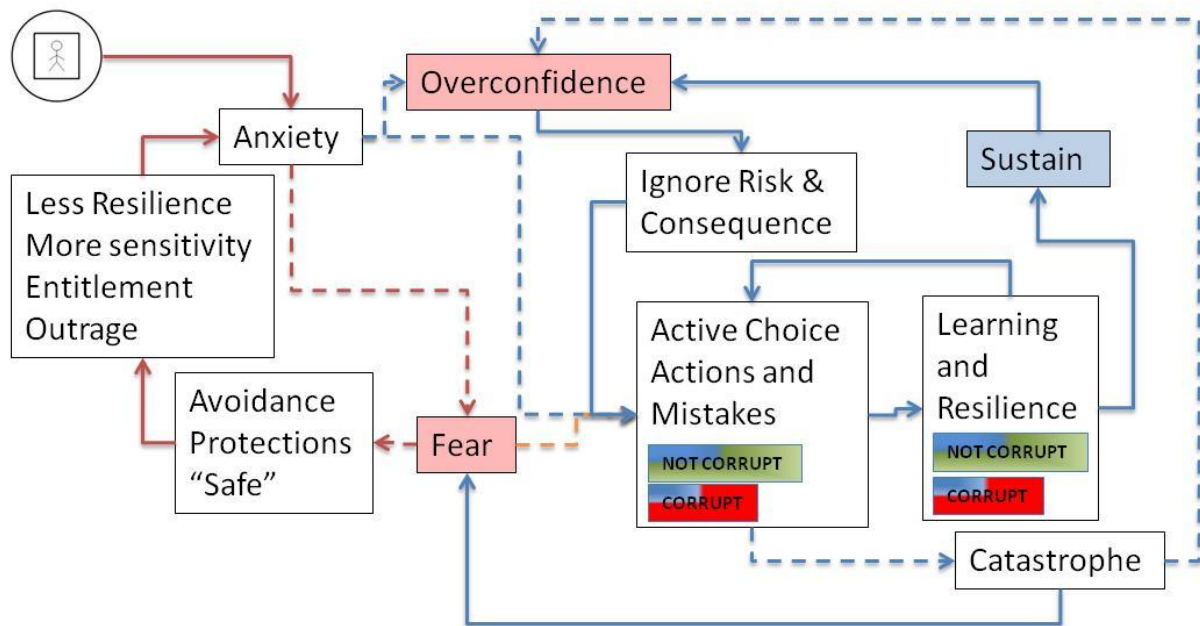

Regardless of how Seneca and Lucilius actually corresponded, it is clear that Seneca crafted the letters with a broad readership in mind

"According to the testimony of ancient historian Hellanicus, the first recorded handwritten letter was written by Persian **Queen Atossa**, around 500 BC" (Tomshinsky, 2013, p. 112). From Tomshinsky's article, it is possible to say that written letters started in Persia, and since then this simple form of sending messages has greatly evolved."

Receiving communication from your friends, family and people you correspond with was highly valued for many hundreds of years. **The pure and simple Joy** of information and **personal connection** through private letters was greatly appreciated. Private thoughts could be shared and expressed without great public displays or scrutinisation by the "Home Office" spies and security agencies (as currently happens with all of the communication in Australia - phones, email, social media, etc.)

I can imagine Queen Elizabeth I sending and receiving information about things happening around the world via trusted couriers, men on horses, teams of people sailing across the seas to make sure the letter reached the hands of safety. War correspondents went to battles to report on what happened and how people behaved. Your actions on the battle field became more widely known and had consequences.

At one of the sieges of France in the 1500s - one the Spanish soldiers wrote about how badly **John Norries** [https://en.wikipedia.org/wiki/John_Norris_\(soldier\)](https://en.wikipedia.org/wiki/John_Norris_(soldier)) had behaved with those who were captured. Indeed - it was a sign of human decency on how you treated your captives. **Word gets around, reputations matter, events are remembered**. Given this criticism of **John Norris** (a protestant supporter and friend of Queen Elizabeth I) was leveled by a Spanish religious zealot - who can be suggested with some certainty - supported Inquisitions, Burning heretics, killing people in south America and raping and pillaging the Spanish Netherlands - is interesting - but maybe this Spaniard soldier was an exception?

But there is a report of massacres by Norries. [https://en.wikipedia.org/wiki/John_Norris_\(soldier\)](https://en.wikipedia.org/wiki/John_Norris_(soldier)) *Lord Essex, knowing that the refugees were still on the island, sent orders to Norreys, who was in command at Carrickfergus, to take a company of soldiers with him, cross over to Rathlin, and kill what he could find. **Norreys** had brought cannon with him, so that the weak defences were speedily destroyed, and after a fierce assault, in which several of the garrison were killed. The Scots were obliged to yield at discretion and all were killed, except the chief and his family, who were reserved for ransom. The death toll was two hundred. Then it was discovered that several hundred more, chiefly women and children, were **hidden in the caves about the shore: they too were attacked and all massacred.***

Artists, Spies, Diplomats and other information gatherers and reporters also went to battles to observe and collect information. Information specialists came in many different guises and had many different jobs. This information became permanent public records and spread widely.

Mapping the Wars

My databases of facts are growing. I have sequences of events, people, place, books and other written ideas. These facts can be argued about. Then the threads which link and bind these facts can be explored and discussed. This is essentially what historians do - they pull together all the information first and then explore the links and then try to make sense of the sequences and connections. Patterns emerge - we see family, tribe, place connections and we see responses i.e. a event then a response to that event.

Discussions, treaties and diplomacy was growing - another interesting war where armies met and encircled each other then instead of fighting the two leaders talked and tried to work out an agreement was **Bohemian Hungarian-Battle of Vilemov - War[1469] Month[2] Day[26]**

My error rate for facts is fairly low, <5%, because I cross check things with other things and actively look for errors. History and philosophy is not the same as engineering nor is it "political or social science". Sufficiently certain/sufficiently vague.

Accuracy and precision varies - for some places I am a little off in my map - a few kilometers - some are accurate to within a few metres. Paris is a big city so a general point in the middle somewhere is

all you need to map it. My roads are usually generally correct and follow the landscape although some are very general connections as a simple connection between two points. In many cases many different paths can be taken on no one road dominates - places like France, England, Germany, China, India - large flat areas - have multiple possible routes. Other routes through the mountains can only go through the mountain passes or, in places like Turkey, along the ridges.

Carthage/Tunis/Abrizi/Uthina/Tunes/Thuni - Historic_City[-300 to 2022] lat/long(36.80649, 10.18153) is about 16km from the old city of Carthage.

With the mapping of wars - people have to be alive - their birthdates and death dates must correspond with the event date. This means I have to check all the dates of events and people.

While doing this I found some errors in my own work and the Wiki database. I have mostly ignored obvious errors on Wikipedia rather than note all of them. These are 3 errors are on wikipedia with either wrong people or wrong links

I currently have 3030 people/event combinations about 2000 are in the 1500s and later - because I made some effort in putting all the wars of the 1500s on the map - except for all the Japanese tribal wars, the South American wars, Korean wars and all the Portuguese colonial wars - although I have some of the main ones. Thailand, Burma and Cambodia are in a constant state of warfare from 1500s onwards for hundreds of years. I ignored most of clan battles in Scotland and Ireland.

595 people have been in more than one event - maximum 29 events Q164062
Maurice,_Prince_of_Orange from the age of 19 to 33.

Q312903 **Alexander_Farnese,_Duke_of_Parma** was in 21 wars between the ages of 33 and 47.

I could run the network through some network software PAJEK or ORANGE or I could extract some interesting areas to focus on and then look at the network. I can remove single events because I am interested in links and relationships - although I could make some statement about the min, max, average age of known people at any event including singles.

I can focus on a particular area and time - mainly Europe and mainly 1500s. I can then explore connections and sequences - I can also explore time distance because I have everything geocoded. I have a full database of time, place, people, event and locations. I can even hypothesise travel routes using the roads I have loaded - especially the passes through the mountains - where they are usually the only sensible route to travel. Famines, witch trials, earthquakes, tsunamis, volcanic eruptions - all feed into the mix.

But what am I after? Well I might **discover** things that I am yet to question - the **activity of doing this** work might **raise other questions**. But I also have a working hypothesis that some kind of cooperative war process was developing - fighting and killing - but with moderation and communication before and after. Still brutal but with other things as well we emerged during the 1500s.

The medieval concept of a united and stratified Christian Europe ruled from on high by the pope and the Holy Roman emperor gave way to the idea of equal rights."³⁰ The Franco-Turkish alliances beginning in the 1520s symbolized the end of the idea of a unified Christendom many decades before the end of the Reformation. I differ from this frame of a **Power system** of classifications of War - especially the idea that nation states is a driver. Nation is not a concept which is fully or widely understood and is only a recent human invention. Australian Aborigines, North American Indians and other tribes use the word "nation" as a **cultural appropriation**. None of these tribal types have any understanding conceptually of what "nation" means. I recognize the nuanced ideas around city-states, tribes, families and groups in general but more work needs to be done to understand the meaning of "Nations" and the concept is not something binary zealots or tribal types can easily comprehend.

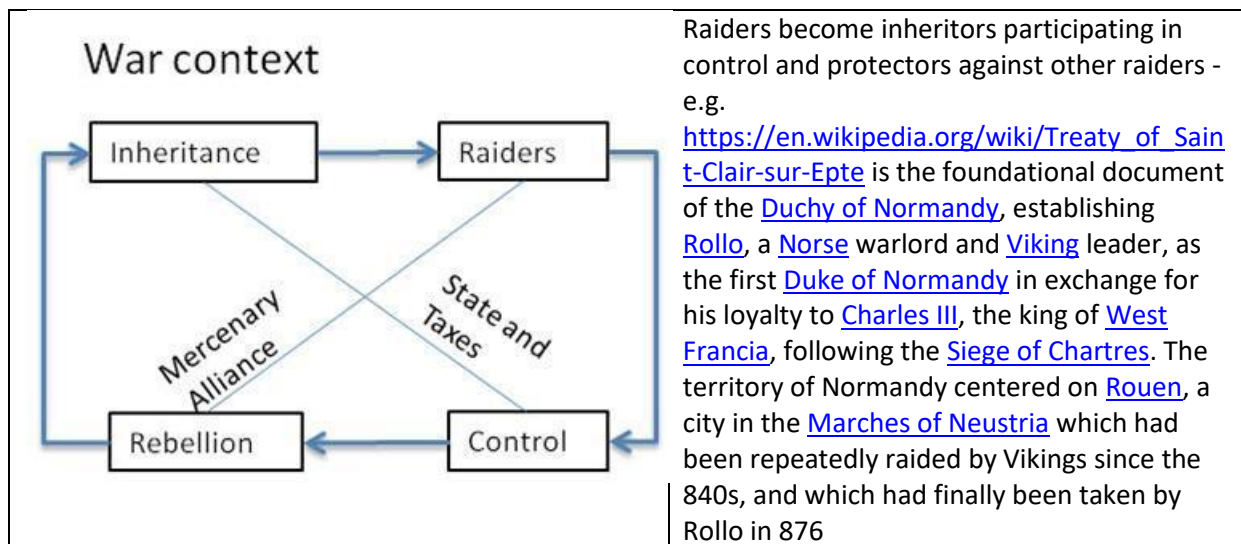
I would position some of those ideas with the "control" part of my wider human model.

My current classification frame for wars includes some ideas which are in a kind of "necessary tension" and "debate" - the ideas of

- **Inheritance** - Families "*War of the Succession*", interregnums - **tribal**, local area and **boundary** wars, ownership, land, property, farms, animals, resources, water, minerals,

business, ships, local trade deals, stability - local (sometimes) laws of ownership and inheritance.

- **Raiders** - Stealing, Killing and Plundering - Barbarians and pirates - Destruction, Sacking, Raping, Pillaging, Burning, Massacres
- **Control**, power, invasion and peace - including colonization, land and power acquisition, treaties, deals, agreements, trade deals, Taxation, Rule of Law, government, (sometimes overlaps with Inheritance (especially **tribal** and **boundary** wars) and Rebellion). This also includes all the religious wars. This is the ongoing problem of “just wars” to achieve settled trade, peace and some stability. A balance. Politics, negotiation and diplomacy emerges here. “*Body Politic*” “*Rule of Law*”
- **Rebellion**, Uprisings, Revolutions and Revolt - including martyrdom (e.g. Roman soldiers becoming Christians and not obeying the military commander). Reaction to **excessive** controls.

Page 191 Philosophies which emphasize the reality of social groups have been exaggerated in some populations to assertions of the absolute value of that group. Few people would deny the historical vitality of many groups and the utility of certain groups to human welfare and individual liberty at the present time and perhaps for a long future. An increasing number of people, however, insist that the philosophical justification for the existence of any particular group must lie in proof of its contribution to the welfare of the individuals which compose it or of humanity as a whole. 86 Political leaders find it increasingly expedient to assume that society is for the benefit of man, that man is not to be sacrificed for the perpetuation of any particular society.

I am impressed with the breadth of the work in A Study Of War by **Quincy Wright**. I rate him and his work highly - he seems to understand and comprehend many things and to have done the research required to form some ideas and hypothesis. I tend to disagree with ideas related to too much control mechanisms and the "World Government" idea that many people express. It becomes corrupt and authoritarian - many Tyrannical Authoritarian regimes in history express "peace at all costs", "Keeping us safe" and this differs with my understanding of humanity and the **plurality model** which requires **necessary tensions**, , questions, exploration, debate, arguments, disagreements and sometimes wars.

No one man worked with more sustained care, compassion, and level-headedness on the study of war, its causes, and its possible prevention than Quincy Wright. He did so for nearly half a century, not only as a defender of man's survival, but as a scientist. He valued accuracy, facts, and truth more than any more appealing or preferred conclusions; and in his great book, A Study of War, he gathered, together with his collaborators, a larger body of relevant facts, insights, and far-ranging questions about war than anyone else has done.

Wright's study of warfare inspired many social scientists and his database of wars is an indispensable resource for anyone seriously interested in quantitative studies of human conflicts.

As far as I can tell - my current database and maps - compiled from internet resources - google maps, Wikipedia and many online books and other resources are more comprehensive for the period I have worked on - especially up to the 1500s - than anyone else I have identified so far who has researched this. And I can manipulate the data using database and other analytical tools. I do intend to keep working on the time period more thoroughly and spend less time on the most recent time periods which seem to have been quite intensively studied around the world. I will check and double check as many things as I can For example

But in his essay Of Ill Means Employed to a Good End , Montaigne also quotes Juvenal's remark that "we suffer the ills of a long peace; luxury is more pernicious than war." He seems to approve the Roman policy of maintaining wars "not only to keep their own men in action, for fear lest idleness, the mother of corruption, should bring upon them some worse inconvenience; but also to serve for a blood- letting to their Republic, and a little to evaporate the too vehement heat of their youth.... Kant from saying that "a prolonged peace favours the predominance of a mere commercial spirit, and with it a de- basing self-interest, cowardice, and effeminacy, and tends to degrade the character of the nation." Nor is war to be absolutely condemned. "Provided it is conducted with order and a sacred respect for the rights of civilians," war itself, says Kant, "has something sublime about it, and gives nations that carry it on in such a manner a stamp of mind only the more sublime the more numerous the dangers to which they are exposed, and which they are able to meet with fortitude." Yet even while thinking that war can be a "spur for developing to the highest pitch all talents that minister to culture," Kant reflects that the underlying purpose of war may be "to prepare the way for a rule of law governing the freedom of states, and thus bring about their unity in a system established on a moral basis.

...“This third power,” Dante continues, “is either the world-government, or it is not. If it is, we have reached our conclusion; if it is not, it must in turn have its equal outside its jurisdiction, and then it will need a third party as a judge, and so ad infinitum, which is impossible. So we must arrive at a first and supreme judge for whom all contentions are judicable either directly or indirectly. . . . Therefore, world government is necessary for the world.” Aristotle, according to Dante, “saw this argument when he said, ‘Things hate to be in disorder, but a plurality of authorities is disorder; therefore authority is single.’ But Aristotle certainly did not draw the conclusion that a single government embracing all mankind should be instituted so that “by common law it might lead all toward peace.” Nor, with the exception of Kant, does any other great author argue to this conclusion.

*There are two views of the war neither of which seems to me adequate. The usual view in this country is that it is due to the wickedness of the Germans; the view of most pacifists is that it is due to the diplomatic tangle and to the ambitions of Governments. I think both these views fail to realize the extent to which war grows out of ordinary human nature. Germans, and also the men who compose Governments, **are on the whole average human beings**, actuated by the same passions that actuate others, not differing much from the rest of the world except in their circumstances. War is accepted by men who are neither Germans nor diplomatists with a readiness, an acquiescence in untrue and inadequate reasons, which would not be possible if any deep repugnance to war were widespread in other nations or classes. The **untrue things which men believe**, and **the true things which they disbelieve**, are an index to their impulses—not necessarily to individual impulses in each case (since beliefs are contagious), but to the general impulses of the community. We all believe many things which we have no good ground for believing, because, subconsciously, our nature craves certain kinds of action which these beliefs would render reasonable⁶ if they were true. Unfounded beliefs are the homage which impulse pays to reason; and thus it is with the beliefs which, opposite but similar, make men here and in Germany **believe it their duty to prosecute the war**.*

[1] Toynbee's goal was to trace the development and decay of 19 or 21 world civilizations in the historical record, applying his model to each of these civilizations, detailing the stages through which they all pass: genesis, growth, time of troubles, universal state, and disintegration...

Toynbee argues that **civilizations** are born out of more primitive societies, not as the result of racial or environmental factors, but as a response to challenges, such as hard country, new ground, blows and pressures from other civilizations, and penalization. He argues that for civilizations to be born, the challenge must be a **golden mean**; that excessive challenge will crush the civilization, and too little challenge will cause it to stagnate. He argues that civilizations continue to grow only when they meet one challenge only to be met by another, in a continuous cycle of "**Challenge and Response**". He argues that civilizations develop in different ways due to their different environments and different approaches to the challenges they face. He argues that growth is driven by "**Creative Minorities**": those who find solutions to the challenges, **who inspire (rather than compel)** others to follow their innovative lead. This is done through the "faculty of mimesis." Creative minorities find solutions to the challenges a civilization faces, while the great mass follow these solutions by imitation, solutions they otherwise would be incapable of discovering on their own.

Historian **Carroll Quigley** expanded upon Toynbee's notion of **civilizational collapse** in *The Evolution of Civilizations* (1961, 1979). [7] He argued that **societal disintegration involves the metamorphosis of social instruments, set up to meet actual needs, into institutions, which serve their own interest at the expense of social needs**

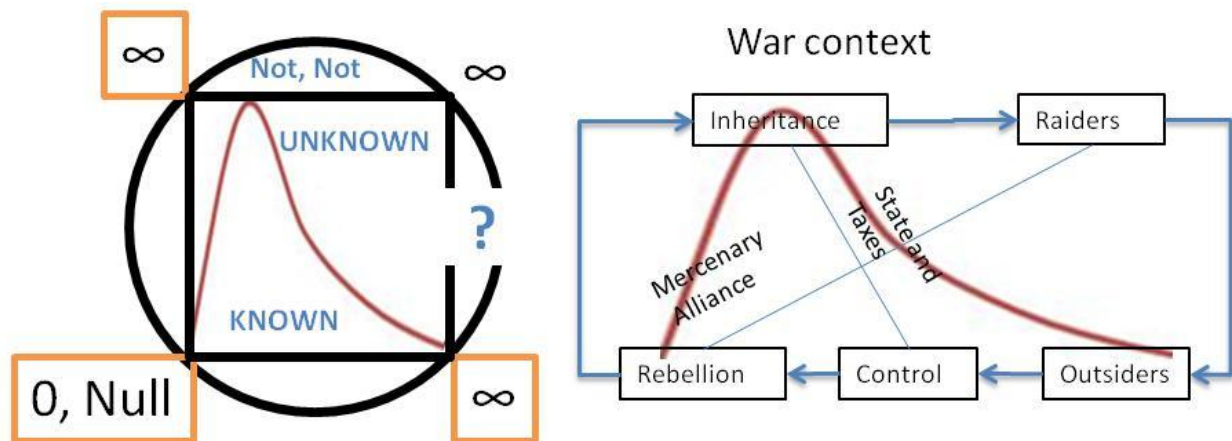

We do know that, in the annual budgets of the British Rāj in India during the last century of its existence, the coast of defence (which, in practice, meant the defence of the North-West Frontier) was an item that absorbed a disconcerting proportion of the revenue.

Leaving unpaid mercenaries ransacking towns, raping, murdering civilians because they had not been paid - was very common throughout the 1400s - 1600s - especially in Netherlands but also too earlier on (700s onwards) when Religious towns were set up - they started taking matters into their own hands to gain money and power. The Spanish also showed this wanton brutality and power grab in the Americas. Rather than balanced control and some kind of peace it was a state of permanent warfare, brutality and **excessive** control and power and the inhuman treatment of individuals.

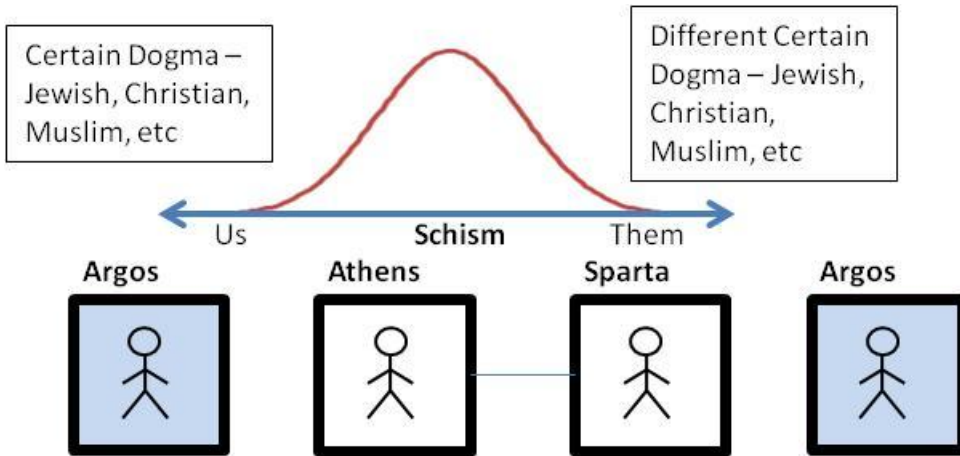
War Context aligned with Plurality

The Rebellion comes when people use God words like “good” inclusiveness, diversity and “cause” and the meaning of inheritance is corrupted.

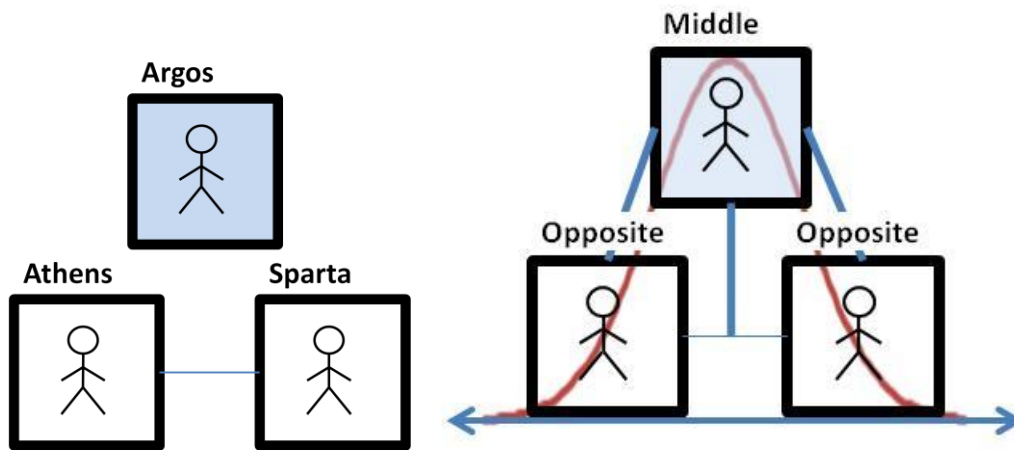


The significance of this new model is it shows the outsiders coming in from the raiders and progressively moving towards the centre of the curve. The outsiders are usually not warring tribes but mainly individuals escaping the group mentality. We already saw Athens and Sparta as the **binary tribal warfare model** but as third parties emerge and refuse to take binary sides we get different results. (also see Game Theory)

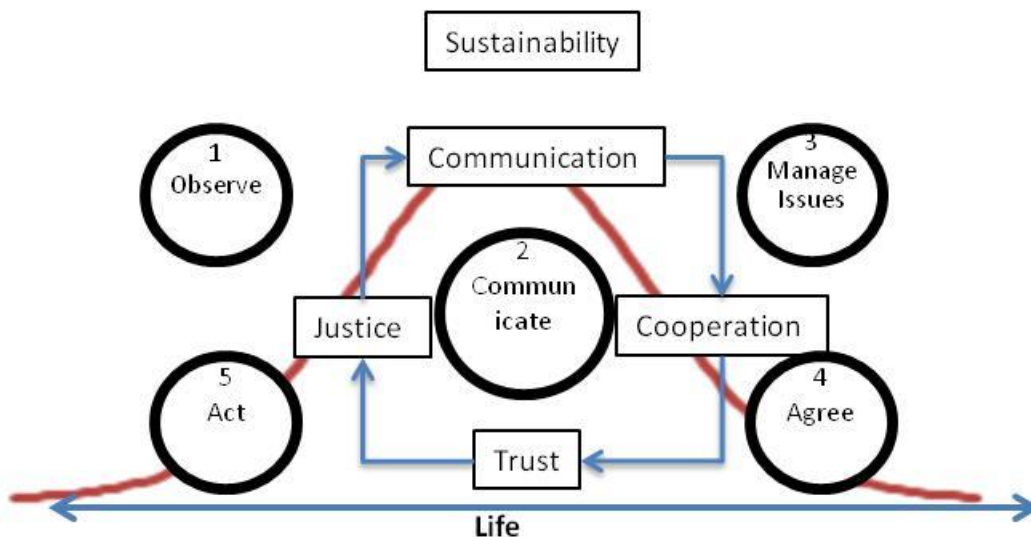

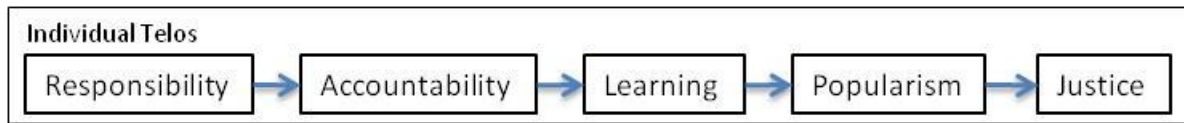
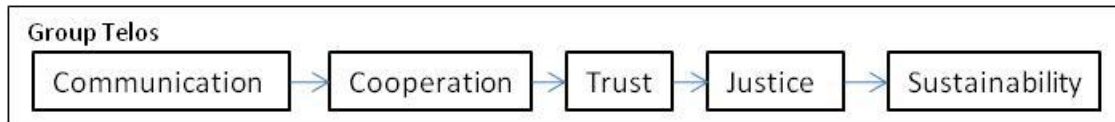

The following are not trivial observations.

1. The creating of a plurality by including the outsiders involves difficult debates and not tribal warfare. This is a significant human development.
2. Rebellion and Revolt type conflicts can occur around the insufficiently defined and insufficiently measured concepts to the left of the peak of the plurality curve. E.g. "God" "good" "nice" "Equality" "Diversity"

Quincy Wright uses the word Plurality - as many people do - without necessarily understanding the significance of the concept and also expecting that other people understand the meaning. Most people do not understand the plurality model and are stuck in binary.

Narcissistic psychopaths, tyrants, despots and others - can occupy positions of control and they increase uprisings, rebellions, revolts and revolutions. Part of the control job is to ensure that these people are removed before those uprisings take place

My models are not complete or fully comprehensive - yet they are useful for discussion and further exploration.

The study of the Faerie Queene should be preceded by a review of the great age in which it was written. An intimate relation exists between the history of the English nation and the works of English authors. This close connection between purely external events and literary masterpieces is especially marked in a study of the Elizabethan Age. To understand the marvelous outburst of song, the incomparable drama, and the stately prose of this period, one must enter deeply into the political, social, and religious life of the times.

The Faerie Queene was the product of certain definite conditions which existed in England toward the close of the sixteenth century. The first of these national conditions was the movement known as the revival of chivalry; the second was the spirit of nationality fostered by the English Reformation; and the third was that phase of the English Renaissance commonly called the revival of learning.

The closing decade of Queen Elizabeth's reign was marked by a strong reaction toward romanticism. The feudal system with its many imperfections had become a memory, and had been idealized by the people. The nation felt pride in its new aristocracy, sprung largely from the middle class, and based rather on worth than ancestry. The bitterness of the Wars of the Roses was forgotten, and was succeeded by an era of reconciliation and good feeling. England was united in a heroic queen whom all sects, ranks, and parties idolized. The whole country exulting in its new sense of freedom and power became a fairyland of youth, springtime, and romantic achievement.

Wise and gallant courtiers, like Sidney, Leicester, and Raleigh, gathered about the queen, and formed a new chivalry devoted to deeds of adventure and exploits of mind in her honor. The spirit of the old sea-kings lived again in Drake and his bold buccaneers, who swept the proud Spaniards from the seas. With the defeat of the Invincible Armada, the greatest naval expedition of modern times, the fear of Spanish and Catholic domination rolled away. The whole land was saturated with an unexpressed poetry, and the imagination of young and old was so fired with patriotism and noble endeavor that nothing seemed impossible. Add to this intense delight in life, with all its mystery, beauty, and power, the keen zest for learning which filled the air that men breathed, and it is easy to understand that the time was ripe for a new and brilliant epoch in literature. First among the poetic geniuses of the Elizabethan period came Edmund Spenser with his *Faerie Queene*, the allegory of an ideal chivalry.

undoubtedly tended to sober their minds and induce them to reflect much upon the great and solemn duties of life. The character of the age was stamped with the dignity which hallows tribulation, and with the force and nerve which the habitual contemplation of danger rarely fails to confer. The same causes undoubtedly promoted the religious spirit which prevailed. While bigotry and fanaticism appeared in a small portion of the nation, it is certain that the age of Elizabeth was marked by the general diffusion of a spirit of deep devotion. There was enough of chivalry left to keep alive the fervor which prevailed at an earlier period, and enough of intelligence to temper this fervor into rational religion. The feeling of shame at professing faith and devoutness was the growth of a later day; it was unknown in those times. The gayest courtier that chanted his love-song in the ear of the high-born maiden, and the gravest statesman who debated at the table of the privy council, were alike penetrated with devotional sentiment, and alike ready to offer up prayers and thanksgiving to the Most High. We are perfectly aware that the outward signs of piety displayed by a few principal characters are not a faithful index of the state of religion at any period. It is not fair to infer, because Elizabeth devoutly commended herself to the care of the Almighty when forsaken, friendless, an orphan, alone, and helpless, she was landed at the foot of the Traitor's Stairs in the Tower of London, or because she returned to the same gloomy fortress when a triumphant queen, to offer up her praise and gratitude to God for his marvellous mercies, that she lived in a pious age. Neither are we to regard it as a sure indication of the prevailing spirit, when Burleigh solemnly commends his son to the Almighty in his letter of advice; when the chivalrous Sidney is found composing a prayer, which, for solemnity, grandeur, and devotion, is scarcely surpassed in the English liturgy; when the adventurous Raleigh displays an amount of knowledge on sacred subjects that might be the envy of an Oxford professor of theology, or when the city of London presents to the young Queen, on the day of her coronation and in the midst of her glittering pageantry, the Bible, as the most appropriate and acceptable offering.... The principles which formed society were precisely such as were best calculated for the finest developments of character. The old high, fervid spirit of chivalry was not lost; there were the same sense of honor, the same knightly bearing, the same passion for glory, and the same admiration for courage and prowess that had prevailed in the earlier days of its sway. But these were tempered by milder and more attractive virtues and accomplishments; the clerkly learning, which had held so humble a rank in the days when nobles could scarcely sign their names, had now risen into far higher estimation. Great warriors were now no longer ashamed to know how to read and write; on the contrary, the possession of learning and literature, the delicate arts of poetry and music, the graces of conversation and manners, were now as requisite to the full accomplishment of the knight, as his horsemanship, or his skill in the management of his lance. In a word, the sterner characteristics of the ancient knight were softened down, in the age of Elizabeth, into the more perfect and graceful attributes of the gentleman. The perfect gentleman was more completely exhibited in the days of Elizabeth than at any time before; for the chivalry and the accomplishments which were then united in the same individual, had been formerly divided between the noble and the churchman or the clerk. Were we called upon to characterize the age in which Spenser lived, by a single word, we could find none that would better express its combined attributes, than the word which the poet uses in describing his principal hero: "In the person of Prince Arthure," says he in his letter to Raleigh, "I set forth magnificence." The age of Elizabeth was distinguished by magnificence, in the highest sense of the word, by the

most brilliant display of great qualities of all kinds; and the hero of the Faerie Queene seems to be the personification of the splendid attributes of the age. A prevailing sentiment, in the mind of Spenser, was the perfectness of character to which the gentlemen of his time aspired, and on this model he fashioned his hero. He observes that "the general end, therefore, of all the books is to fashion a gentleman or noble person in gentle and virtuous discipline." And again, "I labor to pourtraict in Arthure, before he was King, the image of a brave knight, perfected in the twelve moral virtues." And as we read the gorgeous description of the prince, when he first meets the forsaken Una, we could fancy that the magnificent characteristics of the golden age of England had blended together, and blazed forth in one dazzling form before us.

Valla read and translated widely in the classics, but chiefly in Greek scientific texts (which he translated into Latin), and lectured in mathematics, physics, and the classical languages in Pavia and later Venice. It was here that his magnum opus, **De expetendis et fugiendis rebus opus (A Book of things to pursue and those to avoid)** was published by the great Venetian printer Aldus Manutius in 1501, a year after Valla's death. This enormous encyclopedic work contains discussions of arithmetic, geometry, astrology, physiology, medicine, economics, politics, moral philosophy, poetry, music, rhetoric, dialectic, and grammar, illustrated by numerous woodcut diagrams. Much of the content is drawn from his reading of Greek texts, and in some cases preserves the essence of works otherwise now lost to us. It is believed that Leonardo da Vinci had a copy of this work in his private library, and other mathematicians of the day, such as Copernicus, were also influenced by it.

The case took place in Husbands Bosworth, a small village not far from Leicester in 1616. John Smith fell into a series of violent fits, not even several men could hold him down. He made strange noises, and, as noted in a letter from Alderman Robert Heyrick to his brother Sir William,[1] he would beat himself with inhuman strength, yet somehow remain unharmed. He gave extensive details on their familiars. The two judges, Sir Humphrey Winch and Sir Ranulph Crewe quickly condemned the women, rounding all 15 of them up. Nine of them were tried, found guilty and hanged for allegedly possessing John Smith. The other six were placed in prison to wait their turn. None of them were named before being hanged. King James I happened to be passing through about a month later, and heard what was going on. He called for John Smith to be questioned, and had little trouble determining the child was fraudulent. He broke down, and confessed the truth. Of the six women who had been imprisoned, only five of them were released, as one of them died inside. According to a timeline, the woman who had died told the jailer she was working with the witches against Smith the day before she died. She had begged him not to say anything because the witches would harm her.
